


The Government Supports Orange Walk East Transforming Possibilities into Reality !



On the 12th of November, Orange Walk Town was shaken by the sound of a huge explosion on San Francisco Street.

John Gillett and his son-in-law Errol Diaz were transfering fuel to a dump truck at night in a dark area with poor lighting. Apparently the diesel they were transfering did not appear normal so John used a cigarrette lighter to get a better view. This caused the explosion to erupt from an

place a breathing tube because he was so severely burnt he was unable to breathe on his own. Plans were to airlift him to Guatemala but unfortunately he succumbs to his injuries on Sunday 13th, November. Errol Diaz remains quarantined at the





## Hisband Stabs Wife Twice



Martha Alicia Wagner November 16, Orange Walk Town

At around 8:45pm police were called on Rio Bravo Street in the Louisiana Area where they found Martha Alicia Wagner, 46yrs suffering from stab wounds. Martha Wagner was accompanied by her brother-in-law when her husband, Felipe Wagner, 36yrs arrived and demanded her to go home. When she refuse he left but to return armed with a knife. An argument began between the three of them then led Felipe Wagner to stab Martha Wagner twice, once in the chest and once in the back. Martha Wagner was rushed to the Northern Regional Hospital and then trans-

ported to the Karl Heusner Memorial Hospital where she is in a stable but critical condition.

Her wounds inflicted by her husband of 13 years punctured her lungs and tored the artery of her heart. She has a lot of haemorrhage and is in dire need of 14 litres of O Negative blood. Relatives in Orange Walk are claiming that there is some kind of love-triangle amoung the brothers and the wife of the accused and that the alleged abusive relationship may be in the reverse. ### TRAFFIC SAFETY TIPS FOR DRIVERS

1.Check your motor vehicle to ensure that everything is in good working condition. Example- brakes, all lights, horn, wipers, tires, spare-tire, tire tools, oil, water, brake fluid & dash board gauges.

2.Ensure that your driver's license is valid and that your vehicle is licensed and insured.

3.Wear your seat belts at all times when on the highways. (It is an offence for drivers and front seat passengers not to wear seat belts on the high ways).

4.Don't carry passengers in the back of open pickup trucks. (Vehicle only insured to carry amount of passengers as stipulated on certificate of registration/ title).

5.Don't drive if you are consuming Alcoholic beverages or taking medication (drugs). Have designated driver (alcohol and drugs affect your vision and judgement).

6. Avoid making calls on cell phone when driving, it is best to pull off to the right to make calls or to answer your cell phone, don't text whiles driving.

7. Wear your helmet at all times when operating or being carried as a passenger

on a motor cycle.

8.Only overtake if you have a clear view of the road ahead, never overtake around blind curves or when driving over a hill.

9.Drive within the speed limit at all times.

# FOOD AND NUTRITION

### **Fats Facts: Healthy and Unhealthy Fats**

All fats found in fresh whole foods are good, healthy, and sometimes vital. Its is wise to include a full spectrum of fats in your diet, which will work hard to keep you healthy and young-looking. This, of course, is not the message we have been getting in the popular media, and because of this we have built up an unhealthy guilt complex and fear of fat.

Certain fats are indeed bad for us, but luckily it is easy to spot them. Trans fatty acids have been linked to raising "bad" cholesterol (LDL) and lowering "good" cholesterol (HDL); they are also suspected of being behind that "stubborn fat" that won't leave no matter what we do. They are the result of processing oils through hydrogenation. You can spot the presence of trans fats in a product because hydrogenated fats have to be listed in the ingredient panel of food. By adding up all the fats listed in the panel and then subtracting that number from the total listed, you will come up with the amount of trans fats in the product. However, the easiest thing to do is just avoid anything that has any hydrogenated oil in it.

Rancid fat is the other bad fat - fat that has been mutated by oxygen, heat, moisture, and light. This fat is full of free radicals and can contribute to all the health and aging problems associated with them. At first you might think that it would be easy to avoid this one. Just reading the work "rancid" tends to make our noses wrinkle in disgust; however, we have been conditioned to accept rancid fats. The reason that dollop of butter is salty is to help preserve it and to cover up the rancid taste. Yes, butter is good for us, but rancid butter is not. That flax oil in the refrigerator is liquid gold to some, but if it is rancid, it is worse than useless. We have to retrain our noses and taste buds to discern fresh good fats from rancid bad ones. This is one reason for using unsalted rather than salted butter.

This restraining can be done by finding stores that sell their stock quickly, store their products properly, and rotate their stock on the shelf so that no old products linger there. Also check the expiration dates on products to help you find the

2 Large onions, chopped

1 (14.5 ounce) can chicken

5 Remove turkey from freezer put to thaw (approx. 24 hours.) 6 Wash turkey with white vinegar. Rinse, drain or pat dry. 7 Rub turkey in and out with meat tenderizer put in plastic bag and put back in refrigerator. 12 to 24 hours. 8 Remove turkey from refrigerator rub inside with butter and thyme. 9 Just before baking, loosely stuff turkey. 10 Place any remaining stuffing in a greased baking dish; cover and refrigerate until ready to bake.

11 In melted butter add black pepper, garlic powder, thyme. Mix and rub this over turkey. 12 Bake Turkey, uncovered, at 325 degrees for 3 to 4 1/2 hours or until a meat thermometer reads 180 for the turkey, basting occasionally with pan drippings. (Cover loosely with foil if turkey browns quickly).

13 Bake additional stuffing, covered for 30-40 mins. Let stand for 20 mins before removing stuffing and carving.

Special attention must be directed to the activities of criminals on bicycles. It is easy enough to make sure that riders are free of weapons. Licensing will allow for the collection of significant demographic information. During the times of emergency further info should be collected. Investigative follow up must occur after each and every adverse event - all proceeds cash and property - must be confiscated and used in the fight.

The Rich and Famous - There

was a time when the movement of guns, cocaine, marijuana and possibly other drugs financed a revolution in Central America. Also there was a time when elected politicians encouraged and/or actively participated in the nacotrade. Belize makes no guns and grows no cocaine; any operation that gets drugs & guns on the streets must be shut down.



freshest product.

Remember that the best fats come from fresh whole foods, so try making your own butter from some fresh, pure whipping cream. Add a bit of salt to taste, if you prefer it salty, and memorize the taste to compare with commercially prepared butter. If that is a bit too much work, just find the freshest frozen unsalted butter you can, and taste that. When dealing with vegetable oils, try grinding the seeds up and them smelling the fresh aroma. Again, if this is too much of a bother, just get a good smell of the oil when you first open the bottle or tin and memorize that fresh scent. As soon as you notice that the smell is off, get rid of it.

### Chinese Toddler Ignored After Hit-and-Run Dies

A toddler who was twice run over by vans and then ignored by passers-by on a busy market street died Friday November 11, 2011 a week after the accident and after days of bitter soulsearching over declining morality in China.

The Guangzhou Military District General Hospital said that the 2-year-old girl, Wang Yue, died of brain and organ failure. "Her injuries were too severe and the treatment had no effect," intensive care unit director Sue Lei told reporters.

The plight of the child, nicknamed Yueyue, came to symbolize what many Chinese see as a decay in public morals after heady decades of economic growth and rising prosperity.

Gruesome closed-circuit camera video of last Thursday's accident, aired on television and posted on the internet, showed Yueyue toddling along the hardware market street in the southern city of Foshan. A van strikes her, slows and then resumes driving, rolling its back right wheel over the child. Over the next seven minutes, as she lay with blood pooling, 18 people walk or cycle by and another van strikes her before a scrap picker scoops her up as the girl's mother rushes into the street looking for her. for everybody."

Police have detained the drivers of both vans on suspicion of causing a traffic accident but have not said what formal charges they would face and if manslaughter would be among them now that the girl has died.

The people who could be seen on the video passing by the injured Yueyue have reounted being harassed for ignoring her. The respected Southern Metropolis Daily Newspaper quoted a man it identified only as a hardware merchant Mr. Chen as saying that Some experts said an unwillingness to help others is an outgrowth of urbanization as migrants pour into cities and create neighborhoods of strangers.

## Guatemala Authorizes Extradition of Former President to US.

Guatemala City, Guatemala (CNN)

Guatemala's president has authorized the extradition of former Guatemalan President Alfonso Portillo to face money-laundering charges in sions of judges and magistrates," Colom said, according to the state-run AGN news agency.

Portillo, who was president of the Central American nation from 2000 to 2004, is accused of laundering \$70 million through U.S. banks. He has repeatedly denied the accusations.

"We have maintained since the beginning that this is political persecution and it is easy to show it," Telesforo Guerra, Portillo's attorney, told CNN en Espanol in August.

In August judges in Guatemala's Constitutional Court upheld a previous court ruling authorizing the extradition of the former president and denied an appeal presented by his defense.

The U.S. Embassy in Guatemala welcomed the court's decision in August.

"We applaud the efforts made by the Constitutional Court, the Attorney General's Office and the International Commission against Impurity in Guatemala," the embassy said in a written statement. "This sends a strong message that nobody is above the law."

The U.S. indicment alleges Portillo embezzled the money with co-conspirators from about 2000 through about 2003. the Iranian nuclear program."

Among the issues are "those which need to be clarified to exclude the existence of possible military dimensions" in the nuclear program, it says.

The resolution was approved by an overwhelming majority of the International Atomic Energy agency's governing council, including assents from what is called the E3+3 - Germany, the United States, France, Great Britain, Russia, and China - German Foreign Minister Guido Westerwelle said Friday in Islamabad, Pakistan.

World powers have been concerned that Iran is harboring a nuclear weapons program. Iran says its program is for peaceful purposes. But a November 8 report by the IAEA found "credible" information that Tehran has carried out work toward nuclear weapons, including tests of bomb components.

Iran's permanent envoy to the IAEA, Ali Asghar Soltanieh, said after the vote that allegations against his nation are fabricated and Iran will not succumb to international pressures.

The IAEA governing council resolution calls on Iran and the agency to "intensify their dialogue" for urgently resolving "all outstanding substantive issues for the purpose of providing clarifications regarding those issues."

State media said the girl's father was tending the family's hardware shop at the time of the accident and her mother was busy hanging laundry. Both failed to notice she had wandered outside.

Communist Party Chief of Wealthy Guangdong Province, Wang Yang, has called the accident "a wake-up call the United States, state media reported Tuesday.

Guatemalan President Alvaro Colom revealed his decision to reporters Tuesday, saying he had decided to allow the extradition because he respected the separation of powers. Guatemala's Constitutional Court has also authorized the extradition.



The blockbuster drug Avastin should no longer be used in advanced breast cancer patients because there's no proof that it extends their lives and it presents dangerous side effects, the government declared Friday.

The ruling by the Food and Drug Administration was long expected, but it was certain to disappoint women who say they've run out of other options as their breast cancer spread through their bodies. Impassioned patients had lobbied furiously to preserve Avastin as a last shot.

### Breast Cancer Drug Revoked for 'Life-threating' Risks

"This was a difficult decision," said FDA Commissioner Margaret Hamburg. But, she added that "it is clear that women who take Avastin for metastatic breast cancer risk potentially life-threatening side effects without proof that the use of Avastin will provide a benefit, in terms of delay in tumor growth, that would justify those risks."

"Those risks include severe high blood pressure, massive bleeding, heart attack of heart failure, and perforations in parts of the body such as the stomch and intestines," she said.

Avastin is the world's bestselling cancer drug, and also is used to treat certain forms of colon, lung, kidney and brain cancers. So even though FDA formally revoked its approval of the drug to treat breast cancer, doctors still could prescribe it - but insurers may not pay for it. Including infusion fees, a year's treatment with Avastin can cost \$100,000.

Some insurers already had quit covering the drug's use in breast cancer after FDA's advisers twice, once last year and once last summer, urged revoking the approval.

But Medicare said Friday that it will keep paying for now.

The Statement from the U.S. healthcare program could mitigate concerns that patients using the drung would lose insurance coverage should the FDA revoke approval for its use in breast cancer.

In 2008, the FDA allowed Avastin to be marketed as a treatment for breast cancer taht has spread, or metastasized, to other parts of the body and is generally considered incurable. The approval came under a special program that allows patients access to promising treatments while their makers finish the studies needed for final proof that they really work as promised.

But when Avastin manufacturer Genentech did those studies, the data showed only a small effect on patients' tumor growth, not that they were living longer or had a better quality of life and not enough benefit to ourweigh such severe side effects, FDA concluded.

Genentech, part of Swiss drugmaker Roche Group, had argued that Avastin should remain available while it conducts more research to see if certain groups of patients might benefit from the drug.
