


#### Two Hundred and Twenty Five more House Lots!

as millions of dollars were at stake and the new direction was uncertain.

From the inception of the takeover of this new management of the Corozal Free Zone it was noticed that the complete network was in shambles. A lot of work had to be done and drastic measures had to be implemented in light of the sorrowful situation we encountered therein.

The Corozal Free Zone was plagued with the following problems before the advent of our new management in 2008.

- 1. Gross mismanagement of the Corozal Free Zone finances reflecting in the bills accountable to the Banks and the Private Sector. The audit for 2007 reflected profit of only \$30,000.00 Bze. per annum.
- 2. The Security System was in the most deplorable condition having being privatized costing the management \$600,000.00 per annum.
- 3. Security Personnel were working under inhumane conditions with very limited resources.
- 4. The infrastructure was in a sorrowful conditions. Streets were in bad shape. Garbage

was scattered all over the place and the drainage was a huge problem irrespective of the fact that the then P.U.P Government paid two million dollars for a thorough restructuring.

- 5. There were repeated incidences of fire.
- 6. Garbage collection was privatized yet the zone was maintained in very unhygienic conditions.

The Corozal Free Zone under this new management today has realized the following.

- 1. The administration of the Zone was restructured and people well capacitated were put in place. The result was that we established a better Management / Private Sector relationship recognizing the Corozal Free Zone Chamber of Commerce as the liaison between management and investors. Automatically uplifting investor confidence.
- 2. We created the sound fiscal management of the Zone and a transparent financial system where the first year audit reflected \$901,000.00 profit as compared to \$30,000.00 previously. We also put in place a yearly Social Interventions Program to the tune of some \$40,000.00 perannum.

- 3. The Zone's Infrastructure was upgraded. Streets paved, drainage improved drastically automatically which downgraded the flooding problems. Garbage collection under this new Corozal Free Zone (CFZ) Management has been more cost effective as the services has been greatly improved with the of procurement two compactor trucks. We restructured the entrance to the CFZ landscaping to give a more picturesque view of CFZ.
- 4. We completely upgraded and restructured the Security under Services CFZ Management creating a more investor and visitor friendly atmosphere while improving the working conditions of the employees. (Security hut, booths and bathroom facilities were upgraded with all amenities) We have a more visible security patrols which increased investor and visitor confidence while reducing the spate of burglaries.

Yet our management has seen savings of over \$120,000.00 perannum by centralizing the security services.



5. With the acquisition of a fire truck some two years ago and the construction of a fire station with all amenities the CFZ has seen reduced incidences of fire. There has been only one incidence of fire since the upgrading of the CFZ Fire Department.

6. Our employment capacity has been maintained at a stable level of basically 2,700 employees.

Since the takeover in 2008 this new management has shown relentless efforts in improving the conditions of the Corozal Free Zone and by extension the livelihood of all involved with the CFZ.

There is no question, that damn road is bloody slippery and will cause many more horrific accidents which will result in deaths.



## Mexican National Sentenced to 24 Years for Drug Trafficking and Importation of Drugs

Forty four year old Mexican National, Martin Urias who was caught with a large quantity of cocaine on Thursday, December 1st. was charged with drug trafficking and importation of drugs and sentenced to sixteen years in prison on Friday, December 2nd.

He had apparently been frequently travelling through Belize to Guatemala at least twice a month and back to Mexico. He claimed to be a shoe salesman but only travelled with samples.

We understand that after he had crossed the western border Urias was seen acting suspiciously as he neared a police checkpoint in the area where police were training. An alert police officer saw the pickup with Mexican Plates and recognized it because it had already been flagged by police in Benque Viejo some months ago.

A search of the vehicle in Corozal turned up nothing. It

was then taken over to the Corozal Police station where a detailed search yielded one hundred and eleven bricks of cocaine stamped XT stuffed inside a hidden compartment in the camper of his trailer. The cocaine amounted to a total of two hundred and eighty-four pounds with a street value of two million US dollars.

Magistrate Clive Lino sentenced Urias to eight years in prison and fined him \$100,000 for the count of drug trafficking. In default he will spend eight years in

prison. For the count of importation of drugs he was sentenced to eight years and also fined an extra \$100,000 or in default another eight years in prison.

The 'two' eight year sentences are to run concurrently, meaning he will serve eight, not sixteen years.

The default sentences for non-payment of the fines are consecutive, meaning he could serve a maximum of 24 years in prison. We understand that the fines have not been paid yet.

He is presently at the Hattieville prison, after appearing in Corozal Magistrate's Court on Friday and pleading guilty to Drug Trafficking and Importation of Drugs.

On Wednesday at a little after 6:00am the two hundred and eighty-four pounds of cocaine arrived and was destroyed here in Orange Walk at Loskot Sawmill.

The drugs were escorted from Belize City to Orange Walk in the dead of the night by the Anti Drug Unit along with other elements of the Police Department, the Media and the Judiciary.

The one hundred and eightyfour pounds of cocaine was completely destroyed in less than an hour in a cast-iron, cylindrical furnace at the Loskot Sawmill.

#### TRAFFIC SAFETY TIPS FOR DRIVERS

- 1. Check your motor vehicle to ensure that everything is in good working condition. Example- brakes, all lights, horn, wipers, tires, spare-tire, tire tools, oil, water, brake fluid & dash board gauges.
- 2.Ensure that your driver's license is valid and that your vehicle is licensed and insured.
- 3. Wear your seat belts at all times when on the highways. (It is an offence for drivers and front seat passengers not to wear seat belts on the high ways).
- 4.Don't carry passengers in the back of open pickup trucks. (Vehicle only insured to carry amount of passengers as stipulated on certificate of registration/title).
- 5.Don't drive if you are consuming Alcoholic beverages or taking medication (drugs). Have designated driver (alcohol and drugs affect your vision and judgement).
- 6. Avoid making calls on cell phone when driving, it is best to pull off to the right to make calls or to answer your cell phone, don't text whiles driving.
- 7. Wear your helmet at all times when operating or being carried as a passenger on a motor cycle.
- 8.Only overtake if you have a clear view of the road ahead, never overtake around blind curves or when driving over a hill.
- 9.Drive within the speed limit at all times.
- 10. Obey all traffic law and signs.

#### **FOOD AND NUTRITION**

#### **Food Allergy and Intolerances**

Food allergies or food intolerances affect nearly everyone at some point. People often have an unpleasant reaction to something they ate and wonder if they have a food allergy. One out of three people either say that they have a food allergy or that they modify the family diet because a family member is suspected of having a food allergy. But only about three percent of children have clinically proven allergic reactions to foods. In adults, the prevalence of food allergy drops to about one percent of the total population.

This difference between the clinically proven prevalence of food allergy and the public perception of the problem is in part due to reactions called "food intolerances" rather than food allergies. A food allergy, or hypersensitivity, is an abnormal response to a food that is triggered by the immune system. The immune system is not responsible for the symptoms of a food intolerance, even though these symptoms can resemble those of a food allergy.

It is extremely important for people who have true food allergies to identify them and prevent allergic reactions to food because these reactions can cause devastating illness and, in some cases, be fatal.

#### **How Allergic Reactions Work**

An allergic reaction involves two features of the human immune response. One is the production of immunoglobulin E (lgE), a type of protein called an antibody that circulates through the blood. The other is the mast cell, a specific cell that occurs in all body tissues but is especially common in areas of the body that are typical sites of allergic reactions, including the nose and throat, lungs, skin, and gastrointestinal tract.

The ability of a given individual to form lgE against something as benign as food is an inherited predisposition. Generally, such people come from families in which allergies are common - not necessarily food allergies but perhaps hay fever, asthma, or hives. Someone with two allergic parents is more likely to develop food allergies than someone with one allergic

#### Ny'm Good Belizean Bittles

**Creole Christmas Fruit Cake** 

**Total Time:** 1hr 52 mins **Yield:** 6 servings

#### Ingredients: Simple Syrup

1 cup granulated sugar1 cup water1 1/2 tbsps lemon zest, cut in strips2 tablespoons lemon juice

#### For the Cake

1/2 lb mixed dried fruits 2 sticks unsalted butter at room temperature 1 cup plus 2tbsps granulated sugar 4 large eggs 1/2 cup orange flavored liqueur 2 cups all-purpose flour 1 tsp baking powder 1/8 tsp salt 1/8 tsp ground cinnamon pinch freshly grated nutmeg 1/2 cup silvered almonds, toasted 1/2 cup pecan pieces

1/2 cup walnut pieces

1/4 cup rum

#### **Directions:**

Make a simple-syrup by combining the sugar and water in a medium-size saucepan over medium heat. Add the lemon zest and juice and bring to boil, stirring to dissolve the sugar. Boil for 2 mins and remove from the heat.

Combined the dried fruits in a large mixing bowl. Pour the simple-syrup over them, toss to coat and let steep for 5 mins. Strain and reserve the syrup.

Cream the butter and sugar together in the bowl of an electric mixer at low speed, occasionally scraping down the sides of the bowl with a rubber spatula. Beat until the mixture is fluffy and smooth, about 2 mins.

Add the eggs 1 at a time, mixing in between each addition on low speed and scraping down the sides of

the bowl as necessary. Add 1/4 cup of the liqueur and mix to incorporate.

Combine the flour, baking powder, salt, cinnamon and nutmeg in a mixing bowl and blend well. Add this mixture 1/2 cup at a time to the butter mixture with the mixer on low speed, each time mixing until smooth, about 2 mins. The batter will be thick.

Add the warm fruit and all of the nuts a little at a time, mixing well.

Preheat the oven to 350 degrees F.

We congratulate the organizers of this event, the San Joaquin Committee along with Mr. David Akierman and all the participants who together made the session productive and successful.



Before an allergic reaction can occur, a person who is predisposed to form lgE to foods first has to be exposed to the food. As this food is digested, it triggers certain cells to produce specifice lgE in large amounts. The lgE is then released and attaches to the surface of mast cells. The next time the person eats that food, it interacts with specific lgE on the surface of the mast cells and triggers the cells to release chemicals such as histamine. Depending upon the tissue in which they are released, these chemicals will cause a person to have various symptoms of food allergy. If the mast cells release chemicals in the ears, nose, and throat, a person may feel an itching in the mouth and may have trouble breathing or swallowing. If the affected mast cells are in the gastrointestinal tract, the person may have abdominal pain or diarrhea. The chemicals released by skin mast cells, in contrast, can prompt hives.

Food allergens (the food frag-

ments responsible for an allergic reaction) are proteins within the food that usually are not broken down by the heat of cooking or by stomach acids or enzymes that digest food. As a result, they survive to cross the gastrointestinal lining, enter the bloodstream, and go to target organs, causing allergic reactions throughout the body.

The complex process of digestion affects the timing and the location of a reaction. If people are allergic to a particular food, for example, they may first experience itching in the mouth as they start to eat the food. After the food is digested in the stomach, abdominal symptoms such as vomiting, diarrhea, or pain may start. When the food allergens enter and travel through the bloodstream, they can cause a drop in blood pressure. As the allergens reach the skin, they can induce hives or eczema, or when they reach the lungs, they may cause asthma. All of this takes place within few minutes to an hour.

Continued from page 11 butter or non-stick baking spray. Pour the batter into the pan and bake until golden brown and the top springs back when touched, about 45 to 50 mins (turning the pan to ensure even browning after 30 mins.)

Cool the cake for 20 mins in the pan, then remove and continue to cool upsidedown on wire racks.

Make tiny holes with a toothpick randomly on the rounded end of the cake.

Combine the remaining simple syrup with the remaining 1/4 of liqueur and the rum. Wrap the cake in a layer of cheesecloth and pour 1/4 cup of the syrup over the top of cake. Store in a plastic zip bag for 3 to 4 days until the cake is slightly stale.

Sprinkle syrup over cake once every 2 to 3 days until all of the syrup is used. Let the cake age for up to 3 weeks before eating.

#### **Brazil: 33 Dead in Truck-Bus Crash**

Sao Paulo (AP) - Brazilian authorities say a tractor-trailor has slammed into a bus carrying sugarcane cutters, killing at least 33 people and injuring 13 others.

A police spokesman says the truck driver lost control as he was rounding a corner and heading down a hill early Saturday December 3, 2011 near a town called Miracles in the

northeastern state of Bahia. The truck was carrying a load of contruction materials, which also slammed into the bus.

The driver of the truck survived and is in a local hospital. Some of the others injured are in grave condition.

The police official spoke on condition of anonymity, saying he was not authorized to provide details.

He says an investigation is ongoing.

#### Facebook Settles with FTC over Deception Charges

Facebook is settling with the Federal Trade Commission over charges it deceived consumers with its privacy settings to get people to share more personal information that they originally agreed to.

The FTC had charged that the social network told people they could keep the information they share private, then allowed it to be make public.

The charges go back to at least 2009, when Facebook changed its privacy settings so that information users may have deemed private, such as their list of friends, suddenly became viewable to everyone.

"They didn't warn users that this change was coming, or get their approval in advance", the FTC said.

The FTC said the settlement requires Facebook to get people's approval before changing how it shares their data. In a blog post, Facebook CEO Mark Zucherberg said the company has made a "a bunch of mistakes", But he adds that this has often overshadowed the good work Facebook has done. He says Facebook has addressed many of the FTC's concerns already.

The Settlement is similar to one Google agreed to earlier this year over its Buzz social networking service. Like Google, Facebook has agreed to obtain assessments of its privacy pratices by independent, third party auditors for the next 20 years.

Facebook isn't paying anything to settle the case, though future violations could lead to civil fines.

Zuckerberg said Facebook has created two new executive positions - a chief privacy officer of products and a chief privacy officer of policy as part of its response to the settlement.

#### iPhone 4 Explodes Midflight on Australian Airline

Apple's iPhones are always among the hottest gadgets of any holiday shopping season, but for one passenger on an Australian flight, the phone was too hot to handle - literally.

While on Australian flight Regional Express ZL319, a passenger's iPhone 4 (not the iPhone 4S, which is Apple's latest model) suddenly started "emitting a significant amount of dense smoke, accompanied by a red glow," according to a Regional Express statement.

The plane, which was flying from Lismore to Sydney, was in the midst of landing when the incident occured. "In accordance with company standard safety procedures, the flight attendant carried out recovery actions immediately, and the red glow was extinguished successfully," according to Regional Express' statement.

After landing, the iPhone was handed over to officials at the Australian Transport Safety Bureau. There's no official word yet on what caused the phone to combust.

KING-TV reports that the man hand-delivered an envelope addressed to "Sears manager". Inside were a note and a \$100 bill.

The Note said the man stole \$20 to \$30 from a cash register decades ago and wanted to pay back \$100.

Manager Gary Lorentson says he thinks the man's conscience "has been bothering him for the past 60 years".

Store security cameras recorded the man, but Sears officials said they don't know who he is and they won't release the video.

The Store plans to put the money toward helping needy families in the holiday season.

#### Egyptian Election Results deepen Israeli Fears

Jerusalem - For Israelis, the Islamist election surge in Egypt is depressing confirmation of a deeply primal fear: An inhospitable region is becoming more hostile still. This sentiment has been accompanied by a bittersweet sense that Israel was dismissed as alarmist when it warned months ago that the Arab Spring - widely perceived as the doing of liberals yearning to be free - could lead to Islamist governments.

Speaking for most people here, Israeli Defense Minister Ehud Barak called the emerging result of the first round of parliamentary voting in Egypt "very, very disturbing" and expressed concern about the fate of the landmark 1979 Egyptian Israeli peace treaty.

Experts here, as elsewhere, point out that political Islam comes in varying shades of green: The Muslim Brotherhood in Egypt has about a 10 percent lead over the more radical Salafists and appears far less eager to impose a devout lifestyle or seek conflict.

But most Israelis appear to have little patience for such distinctions. There is a sense that moderate Islamists are pulling off something of a con, lulling opponents into complacency, projecting a seemingly benign piety to exploit a naive public's hunger for clean government after years of corrupt, despotic rule. And there is a long memory of Iran, once friendly to Israel, where secular forces including the military helped depose the Shah in 1979 only to swiftly be streamrolled by fundamentalists.

Some of the fears - for example, that an Islamist - led government in Egypt would mold itself in Iran's image - may be overblown. Iran's clerical rule is unique in the Middle East, and the Muslim Brotherhood stresses the idea of a theocracy has no place in its ideology. Instead, it says it's committed to an Egypt that is civil, democratic, modern and constitutional.

Israel concerns about political Islam can be traced to its longstanding battle against Hezbollah guerrillas in Lebanon and more recently to 2006, when the Islamist Hamas group swept Palestinian legislative elections.

The Hamas victory triggered a process that ultimately left the militant group, considered a terrorist organization by much of the world for its suicide bombing campaigns and other violent acts, in control of the Gaza Strip. Since then, Hamas and other militants have used the territory as a launching pad for firing rockets into southern Israel.

The stakes in Egypt are much higher. Egypt is the largest and most influential Arab nation, with a U. S. - backed army that has staunchly honored a 1979 peace agreement with Israel.

The peace agreement has been a cornerstone of Israeli security policy for three decades, allowing the military to divert resources to fight foes in Lebanon, Gaza and the West Bank. The treaty has also been a boon for Egypt, bringing in billions in U. S. military assistance.

#### Digging for gold, children work in harsh conditions, paid with bags of dirt

Samba Diarra, 15, journeyed 200 miles to live in a plastic hut alone and work in an artisanal gold mine in Mali. The teen came to the mine to help support his five younger brothers and sisters.

Diarra's parents can't afford to send him to school because he has to support his younger siblings. He is one of at least 20,000 children working in Mali's artisanal mines.

Mali is Africa's third largest gold producer. Artisanal mines rely on heavy human labor and little mechanization. People throughout West Africa are flocking to work in the primitive pits.

"Globally, we've seen an increase with the number of

artisanal gold miners because of the rise of gold prices, but that doesn't necessarily translate to better living conditions," said Juliane Kippenberg who helped author a **Human Rights Watch Report** on Mali's mines.

The skyrocketing price of gold has led to a rush on the precious metal in the United States and throughout the world, but some of the mining that's helping feed the world's craving involves child labor and a dangerous process involving mercury.

Approximately 100,000 to 200,000 people in Mali are working in artisanal mines, according to the Human Rights Watch report. Kippenberg told NBC News Chief Foreign Correspondent Richard Engel that 20 to 30 percent of the workforce in

African artisanal mines is child labor. The report entitled, "A Poisonous Mix: Child Labor, Mercury and Artisanal Gold Mining in Mali," details abysmal working conditions.

The children working in the mines some as young as six years old, help dig shafts with pickaxes, lift and carry heavy bags of ore and pan the gold with an amalgamation process involving mercury.

Diarra spent his first day pulling up gold ore that was mined by men working deep underground. At the end of his first day, he was paid with a bag of dirt. Gold is currently trading at around \$1742 an ounce.

Some children working in the mines never get paid. Those who do, get just a few dollars a week.

Diarra still has dreams of a life away from the mines. Kippenberg said that it will be hard for Diarra to leave the mines.

Malian law actually bans child labor in artisanal mines, but the law is not heavily enforced.

One miner told Rock Center that he simply can't afford the fees to send his children to school so instead they work with him.

Approximately 12 percent of the world's gold is born from the grueling process of artisanal mining. The gold is sold to middlemen and eventually ends up in places like Dubai and Switzerland where it is melted and mixed with gold from large scale mines before it's turned into jewelry worn throughout the world.
