


ORANGE WALK CENTRAL GONE RED!

MESSAGE FROM THE CLERGY

3rd Sunday after Epiphany

Jesus said to them, "Follow me and I will make you fish for people". "Immediately they left their nets and followed him."

Conventional wisdom is filled with advise (is replete) that we take our time. "Haste makes waste", "Marry in haste, repent at your leisure". "Look before you leap". "Patience after all is a virtue". This conventional wisdom did not prevail in 1st Century Palestine. Jesus walking by the Sea of Galilee finds some burly, ragged fishermen, and he issued a simple invitation "Follow me" and they immediately left their nets, their boats, they even left Zebedee high and dry presumably with a net full of holes, and followed Jesus. They seemed content, to let goods, Kindred and this mortal life go. "Let go and Let God".

followed Jesus. They dropped everything. There was little or no hesitation to the call.

The readings for today is again as last week's about calling to serve, to Minister, to evangelize.

Jesus' enthusiasm and his certainty about his mission appealed to their youth. His divine solitude stirred their souls.

St. Augustine wrote, "Fisherman Peter did not lay aside his nets but only changed them". They would become fishers of men; and they would not just catch people but also mend them. We should maybe rethink conventional wisdom.

The New Testament shows us that everything of importance happens immediately. When Jesus healed the lepers, the blind men or those who could not walk or speak, the healing happened immediately. When he was Baptized, he rose immediately from the water. When Paul experienced his conversion, the scales fell from his eyes immediately. Scripture tells us, "immediately while Jesus was speaking Judas came to do his dirty work. When Peter denied Jesus, "Immediately the cock crowd". There are many times when we also act immediately. We act immediately for a sick child, a friend in trouble, we respond immediately. When someone needs food, shelter, clothing, help from an abusive step father, help from kidnapping, help with finance to bury their love ones, we should act immediately. There are many instances in our lives when immediate action was required in our lives when immediate action was required. We all have memories of times when we should have acted immediately. One of the most regretful time in one's life, is when we finally realized that what our young children needed from us, was our attention, love and concern. And now when they end up on the wrong side of the Law, we wish, we had given them that immediate attention, love and concern earlier.

This Gospel about fishing makes us imagine Jesus and his disciples with fishing poles in their hands. But, the Method they used was with Nets.

Matthew tells us, "They cast their nets in the sea, for they were fisherman". And this was for good reason. You see you must go out like Jesus and his disciples and find people to whom you will be hospitable, once you find them. This finding is done with Nets, not fishing poles.

This my friends, is aggressive evangelism. You see, fishing with nets is indiscriminate. A net will haul in any fish that can swim and not just certain or special kind. You see the fishing pole is like that. them because they make a lot of noise, so they are dangerous. Let us secretly tap the phones of those Arabs and other Minority groups who call their people in the Middle East, Africa, the Caribbean and elsewhere, but those who call Europe or who are calling from White neighborhoods are not dangerous.

My friends Evangelists are committed to rounding up all sorts and conditions of men and women without discriminating.

Jesus' Ministry was to outsiders, those on the fringes of society and not the inner circle elites and socialiates. Today, we would say that Jesus was inclusive. Jesus, over and over warned the Pharisees that they did not have a special corner at the market.

The Parable of the wedding feast tells us that the King told the servants to go out into the highways and byways and to bring in everyone, even those on the "B", "C", and "D" lists; even the maim and lame.

Fishing with nets is labour intensive. It is hard work. It is not like line fishing when you can sometimes take a nap waiting for the fish to bite. It takes a team

The disciples did not ask where they were going, how long they would be gone, what they would expect to do, or how much they would be paid. They simple left immediately and In the movie "Casablanca", the Police Captain told his ment to "round <u>up the usual</u> <u>suspects</u>". Put on death row those people with a dark skin color. Let us throw all the Negros in prison and build more jails for them, instead of building more schools and providing them with jobs.

Yes, because they are the only ones who commit crimes. We are scared of to haul, and cast, and set a net properly.

Therefore, evangelism is not a one man's show. Everyone must pull their weight. Fishing with Nets requires persistence and dedication. It is also possible to "fish all night and catch nothing (LK 5-5). The fisherman sometimes have to find a different site, a different fishing hole and





- 8. Only overtake if you have a clear view of the road ahead, never overtake around blind curves or when driving over a hill.





Becoming a Stepparent

Becoming a parent by blending families or marrying someone with kids can be rewarding and fulfilling experience. If you've never had kids, you'll get the opportunity to share your life with a younger person and help to shape his or her character. If you have kids, you'll offer them more opportunities to build relationships and establish a special bond that only siblings can have.

In some cases, your new family members may get along without a hitch (just like The Brady Bunch), but other times you can expect difficulties along the way. Figuring out your role as a parent - aside from the dayto-day responsibilities that come with it - also may lead to confusion or even conflict between you and your partner, your partner's exwife or ex-husband, and their kids.

While there is no foolproof formula for creating the "perfect" family (every family has its own dynamics), it's important to approach this new situation with patience and understanding for the feelings of those involved. Here's how to make things easier as you to grow.

Start out slow and try not to rush into things. Let things develop naturally kids can tell when adults are being fake or insincere. Over time, you can develop a deeper, more meaningful relationship with your stepchildren, which doesn't necessarily have to resemble the one they share with their birth parents.

Factors That Affect Your Relationship

Children who are mourning the loss of a deceased parent or the separation or divorce of their birth parents may need time to heal before they can full accept you as a new parent.

For those whose birth parents are still alive, remarriage may mean the end of hope that their parents will reunite. Even if it has been several years since the separation, kids (even grown ones!) often hang onto that hope for a long time. From the kids' perspective, this reality can make them feel angry, hurt and confused.

Other factors that may affect the transition into

parents before they separated and are blamed for the break-up), but in most cases having a history together makes the transition a little smoother.

How long you dated the parent before marriage.

Again, there are exceptions but typically if you don't rush into the relationship with the adult, kids have a good sense that you are in this for the long haul.

How well the parent you marry gets along with the ex-spouse.

This is critical factor. Minimal conflict and open communication between expartners can make a big difference regarding how easily kids accept you as their stepparent. It's much easier for kids to transition to new living arrangements when adults keep negative comments out of earshot.

How much time the kids spend with you.

Trying to bond with kids every other weekend when they want quality time with a birth parent they don't see as often as they'd like - can be a difficult way to make friends with your new stepkids. Remember to put their needs first: If kids want time with their birth parent, they should get it. So sometimes making yourself scarce can help smooth the path to a better relationship in the long run.

patience and grace.

Steps to Great Stepparenting

All parents face difficulties now and then. But when you're a stepparentm, those obstacles are compounded by the fact that you are not the birth parent - this can open up power struggles within the family, whether it's from the kids, your partner's ex, or even your partner.

When times get tough, however, putting kids' needs first can help you make good decisions. Here's how:

Put needs, not wants, first.

Kids need love, affection, and consistent rules above all else. Giving them toys or treats, especially if they're not earned with good grades or behavior, can lead to a situation where you feel like you're trading gifts for love. Similarly, if you feel guilty for treating your biological kids differently from you stepchildren, don't buy gifts to make up for it. Do you best to figure out how to treat them more equally.

House rules matter.

Start Slow

The initial role of a stepparent is that of another caring adult in a child's life, similar to a loving family member or mentor. You may desire a closer bond right away, and might wonder what you're doing wrong if your new stepchild doesn't warm up to you or your kids as quickly as you'd like but relationships need time

How old the kids are.

When it comes to adjusting and forming new relationships, younger kids generally have an easier time than older kids.

How long you've known them.

Usually, the longer you know the kids, the better the relationship. There are exceptions (for example, if you were friends with the Knowing ahead of time what situations may become problematic as you bring new family members together can help you prepare so that , if complications arise, you can handle them with an extra dose of Keep your house rules as consistent as possible for all kids, whether they're your kids from a previous relationship, your partner's kids from a previous relationship, or new children you have had together. Children and teens will have different rules, but they should be consistently applied at all times. This helps kids adjust to transitions, like moving to a new

house or welcoming a new baby, and helps them feel that all kids in your home are treated equally. If kids are dealing with two very different sets of rules in each home, it may be time for an adults-only family meeting - otherwise kids can learn to "work the system" for short-term gain but long-term problems.

Create new family traditions.

Find special activities to do with your stepkids, but be sure to get their feedback. Some new family traditions could include board game nights, bike riding together, cooking, doing crafts, or even playing quick word games in the car. The key is to have fun together, not to try to win their love kids are smart and will quickly figure out if you're trying to force a relation-ship.

Respect all parents.

When a partner's ex is deceased, it's important to be sensitive to and honor that person. If you and your partner share custody with the birth parent, try to be courteous and compassionate in your interactions with each other (no matter how hard that can be!). Never say negative things about the birth parent in front of the kids. Doing so often backfires and kids get angry with the parent making the remarks. No child likes to hear their parents criticized, even if he or she is complaining about them to you.

Don't use kids as messen-

gers or go-between.

Try not to question kids about what's happening in the other household they'll resent it when they fell that they're being asked to "spy" on another parent. Wherever possible, communication directly with the other parent about relevant matters, such as scheduling, visitation, health issues, or school problems. Online custody calendars make this process a little easier because parents can note visitation days and share this information with each other via the Internet.

Talk to your partner or spouse.

Communications between you and your partner is important so that you can make parenting decisions together. This is especially crucial if you each have different notions on parenting and discipline. If you're new to parenting as a stepparent, ask your partner what would be the best way to get to know the kids. Use resources to find out what kids of different ages are interested in - and don't forget to ask them.

No matter what the circumstances of your new family, chances are there'll be some bumps along the way. But don't give up trying to make things work - even if things started off a little rocky, they still can (and probably will) improve as you and your new family members get to know each other better.

EMBRACING *History*

Philip S. W. Goldson

Philip Stanley Wilberforce Goldson was born on the 25th of July 1923 in Belize City. He was the second son of Peter Edward Goldson and his wife Florence Matilda Babb Goldson.

Philip Goldson started life as a person of modest means and was able within his 78 years to soar above the various diverse circumstances that would govern his illustrious life.

He attended St. Mary's Primary School and althoug he never had the opportunity to go to high school he studied at night and successfully obtained the Cambridge University Overseas Junior certificate in 1939, and the Senior School Certificate in 1941.

From 1941 to 1947 he worked in the British Honduras Civil Service. While in the Civil Service, Goldson started his career in journalism editing the "Civil Service Chronicle", "OUT LOOK", a cultural quarterly of the St. John's College Literary Society and writing short stories and sketches for the BBC in London. With the advent of the Nationalist Movement, he wrote news items for the Belize Billboard.


the People's Committee (a committee formed on December 31st, 1949 to protest devaluation) dissolved itself and the P e o p l e's United Party was formed. Its first lead-

ers were: John Smith, HON

Leader; Leigh Richardson, Chairman; George Price, Secretary; and Philip Goldson, Assistant Secretary.

From 1950 to 1956 Philip Goldson continued as a Member of the People's United Party. During that year he became the editor of the Belize Billboard and later that year the managing editor.

Entrenched Colonialism was hard to reform. The Establishment was complacent, self-satisfied and suspicious of innovation. Even many members of the working class failed to realize the depth of the problems facing the Colony and the difference between their way of life and other

While in prison he spent much of his time teaching some of his fellow inmates to read and write.

Prior to going to jail for his ideal Mr. Goldson won a seat to the Belize City Council and had served as Vice President (Deputy Mayor) until his conviction.

Once free he went back gladly to public life and in 1954 won a seat in the British Honduras Legislative Council where he was appointed member (quasi-Minister) for Social Services, a post he served with dignity until 1957.

His portfolio included Labour, Housing and Planing, Health, Education and Social Welfare and Community Development. During this period he coordinated the building of Corozal Town after its destruction in 1955 by Hurricane Janet. and initiated special allowance for retired teachers who up to then did not enjoy pension benefits, confirmed Belize as contributing member of the U.W.I., also established Department of Housing and Planning with Henry C. Fairweather as its first Director and Town Planner, and revised Government Workers Rules establishing the check-off system for trade unions.

Because of disagreements and conflict of principle Mr. Goldson, Leigh Richardson and others resigned from the People's United Party in 1956 and formed the Honduras Independence Party. Mr. Goldson lost his bid for a seat in the Government in the 1957 elections.

On July 1st, 1958 the new Party joined with the National Party to form the National Independence Party and Mr. Goldson became the Party Secretary and was the NIP leadership and leader of the Opposition to 1979.

In 1973 the National Independence Party merged with two other Oppositions groups, the People's Development Movement and the Liberal Party to form the United Democratic Party. There were new challenges, new jobs to be done, and new campaigns to plan. He served as Deputy Party Leader from 1979-1982. He resigned from the UDP in 1991 in opposition to the passage of the Maritime Areas Act, and formed and

The plight of the workers in Belize led him into trade unionism. He became the National Organizer of The General Workers Union in 1949 and later became its General Secretary.

Dr. Manuel Esquivel

Dr. Manuel Esquivel, KCMG, PC was born on May 2nd, 1940 and is a Belizean politician. As a leader of the United Democratic Party, he served as Prime Minister from 1984 to 1989, and then again from 1993 to 1998.

Manuel Esquivel, born in Belize City when it was still the colony's capital, studied a Bachelor of Science in Physics at Loyola University New Orleans; he subsequently pursued post-graduate studies in physics at Bristol University, England. He taught science and mathematics at Saint John's Junior College in Belize City before becoming involved in politics.

He was one of the founders of the United Democratic Party and was chosen as the party leader. Elected to

the Senate (the upper

Chamber of the National Legislature) in 1979, Esquivel served as Minister of Finance and as Minister of Defense and Economic Devlopment.

He was appointed to the Privy Council of the United Kingdom by Queen Elizabeth II. This life-time appointment confers the title "Right Honourable". He also holds an Honorary Doctorate of

When the party lost power in 1989, it still held the second largest number of seats in the legislature, making him the leader of the offi-

cial opposition. After the UDP won the February 2008 election, Dr. Manuel Esquivel was appointed by Prime Minister Dean Barrow as senior advisor to government with the rank of minister on February 12, 2008.

Dr. Manuel Esquivel is married to wife Kathleen (Kathy), with three children. Daughter Laura has followed in her Father's footsteps as City Councillor under the UDP since March 2006. Dr. Manuel Esquivel was appointed Knight Commander of the Order of St. Michael and St. George (KCMG) in the 2010 New Year Honours.





INTERNATIONAL NEWS Is The Multimillionaire A Belizean?

DES MOINES, Iowa (AP) - A New York attorney's decision to withdraw his claim on a multmillion dollar Iowa Lottery prize doesn't put to rest official's questions about how he obtained the ticket.

Iowa lawmakers say they are satisfied with the Iowa Lottery's handling of a \$14.3 million Hot Lotto jackpot claim that was eventually withdrawn.

Crawford Shaw, of Bedford, N.Y., withdrew his claim last Thursday on a multimillion dollar Iowa Lottery prize just as mysteriously as he has made it, saying through a Des Moines law firm that he couldn't satisfy lottery officials' request for basic information about how he obtained the winning ticket.

The lottery has asked the Iowa Division of Criminal Investigation and the Iowa attorney general to investigate.

Officials say Shaw submitted the ticket for redemption on behalf of a trust on Dec. 29, less than two hours before it expired, and has identified the recipient only as a corporation in the country of Belize. The lotthe winning ticket was purchased at a Des Moines gas station in December 2010. The payout for the prize would have been \$7.5 million cash, or \$10.3 million spread over 25 years after taxes.

Iowa lottery officials had given Shaw until Friday to provide the identities and contact information of anyone who purchased or possessed the ticket. Shaw, as Trustee for and on behalf of the Trust, does hereby withdraw the Claim and does hereby agree to take no further action to enforce the Claim," the fax signed by Shaw reads.

Shaw signed the ticket on behalf of Bedford, N.Y. based Hexham Investments Trust, though lottery officials have said he misspelled the name of the trust by leaving off the second 'h'. Shaw claimed not to



Instead of claiming the prize in person, as is normally done, Shaw signed the ticket on behalf of the trust and shipped it by FedEx to a Des Moines law firm he had retained.

Shaw, 76, sent a fax to the law firm Thursday saying he doesn't know the iden-

be a beneficiary of the Trust.

Iowa Lottery CEO Terry Rich said Thursday that it's the strangest situation officials can recall in the 26year history of the lottery. He declined to speculate on the details of the claim, saying if he knew more than what's been released, lotFirm that if the jackpot were paid, the money would be donated to charity. He declined to comment further Thursday.

Records show Shaw played at least a minor role in the collapse of Industrial Enterprises of America, a chemical company that was looted and bankrupted in 2009 by a stock manipulation scheme. Shaw helped found the company after taking control of a Houston-based shell corporation, serving as its CEO from 2004 to 2005.



At least 10 people were confirmed dead, including students at a college and an elementary school and others in a town market that collapsed. About 100 were injured.

The quake, which hit at 11:49 a.m. local time (10:49 p.m. ET), triggered another landslide in the mountain village of Solongon in La Libertad town, also in Negros Oriental. An unknown number of people were trapped. Three key bridges in the town suffered cracks and were no longer passable.

Philippine seismologists briefly issued a tsunami alert for the central islands. Five bamboo and wooden cottages were washed out from a beach resort in La Libertad by huge waves, but there were no reports of injuries. Elsewhere along the coast, people rushed out of schools, malls and offices.

The epicenter was closest to Tayasan, a coastal town of about 32,000 people flanked by mountains in Negros Oriental province. Two died there, including a child when a concrete fence of a house collapsed. recorded nearly 45 aftershocks.

A three-story office building also collapsed in La Libertad, but occupants managed to run out.

Negros Oriental police chief Edward Carranza said the temblor damaged many houses in Guihulngan and he ordered his men to help displaced residents find shelter.

Officials in some areas suspended work and canceled classes. Power and telecommunications were knocked out in several places.

Carranza said police rushed out of his building when the quake struck.

The U.S. Geological Survey said the quake was centered 44 miles (72 kilometers) north of Dumaguete city on Negros and hit at a depth of 29 miles (46 kilometers). The area is about 400 miles (650 kilometers) southeast of the capital, Manila.

The situation appears to have worsened for the Mali government over the past few days. The rebels have retaken the town of Menaka, a certain unspecified number of soldiers and civilians had been killed by the rebels in the town of Aguelhok. In Bamako, the capital, families of soldiers have demonstrated against what they say is the government's poor handling of the rebel offensive, blocking roads and burning tires. The defense minister has been replaced, and reprisals have been reported against Tuareg citizens living in the south.

Officials in Bamako make no secret of their shock at what one Western diplomat called the "robustness" of the rebel incursion.

The Malians, who viewed Colonel Qaddafi as a generous benefactor - he helped build an administrative complex here, among other things - now find themselves gnashing their teeth over this less beneficent aspect of his legacy. Still, officials here insist that the situation in the north is under control, while acknowledging that the threat is not over. In some ways, the aggressive new Tuareg campaign represents the kind of support the rebels had long sought from Colonel Qaddafi, who for years alternately aided and betrayed the desert warriors, according to a recent study by Mr. Boilley. After the great regional droughts of the 1970s and 1980s, young Tuaregs migrated north to the colonel's military training camps, to later fight for him in places like Chad, while at the same time destabilizing the governments in Niger and Mali.

Libya, with its World Revolutionary Center, where the warlords Charles Taylor of Liberia and Foday Sankoh of Sierra Leone were schooled in Colonel Qaddafi's doctrines, became the regional matrix of instability.

Colonel Qaddafi backed independence movements all over Africa, including a coup attempt in Sudan in 1976, and he supported pariah governments the West shied away from, like the military junta in Gambia in 1994.

Another child was killed in a church when a wall collapsed during a funeral in Negros Oriental's Jimalalud town.

Tayasan police officer Alfred Vicente Silvosa told The AP by phone that aftershocks were preventing people from returning to their homes. Seismologists USGS put the quake at 6.7 in magnitude and a depth of 12.4 miles (19.8 kms). Two aftershocks, of 4.8 and 5.6 magnitude on the USGS scale, followed within 30 minutes of the earthquake.

The Philippines is located in the Pacific "Ring of Fire" where earthquakes and volcanic activity are common. A 7.7 magnitude quake killed nearly 2,000 people in Luzon in 1990. Analysts who study the region agree that the latest Tuareg resurgence is something new, and that Colonel Qaddafi is largely responsible, posthumously. His most significant African venture was in Chad during the 1980s, when he backed a rebel group against the government, with an eye toward capturing a mineral-rich border area. His surrogates were defeated by Chad's government in 1987, but Libyan troops did not leave the disputed border strip until 1994.
