

SAN IGNACIO TOWN, Cavo District, Wednesday, November 14, 2007:

San Ignacio Police today reported the apprehension of a man suspected to be responsible for burglarizing a number of churches in the community.

Based on information received, San Ignacio Police visited the Minerva Lane, San Ignacio Town home of Ryan "Fing" Coleman, 23, Belizean musician, a search of the house reportedly resulted in the recovery of several items suspected to have been stolen over the past few weeks from at least two evangelical churches located on Joseph Andrews Drive in San Ignacio Town.

In the first reported case, on Saturday, November 3, 2007, Lionel **Fuentes**, visited the San Ignacio Police Station where he reported that at around 9:30 p.m., on Thursday, November 1, the New Life Ministry Church located on Joseph Andrews Drive in San Ignacio town was secured and locked after the night's church service.

He told the police that when he returned to the church at around 7:30 a.m., on Saturday, November 3, 2007, he observed that the church was broken into. Further checks revealed that the church's Yamaha brand silver keyboard valued at \$2,000 along with a PO Mixer valued at \$1,800 were missing.

In the second incident, **Alberto** Cano from the Iglesia De Dios Pentecostes Bethel Church, also located on Joseph Andrews Drive in San Ignacio Town, visited the San Ignacio police station and reported that sometime between 9:00 p.m., on Thursday, November 8 and 2:00 p.m., on Friday, November 9, 2007, his church was broken into and stolen therefrom were: i) one gray Yamaha piano 295 PSR valued at \$800, ii) one black and gray Yamaha piano PSR 550 valued at \$500 and iii) one 600 watts PV amplifier.

Police investigation led to the arrest of Ryan Coleman. He was formally arrested and charged for two counts of burglary in connection with the reported incident at both churches.

The accused, Ryan Coleman appeared before San Ignacio's Magistrate, Mrs. Kathlene Lewis, on Wednesday, November 14 where he pleaded not guilty to both charges. He was subsequently remanded to the Hattieville prison to reappear in court on Wednesday, January 9, 2008.☆

Consultation Tour? This Must Be The Sickest Joke We Have Heard In Recent Times

Some of the most intelligent Belizeans are either directly engaged or in some way connected to the party political sector of the Belizean society.

Both political parties can therefore be credited with having brilliant minds within their ranks.

How is it then, we ask, that those brilliant minds within the ruling People's United Party could have allowed for the recently concluded Prime Ministerial tour to proceed under the banner: "The Prime Minister's Consultation Tour".

With whom was the Prime Minister consulting on this tour that was paid for by the taxpayers of this nation?

At every stop on the tour, the Prime Minister visited with and spoke to school children. On several of the televised political advertisements produced at the end of each stop, we saw the Prime Minster addressing school children most of whom did not have a clue as to what he was talking about and most of whom are far below voting age.

On the flip side, consultation is woefully lacking in those critical areas where consultation is truly required.

The nation is yearning for meaningful consultation on the matter of its petroleum industry but there is no consultation.

Consultation is desperately needed in the area of the intended nationwide roll out of the National Health Insurance scheme, again there is none.

Consultation was needed in the plan to convert our district hospitals into poly clinics – still there was none.

Consultation should have been a must as government is insisting to further dip into the Social Security funds for partisan political purposes as it ventures to increase payments for none contributing senior citizens.

Consultation was needed for the free text book program which continues to hiccup under the hasty implementation process.

Then, despite massive national outcry against tax payers taking on the private debt incurred by the principals of Universal Health Services, there are reports of the continuing footing of this bill.

There is also the matter of non-consultation in respect of the buy back - sale – buy back and reselling of the BTL.

More recently there was the Bacalar Chico fiasco; the Profit Sharing Agreement as it pertains to the oil industry; the attempt imposition of burdensome fees, on short notice, at the western border station;

There is also the case of that large amount of Nepalese laborers working on the construction of the dam at Vaca Falls which is depriving countless Belizeans of the opportunity for much needed employment; and among many others, there is the nationwide imposition of the \$10 motor vehicle inspection tax.

At the end of several weeks on his "consultation tour", at tax payers expense, what does the Prime Minister have to show the Belizean people on the national way forward?

Does he now have a solid plan on how the nation wants him to handle the national petroleum industry? Is he in a better position to chart the way forward, in terms of the sustainable funding and the implementation of a workable mechanism for the nationwide roll out of the National Health Insurance scheme?

What did he gather on the tour in terms of the nation's view on the subject of an elected Senate?

Does the Prime Minister even know that a Nepalese work force has invaded and is taking away a sizable chunk of jobs at the site where the dam at Vaca Falls is being constructed? Does he have a plan to reverse this situation? Does he even care that Belizeans are being squeezed out of employment opportunities while all of us will be repaying the almost 100 million dollars for the construction of this dam? Does he know if this foreign work force is in possession of work permits? Does he know if they are paying into the Social Security Scheme being the very same source that he is preparing to further drain in order to advance his political agenda?

The brilliant minds within the PUP could have selected any other name for the tour, but "Consultation Tour". This must be the sickest joke we have heard in recent times.



We are gathered here this afternoon, not to mourn the passing, but rather to pay tribute and final respects and indeed to celebrate the life of such a fine Lady as was Ms. Nicolasa Urbina.

To some of us she was Tia Nick, to others she was Miss Nick and Mama Nick.

Tia Nick was the 6th child of a dozen children born on March 5, 1921, right here in Santa Elena, to Donatilia Hernandez and Arcadio Urbina.

In her days Tia Nick was also a Banker – Many are the syndicates she ran among family and friends. And no one ever accused her of dishonesty in the handling of their money.

Tia Nick lived 86 full years. Although she was born right here in Santa Elena, Tia Nick lived in various parts of Belize. She also spent a few years living in Chetumal, Mexico.

Even though she was an avid Christian, Tia Nick loved a party. She lived for Birthday

And they tell me that when they are in Melchor and they get hungry, Tia Nick was always there to the rescue with her corn tortilla, cheese dip and chicharon that she always took along in

"Don Galindo" which is the name she gave to the bag that contained all the goodies.

As we gather here this afternoon; Let us reflect on the kindness that Tia Nick showered on many of us.

Let us reflect on the positive contributions she made in our lives.

Let us reflect on the Lady that truly loved and cared for her family, acquaintances and friends.

Let us reflect on the person who always provided that shoulder for us to lean on and that ear to listen to our concerns in our times of need.

Tia Nick is survived by two sisters, Miss Goya Urbina and Mrs. Cathy Butcher. She is also survived by many nieces, nephews and countless friends.

And so as we celebrate the life of this Truly Wonderful Lady, let us make a personal commitment to carry on her legacy in sharing LOVE, RESPECT and KINDNESS to one another.

We bid you farewell Tia Nick. We know that you have gone in PEACE. We know that you are resting in PEACE.

You have touched many of our lives and for this we will always love and remember you. Continue to rest in Peace Tia Nick until we meet again.☆



San Ignacio's Postmaster Gets An Apology!

An irate Postmaster from the San Ignacio Town post office is the first person to respond to last week's article, on the drive for political independence, by Anthony de Leon, in a provocative article, about achieving **INDEPENDENCE** from Twin Towns local government, for the Hillview community and forming a village to get more services for the community.

As the author of that article in last weekend's edition of the STAR **Newspaper**, I got the brunt when the Postmaster informed me that the Post Office was **NOW** delivering mail into the Hillview area door to door and had been doing so for several months. I promised a correction in the newspaper.

The Postmaster said they had been delivering mail directly to houses, about once a week over the last few months

into the Hillview Community on the slope of Green Parrot Valley. Since that is news, I hereby apologize and am happy to hear it.

The Postmaster and I had a short conversation about the possibility of installing a set of Post Boxes under a rain shade on a concrete platform, as used in rural village areas in Florida, somewhere central in the community. He said, it might be impractical due to vandalism and thievery unless it was installed in a public area with a lot of traffic.

Mr. Anthony de Leon, the local mover and shaker for Hillview political independence as a village, I am informed, intended to bring up this very same suggestion with PUPArea Representative, Mario Castellanos. I hadn't heard any result of such a conversation.

It would seem to me these gentlemen might find it less expensive to install a shaded set of locked post boxes on posts set on a concrete platform between the Cheese Factory and Betty's General Grocery Store in the center of the community. There is traffic in the area almost 20 hours per day, going back and forth and it is central to most residents. It would certainly save time and money for the Post Office delivery man with only one stop on his bicycle and perhaps earn a few dollars box rental for the Central Post Office in San Ignacio. Community growing pains require solutions and this is one idea thrown into the hat for discussion by those concerned with such things.

So far, there has been no other

backlash to the provocative article. Except the comments from local residents, that since we get nothing from the Town Council, we could probably get MORE NOTHING from our own village council. At least there would be some property taxes and business license money to work with to fix our bad street corners.

was six years ago, or even longer. The houses are painted, additions being added, trees and decorative shrubbery growing and if we had asphalt paved streets, you would not even recognize the old DFC housing estate. A very few foreclosed houses are now being auctioned off at prices reminiscent of the early boom days in the beginning. They sank to half price for some years, but now have bounced back and it has become a most desired location \(\xi \)

Stand-Off Resolved At The Western Border Station

BELIZE'S WESTERN BORDER STATION, Benque Viejo, Cayo, Thursday, November 15, 2007:

Last week we reported on the stand-off at the Western Border Station whereby customs brokers and importers were protesting the Border Management Agency's imposition of new operational fees and in the process, for five days, brokers and importers refused to clear their imported cargo until the new fees were rescinded.

An instruction from the Ministry of Finance for the suspension of the proposed fees was received at the Western Border Station at around mid-day on Friday, November 9, 2007, and by 1:30 p.m., importers began clearing their goods under the

previous rate structure.

The temporary reprieve was offered on the understanding that stakeholders in the industry would meet to determine a fee structure acceptable to all.

After a first meeting with the Prime Minister in Belmopan and a subsequent meeting between a working group, at the offices of the Belize Chamber of Commerce in Belize City, the situation appears to have been ironed out with the agreed reduced charges as outlined in the table at the left.

Kevin Herrera, General Manager of the Belize Chamber of Commerce informed the media: "At that meeting we were able to make breakthroughs on two of the categories, that is the overnight parking and the ramp use fees.

We still had some issues with the overall parking, I think that was called the "visual inspection" fee previously. The users of the facility, had a major issue with that category and with the name of that category.

We were able to come to a compromise. Most of the fees were slashed in half and some even less, in one or two cases.

So it was tough negotiations, but I think we got something much better than what was being proposed.

I think we live in an era where government and other agencies need to stop trying to just push things down on everybody and try to consult a little more."

Herrera additionally informed that the G.O.B. has agreed that the productive sector needs special consideration.

The new fees are scheduled to come into effect on Monday, November 19, 2007.☆

BNE Confirms Oil In Never Delay and Spanish Lookout Landowners Receive Royalty

SANTA ELENA TOWN, Cayo, Wednesday, November 14, 2007:

Belize Natural Energy (BNE) has confirmed that the newest well called Never Delay No. 1 has produced oil and gas which warranted testing.

The test drilling was completed in November and additional evaluation is being conducted before the commercial value of this latest discovery can be determined.

In other news coming out of Belize Natural Energy, landowners in Spanish Lookout are getting the first royalty payment for the extraction of oil from their lands.

The payment of over four hundred and thirty-three thousand dollars was received earlier this week.

It represents five percent of governments' seven percent take on

the product extracted by the BNE.

Land owners in Duck Run are also set to receive royalty payments to the tune of forty thousand dollars which they will get as soon as they get their land documents in order.

These payments are for production during the period January 2006 to June 2007.

Government's take during that same period amounted to nine and a half million Belize dollars.

The latest figure as contained in the Petroleum Register shows that the GOB's royalty through September 2007 is in the region of 12.33 million dollars.

The bulk of government's oil revenues comes from the forty percent income tax on BNE's profits. ☆

As anticipated, based on the results of earlier drilling operations in the area as reflected in Eagle No. 1 Well, Never Delay No. 1 produced oil and gas shows. The shows were sufficient to warrant testing of the well, the first of which was undertaken on October 26th 2007.

The drilling of the well was completed on the 6th of November of 2007 and further tests are now being conducted. Once tests are completed and results obtained, a determination of whether the well is of potential commercial interest can then be made.

BNE is adhering to the procedures as set out in the Petroleum Regulations and the Production Sharing Agreement entered into with the Government of Belize in 2003.

BNE thanks the landowners who have supported and collaborated in making the establishment of a viable oil industry a reality. It is only with their continued support and vision that further reserves will be found thus dramatically improving the socio-economic reality of Belize and its people.


Although the accident is yet to produce an arrest, the police informed that a case file has been submitted to the Director of Public Prosecutions for perusal and legal advice.

Extremely Slippery And Dangerous When Wet

The motoring public is therefore advised to exercise care at ALL times when crossing this bridge.

Drivers must exercise EXTREME care when the wooden surface is wet as a combination of the water and the oil creates a dangerously slippery condition. The risk is compounded when speeding is factored into the equation as vehicles descend the hill on both approaches to the bridge especially when approaching from the steeper hill on the Santa Elena side of the bridge.

Since the structure forms a part of the national highway network, the Ministry of Works would be well within its jurisdiction to erect the necessary warning signs in the area for the safety of all road users.
