

# CASTELLANOS, RUIZ & TOT CHARGED FOR TRAFFICKING IN 108 POUNDS OF WEED

#### CENTRAL FARM, CAYO, Monday, December 3, 2007:

Officials from the Customs Department were round and about their regular duties on a feeder road in Central Farm when, a few minutes after 12 noon on Monday, December 3, they accidentally came upon a car with three occupants, moving two sacks of weed just five miles outside of San Ignacio Town.

After making the surprise discovery, Customs officials at the checkpoint immediately contacted police headquarters in Belmopan and a team of officers from the Anti-Drug Unit (ADU) was instantly dispatched to the location to take over the arrest.

When the ADU team arrived, Custom officials handed over the two sacks of marijuana, a black Toyota Camry car (without license plates) and the three male persons who were inside the vehicle when it approached the checkpoint.

The three occupants were

subsequently identified as **Edward Castellanos**, 33, Belizean Taxi driver of a Santa Elena, Cayo address; **Romaldo DuarteTot**, 31, Taxi driver residing in Succotz Village, Cayo and **William Ruiz**, 32, labourer from Arenal Village, Cayo.

The weed, the car and the three detainees were transported to the San Ignacio police station where the "suspected marijuana" was placed on a scale and tallied at 49 kilograms (108 pounds).

All three suspects were jointly charged with drug trafficking and taken before San

Ignacio's Magistrate **Kathleen Lewis** where they all pleaded not guilty to the charge. They are presently out on \$10,000 bail and will be reappearing in court on

This was very hard on the ears and made conversation impossible. Both places appeared to be void of patrons, and this is understandable. If the music is much too loud from several feet away from these establishments one can only imagine what it sounds like inside. I can't imagine anyone wanting to risk damaging their hearing by going inside; and conversation is out of the question.

I believe that the loud music is the reason for a lack of customers. There is also a bar/club on West Street that employs the same tactic to attract customers and it is mostly empty as well; the music begins around 9.30 pm and continues nonstop until 3.00 am.

There are several tourist accommodations in this area and the loud music keep the tourists awake all night making it difficult and uncomfortable for them to make the early time necessary to take the various tours. This is not good for repeat business.

And even the man they arrested has never been tried because the police say they don't have his trial ready.

Our peaceful village of Blackman Eddy has only about 400 people and we all get along, but 13 murders with no investigation and no convictions really shows that the police don't give a damn about us, and they wont get off their fat lazy arses and do what they are paid to do. For shame. that the people he is in charge of aren't doing their job?

# Former PUP Minister Daniel Silva Jr. Expresses Concern About Civil Works On The Bullet Tree Road

SAN IGNACIO TOWN, Cayo District, Thursday December 6, 2007:

I am writing to express my concern on the works currently being undertaken in respect of the paving of the Bullet Tree Road.

The paving of the road from San Ignacio Town to the village of Bullet Tree Falls is welcome news for the residents of San Ignacio, Bullet Tree, Santa Familia and surrounding communities. We are happy that the project is being realized and would like to thank the present government for it. However it concerns me a great deal that the project is deceptive and that the pavement is of substandard quality as depicted in the accompanying photographs.

What is happening at present is that the contractor is taking a layer of white marl with a little amount of stones and dumping it into the potholes, after which the roller passes over it and the asphalt is applied.

This is an improper undertaking as the road has many soft spots all of which will gradually sink under the weight of heavy vehicular traffic thereby creating large potholes which will result in rapid deterioration.

I also noticed that the bridge was built with 3/8 steel and no chippings. This is a matter of urgent concern. It

is an accident waiting to happen when the bridge is subjected to the stress from the weight of heavy vehicles.

What is equally disturbing is the lack of supervision from the Ministry of Works. The time has come for those responsible to become more



The deceptive sign in the area accountable to the people, our tax dollars are being wasted.

It is sad to see roads being paved here in the Cayo area then three months later they simply fall apart. Another area of concern is the contract. There is a big sign erected in the areas which proudly announces that the works encompasses **"UPGRADING AND PAVING 3 MILES BULLET TREE ROAD"** However when you check the distance with the odometer in your car, the distance is only 1.7 miles. It is not even two full miles.

I am therefore asking the people who awarded the contract, to measure the distance for themselves and then demand a refund from the contractor, as even if the road is paved all the way to downtown San Ignacio it will still not make up for the professed "3 miles".

About a month ago I wrote a correspondence to **Michael Tewes** in his capacity as the Chief Executive Officer in the Ministry of Works. In that correspondence I expressed concern about the quality of works being undertaken and, in the absence of a response, I can only suspect that the CEO has elected to ignore the concerns I raised.

I am of the firm belief that the people of Belize deserve roads that will last for 20 years or more. An example being that stretch of the Western Highway between the western municipalities of San Ignacio to Benque Viejo. We do not deserve, and can ill afford, projects like the one that is being undertaken between San Ignacio and Bullet Tree Falls. This is hardly the first time that we are being taken for a ride as it pertains to the Bullet Tree road. This very same road has been **"paved"** twice in the last five years.

I am hereby calling on the Minister of Works to kindly investigate this matter of grave concern. I would like for the CEO - MOW to remember the infamous bridge at Iguana Creek which crumbled from its moorings and now sits at the bottom of the Belize Old River. The fiasco that was the Iguana Creek bridge should forever stand out as a bitter testimony of the wasteful spending of our scarce tax dollars.

#### **US Court Sentence Seawell To** Serve Seventeen Years In Jail

#### **COLUMBUS, Ohio (AP):**

A man convicted in a scheme to ship cocaine to the United States in the shoes of young people recruited as couriers was sentenced Friday to 17 years in federal prison.

**Duane Seawell**, 34, a native of Belize, was sentenced by U.S. District Judge James Graham after pleading guilty in July to money laundering and two counts of shipping cocaine into the United States.

Seawell will likely be deported after serving his prison term.

"I'm very sorry for my involvement," Seawell told Graham. "I'm very remorseful for what I did."

Prosecutors say Seawell is among three brothers and dozens of others who were part of a multimillion dollar plot that extended from Belize through Mexico to cities across the United States, including Columbus, Dallas and New Orleans.

To date, 70 people have been prosecuted and convicted in the case in courts in the United States and Mexico.

Seawell was arrested in Miami in February during a layover as Jamaican authorities were deporting him to Belize for illegally entering Jamaica. Before



announcing D. Seawell, 34 his decision,

Graham noted the size of the conspiracy, the number of people involved and the lives affected by the drug trafficking.

Prosecutors declined to comment. Seawell's lawyer said she had hoped her client's lack of a criminal record and willingness to be extradited to the United States would have resulted in a slightly lesser sentence.

For "someone of this level of criminal involvement to have no record whatsoever is pretty noteworthy," said attorney Diane Menashe.

She said he had a history of being employed and some college education.

# Ivan Roberts Interviews Geologist Jim Cavanaugh

SAN IGNACIO TOWN, Cayo, Monday, December 3, 2007: CAVANAUGH SPEAKS OUT An Interview with Consultant Geologist Jim Cavanaugh By: Ivan Roberts 604-3258 belcredit@yahoo.com

The presentations sponsored by UBAD at Bishop Sylvester Center in Belize City on November 28<sup>th</sup> were a great help for us Belizeans who would like to know more about what is going on with oil in Belize and how it is going to affect the Belizean people.

Jim Cavanaugh's presentation was an eye opener, but there seems to be quite a difference in what this experienced oil geologist is telling us and what both BNE and the Petroleum Department are claiming. In fact there is a lot of confusion between what Cavanaugh says and what BNE and GOB says he means or doesn't mean.

For instance The Reporter ran an article on December 2<sup>nd</sup> with the heading: "What's this about oil and Quakes? Geological Survey says it does happen!"

In another article in the same issue of the newspaper, Belize Natural Energy (BNE) claims that Jungle Jim (Cavanaugh) "continues to be unscientific and alarmist".

I went on the internet search and typed in *"Oil production subsidence"* and was surprised to find there were 332,000 entries.

I also typed in *"oil production earthquakes"* and found an amazing 1,510,000 entries! Obviously oil production can cause subsidence and/or earthquakes.

From what most of us have heard so far, Cavanaugh is obviously a very sound scientist, in fact he seems to be about the only real scientist speaking out on behalf of Belizeans.

To settle some of the confusion for myself I decided to go to the horse's mouth so to speak.

The following interview with Cavanaugh explains his position while it also opens up even more questions.

**Roberts:** Jim, how do you feel the UBAD presentation turned out? At the presentation there was not enough time for me to ask all the questions I wanted to.

**Cavanaugh:** The presentation was fantastic! Not because of any side winning an argument, but because this type of forum is so valuable in getting information out to the Belizean people. We definitely need more of them especially whenever a contentious issue needs to be aired. These presentations are of value to everyone, the Belizean people, political leaders and power brokers. It is about the only forum where the people can speak out... and speak they did. Roberts: I had a number of questions for Andre Cho. It is a real shame he did not shows up. What do you think his reason was for not showing? Cavanaugh: Naturally you will have to ask Cho that. Personally I was pleased he didn't show because it gave me more time to cover the abuses and problems of oil activities, which he apparently supports or condones. I want to emphatically stress that the purpose of my work is not to create confrontation but to avoid it. My goal is to inform and educate Belizeans in an effort to prevent the dreadful abuses that have occurred in other countries with new oil discoveries. Many of the activities of BNE, and especially their seismic subcontractors, have violated our laws and abused the rights of our landowners. Cho's lack of experience in the oil business has resulted in a number of very wrong interpretations which work against our Belizean people while supporting the improper and illegal activities of foreign oil companies. I did not want to have to waste valuable time in arguing over such nonsense... but will welcome the opportunity to debate these issues at a later forum which is organized just for that purpose.

**Roberts:** Jim, a BNE article in The Reporter says you blame California's earthquakes on oil production. Can you explain how that happens?

Cavanaugh: My Goodness! NO. I can't explain that because it is not true and I didn't say that. I am a professional geologist and certainly understand that the principal cause of earthquakes are volcanic activity, fault movements and moving earth plates. What I said was that oil production can cause subsidence which can cause mini earthquakes when the rock overlying a reservoir settles or adjusts. There is no mystery about this and the phenomena is well known, and is the possible cause of the small shock they felt at Spanish Lookout. This is hardly being alarmist!

**Roberts:** Your presentation showed that reservoirs were hard rocks with pore spaces where the oil was stored, kind of like a rock sponge. One of the recent articles said that "*Oil* generally is found in permeable sediment that are soft and squishy, not in hard rock." Can you explain this disagreement?

**Cavanaugh:** Whoever wrote that simply doesn't know what he is talking about. Most of our oil was formed from 60 to 300 million years ago... sometimes more, and believe me, any soft and squishy sediments that old have long since become hard rock. Reservoirs are formed in porous hard rocks, generally sandstones and limestones, solid rock but never in soft squishy sediments.

**Roberts:** Belizeans have been asking how much oil do we have. The numbers given by BNE seem to change a lot, varying between 3 and now 11 million barrels of oil reserves. If this is all the oil we have our oil industry has a short life. Are we being told the right numbers?

Cavanaugh: NO. There is an old saying in the oil patch, "You don't get high production from a bucket." Wells producing an average of 750 bbls/ day are not pumping from a bucket, but instead from a rather large reservoir. I am not allowed to see the data, but just working from experience and what is known of the thickness and size of the reservoir, we can expect total production of 100-150 million barrels from the Spanish Lookout Field alone. This is a giant field, and I am confident that Never Delay will be of comparable size. When we were first doing petroleum recon in Belize in the 1970s after the Arab embargo, the entire area from the Belize River northward was the highest priority area, thus we can expect more discoveries from other contactors. What this means is that we have the opportunity at hand from oil revenues to give Belizeans the highest standard of living in Central and South America, IF we can prevent the corruption that is already siphoning off our benefits. **Roberts:** Can you explain why such a big difference from 11 million to 100-150 million barrels?.

released are a bit too cautious. Of course I will be long dead before my projections can be proven right or wrong. But there is another reason for undervaluing the reserves which has rather evil implications. That has to do with the 10% GOB ownership of the oil company, BNE. GOB has already started talking about selling these shares which will deprive the Belizean people of revenues. If the reserves are set at the latest published figure, the value of the stock is being set based on 11 million barrels instead of 100-150 million. This means that the stock could be sold to political cronies at less than 10% of their true value. Actually Belizean public must prevent the stock from being sold at all, and instead demand that the revenues be directed straight into benefits for Belizeans.

**Roberts:** At the UBAD forum I asked about flaring problems. Are we wasting a valuable natural resource and losing a lot of money?

Cavanaugh: Yes, of course we are wasting the gas. BNE reports they are producing 3200 bbls of oil per day and flaring 250 cubic feet of gas for each barrel of oil. What this means in dollars and cents is an enormous loss of 800,000 cubic feet of gas a day or about 300 million cubic feet a year, which is about 8,350,000 gallons of liquid petroleum gas (LPG). At the recent price of \$120 for a 100 pound cylinder we are wasting some ten million dollars of gas a year just with the present production of the 5 wells at Spanish Lookout. The Spanish Lookout field, when fully developed, will produce some \$50 million a year in LPG, and it is now being burned off to contaminate our air and countryside. And worse, we are importing LPG at a drain to our already heavily in-debted economy.

**Roberts:** Measuring our oil production seems to be a controversial problem. BNE and GOB claim they are satisfied with the way the oil is measured, but you say this is not satisfactory. Is it not the responsibility of GOB to protect the interest of the Belizean people by insuring absolute accurate measuring and accountability?

Cavanaugh: It appears that GOB and BNE do not want the public to know exactly how much oil is produced. If oil production is measured at each well head, we simply have to add up the total wells to know how much oil should be sold. This is a world wide practice... except for Iraq and Belize. If we sell less than what is measured at the wellheads, some one is either stealing the oil or the loss is contaminating the environment as a leak somewhere. The universally accepted definition of royalty is proportionate payment for the oil produced as measured at the wellhead. Obviously this does not mean after it has changed hands and no one can verify the measuring. When governments or royalty owners are involved in the revenues accurate measuring at the point of production is always mandatory... except in Belize. To claim they don't have to install accurate and verifiable meters is outrageously arrogant and it demands that the landowners have to accept whatever GOB/BNE tells them was produced without any way to verify the numbers. Roberts: There seems to be a problem with the numbers being reported for revenues and royalties. Dr. Canton reported at the UBAD forum that 886,000 barrels of oil were produced in 2006, with the government

receiving \$23.4 million and BNE profits of \$9.7 million. This doesn't add up correctly at all. Can you explain the accounting?

**Cavanaugh:** No. And I don't imagine that any competent accountant can either. It looks like BNE is deducting their capital investment from oil income, but exploration and drilling costs are venture capital investment, not expenses. If a well is dry, the investors lose. If it produces they have a capital gain. Because no one will supply an accounting, the figures are meaningless. It is a bit insulting to think that a legitimate company would expect Belizeans to be that stupid.

**Roberts:** Dr. Canton reported that the first royalty payment was finally paid to Spanish Lookout, after more than two and a half years of production. Is it going to take Belizean landowners that long to get their money...and why?

**Cavanaugh:** Yes, it is really dreadful that it took over two years to make the first royalty payment. The financial system is straight forward: the oil produced is sold to the refinery who promptly pays for the oil received. My experience has been when there is a divided interest, like we have in Belize with the producer (BNE), government (GOB) and landowners receiving a share of the production, the buyer of the oil pays all the interest holders direct to make sure all interests are paid. With an international sale, perhaps that responsibility would fall on the Oil Contractor (BNE). The buyer pays on the 15<sup>th</sup> of the month following the purchase, so BNE and/ or GOB have had the money from oil sales in hand since the first deliveries over two years ago. However, the Department of Petroleum is totally confused about how to distribute the payments, or even how they should be computed, and unless and until this gets straightened out, landowners will not know if what they are paid is correct. The seeds of our infant oil industry have been planted in poor soil. Instead of good water and proper fertilizer, the seeds are struggling with a flood of ignorance and an oversupply of corruption. It will survive but will Belizeans ever see the benefits? That worries me.

**Cavanaugh:** One reason would be caution, although the numbers being

# **Bateman & Requena Remanded For Robbery**

SAN IGNACIO TOWN, Cayo District, Tuesday, December 4, 2007:

Two Cayo boys, **Francis** *"France"* **Requena** and **Simon Bateman Jr.,** were today remanded to the Hattieville Prison after pleading not guilty to robbery.

Police reports that over the past few weeks they have been receiving an alarming increase in reported robberies in the Santa Elena area with the victims on most occasions being male persons walking the streets of often on their way home after a night of drinking on the town.

A break in the chain took place when **Francis** "*France*" **Requena**, 19, Belizean mason of #6 Western Highway, Santa Elena, attempted to

The incident was captured by the store's surveillance system thereby prompting an investigation.

Requena reportedly led police to an area near the Santa Elena approach to the Hawksworth Bridge on the bank of the Macal river where a brown leather wallet, as well as a social card and a voter's identification card, both in the name of Teodulo Ho, were recovered.

A quick check of police records revealed no report lodged by Ho. However when the police found Ho, an employee of the Ministry of Natural Resources, he informed that during the night of Saturday, November 24, he was attacked by two male persons as he was walking on the Western Highway in Santa Elena Town.

The attackers said Ho, made off with his brown leather wallet containing his social security card, his voters' identification card, and his Belize Bank ATM card.

San Ignacio police informed that

apart from the unreported attack on Ho, there were at least three reported similar incidents that took place in Santa Elena Town within a time span of two hours on that same Saturday, November 24, 2007.

The police hereby warn the public to refrain from walking the streets especially after a night of drinking, as staggering movements will alert predators to the presence of a prey to pounce upon.

In most of these case, victims of these attacks have very little if any cash in their possession as they usually spend most, if not all, of their money on drinks to the point where they are unable to even pay a taxi fare for the ride to their homes Apart from suffering bodily injuries in these attacks, a victim could end up dead as predators attempt the take the very little they have

The most cases the prize catch is the victim's cellular telephone which, depending on the brand, will net the robber anywhere between \$50 and \$100 on the streets.
