SANTA ELENA TOWN, Cayo District, Wednesday, May 21, 2008:

Two Santa Elena boys are today in the custody of San Ignacio Police charged with robbing a resident also of Santa Elena Town.

It was shortly after 8:00 p.m., on Saturday, May 17 when San Ignacio police were summoned to the San Ignacio Town Hospital where they encountered **Eneldo** "*Tu Sabes*" **Martinez**, 44, Belizean Laborer of #1911 George Price Avenue, receiving medical treatment for

In a statement to the police, the victim informed that at around 7:00

pm that Saturday evening he left his mother's house on George Price and walked up to the Low Line Bar

located on the right side of George Price Avenue just before turning the curve when driving down the hill to the wooden bridge.

Martinez informed that with \$70 in his pocket, he intended to enter the bar to drink a Belikin beer. He said that he had not even entered the establishment when he was approached by six boys, three of whom he immediately identified as Joel Sierra, whom he knew was recently released from jail. The other he identified as **Ducho Espa**t and third one whom he knows only as **Mr**. Edmund Bennett's step-son whom he knew while working as a carpenter helper with Mr. Edmund **Bennett** right up to the time of Mr. Bennett's death a few years ago.

Martinez alleges that while stepping into the bar, "Joel Sierra asked me to give him a beer; I answered telling Joel that I don't have it, and I can't buy him a beer. When I said that I can't buy him a beer, Joel then punched me on the left side of my face and at the same time Ducho Espat punched me on

A Government's Sacred Responsibility Is The Security Of Its People

It used to be in years gone by when a murder, in any form, was BIG news in Belize.

The news was even BIGGER when it was a shooting death.

Today, we have reached the stage when we expect for one person, or even more than one person, to be killed everyday somewhere in the country.

Today we find ourselves counting the days between the last murder and when a few murder-free days go by we feel like something is just not right.

The senseless killings, especially on the streets of Belize City, has reached a new and dangerous level with last Sunday night's detonation of a grenade in Mayflower Alley.

One dozen persons were injured in the blast one of whom died from the fragmentation of the explosive device.

Someone committed this act of terror. Cost what it may, the number 1 priority of the Belize Police Department **MUST BE** to find that someone and bring that monster to justice.

After that individual has been convicted by a jury, that monster MUST BE EXECUTED without delay.

Belize is an independent nation. The government is charged with the sacred responsibility of protecting its citizens. Let no one tell us that we cannot execute this convicted terrorist.

These acts of terrorism start with the launching of a grenade and escalate into bigger things.

In the United States of America it escalated to the point where a lone

ranger bombed a government building. Timothy McVeigh was convicted for the April 19, 1995 bombing of the Alfred P. Murrah federal building in Oklahoma City. Where Timothy McVeigh today? Ninety minutes after the incident he was arrested on a lesser charge and two days later he was arrested for the bombing. He was convicted later and subsequently EXECUTED.

The United States of

America bombed an entire nation, killing hundreds of thousands of people, in retaliation for the September 11, 2001 terrorist attack on the Twin Towers of the World Trade Center in New York City.

This terrorist in Belize must be found, arrested, convicted and executed.

The execution must be done in such a manner that every detail can be captured by way of video recording maybe not for public viewing. At the very least however the tape must be shown every single day to every inmate behind prison walls. As our

SAN IGNACIO TOWN, Cavo District, Friday, May 23, 2008:

Reliable reports reaching us indicate that San Ignacio police intends to throw the books at one of their own in connection with a road traffic accident that occurred on Sunday, May 18, between miles 69 and 70 on the Western Highway leading to Benque Viejo Town.

San Ignacio police reports that acting upon information received they arrived on the scene of the traffic accident shortly after 5:30 p.m. on Sunday May 18, where they found two extensively damaged cars on the left side of the highway when traveling from San Ignacio towards Benque Viejo Town. One of the cars was a red Geo Prism with taxi license plates D-4132 and the other was a red Toyota Corolla with private Cayo license plates CY-C-26700.

In a statement to the police Marribel Gonzalez, 23, University of Belize student, informed that she was driving the Toyota Corolla from the direction of San Ignacio toward Benque Viejo Town when upon reaching the area, she saw the Geo

students assemble for the daily singing of the national anthem of Belize, so too should every prisoner assemble for the viewing of the execution of the Mayflower Street Terrorist.

Prism heading in the opposite direction but on her side of the highway. She informed that in an effort to avoid a collision she switched over to the other side of the highway with the Geo Prism doing likewise. Gonzalez informed that whilst in the process of returning to the proper side of the highway the head on collision occurred.

Police investigation revealed that the Geo Prism was neither licensed nor insured. The driver was identified as Police Constable, Silvio **Flores,** stationed at the Intermediary Southern Formation (ISF) in Independence Village, Stann Creek District. Flores, a resident of the Hillview community in Santa Elena Town, was not on the scene of the accident when the police arrived.

All seven occupants of the Toyota Corolla received various degrees of injuries and were treated at the San Ignacio Hospital.

Traveling inside the Geo Prism along with PC Silvio Flores were his 9 and 11 year old sons as well as fellow Constable Baston Peters a resident of Teakettle Village all of whom were launcher should be treated? Frankly, NO! Does a grenade, detonated by a 16 year old person cause any less devastation than the one activated by a 61 year old person? Hell NO!!

The questions on many of our minds are likely to be: a) What kind of beef could a 16 year boy have to unleash such destruction? and b) How could a 16 year old get his hands on a grenade?

His parents, and maybe even grandparents, might have never as much as seen a real grenade much less laid their hands on one. Furthermore, activating a grenade in the middle of gathering is unimanigable to the ordinary person.

San Ignacio police informed that Flores could face as much as 16 charges in connection with the accident. The possible charges, according to the police, could include, 7 counts of negligent harm, 2 counts of negligent grievous harm, 2 counts of negligent wounding, 1 count each for driving motor vehicle not covered by third party risk insurance, driving an unlicensed motor vehicle, driving without due care and attention, failure to report a traffic accident and making a false statement to the police since it is alleged that Flores is denying being the driver of the Geo Prism at the time of the accident.

How Will This Policeman Compensate This Family?

Dear Editor;

On Sunday, 18th May 2008 sometime after 5:00 pm, a traffic accident occurred on the Western Highway on the hill before reaching Kaana Resort.

Upon my arrival all the victims from both vehicles were already taken to the hospital for treatment and the police were there taking measurements of the scene of the

As I gathered among the crowd, I was told that the car coming from Benque was driven by a police officer and the other vehicle was a family car belonging to the Gonzalez family, a family with which I am acquainted, from Benque Viejo Town.

From my observations of the scene, I concluded that the Gonzalez car was coming from San Ignacio travelling towards Benque Viejo Town when it had to exit its lane as the other car was apparently driving as if it was in London, UK but upon realizing that it was traveling in the wrong lane, the driver was in the process of switching back into its proper lane. Then there was a **BANG** resulting in a head on collision.

My checks revealed that the license and insurance attached to the car coming from Benque Viejo Town were not valid as they had expired since 2007. There were also beer bottles (Belikin and a Cuama) inside the car which was photographed. I am hoping that these items could be properly stored to be used as evidence in the case. I hope that these items do not end up being intentionally lost by fraternity cover!!!

I travelled to the San Ignacio Hospital whereby the female that was inside the car driven by the police was being transported by ambulance to Belize City in a serious condition. A policeman whom I know as Peters was being hospitalized where he verbally claimed he was not the driver but had hired the car to go to champon. The other driver was not at the hospital?? As for the Gonzalez family, only the mother was seriously injured with a fractured hip and injuries to the head which the doctor told her was nothing serious. She was nevertheless later taken to Belize city for surgery on her hip. The other (6) victims had abrasions, minor cuts and were complaining of pain as a result of the impact.

The young female driver was able to talk. She confirmed how the accident occurred. While, with seven persons on board her vehicle she was indeed overloaded hence the reason why she was driving a mere 40-45 mph before the accident and had even decreased the speed upon seeing the oncoming vehicle.

The other vehicle suffered much of the impact due to its speed. I also found out at the San Ignacio Hospital that a samaritan, acquaintances to the Gonzalez family, reportedly took the driver and his 2 sons to the Loma Luz hospital for treatment. However, over 3 hours had elapsed for the same policemen who were at the scene, to arrive at the hospital and issue medico forms. Members of the Gonzalez were requesting for specimen to be taken from the driver of the other vehicle in order to make a determination if drunk driving could have been the cause of the accident. The police are aware that it is an offence for a person to refuse to provide specimen samples...but the perception is that the police were really taking their time and dragging their feet.....

Nevertheless, my checks revealed that up until Monday no one has been arrested yet. Despite the fact that the police are in possession of a statement identifying the driver of the other vehicle who happens to be a policeman (aka as Blinds.) This individual and his two sons were taken to the Loma Luz Hospital along for medical treatment.

This accident has caused a humble family to incur unnecessary expenses such as hiring the service of an ambulance from Spanish Lookout.

The mother was unable to get

immediate treatment at the KHMH because of the senseless incident with the grenade and therefore it was difficult for her to receive medical attention and she had to be taken to Medical Associates Hospital for immediate surgery.

While this accident could have been fatal, the investigation into a straight forward case like this one is starting to drag its feet at the initial stage but the problem is, if the driver is found guilty, the family will have to seek compensation by way of a civil suit. But the reality is that this individual did not have insurance nor license on the vehicle? The question therefore is: How will this polieman compensate this family?

In the interim, the family is punishing under the strain of unnecessary medical expenses, combined with the children who cannot attend school and interruption of other family plans due to this uncalled for accident by those who know and should have abided by the law

I am writing this letter to the editor in an effort to bring this matter to the attention of the Police Officer commanding the Cayo District. This officer needs to take action and in so doing send a message to all his subordinates... Justice delayed is justice denied... those that have sworn to maintain law and order must do so and if they are wrong they are not exempted either.

I wonder if it was the other way around, would action have already been taken? We will wait and see and will continue to observe their professionalism and advocate for justice...

Ninga Man Shot In Santa Elena

SANTA ELENA TOWN, Cayo District, Thursday, May 22, 2008:

San Ignacio Police reports that at approximately 12:55 a.m., on Thursday, May 22, they arrived on the scene of a shooting incident in Santa Elena Town where they found a man with two gunshot injuries.

Acting upon information received, the police visited a house on Maxi Street, Santa Elena where they came upon **Elroy "Ninga Man" Flowers**, 27, Belizean Mechanic, originally from Belize City, with a gunshot wound to the right side of the chest and another to the upper portion of the left arm.

In a brief statement to the police, Flowers informed that at around 12:40 a.m., he was awakened by the breaking of glass from the front window of the small bungalow house where he was staying.

Flowers alleges that he got up from the bed near the window to check on the noise when he saw three persons standing on the outside of the house one of whom he clearly recognized as **Joel Sierra**.

Flowers informed that one of the men fired three shots at him with two of the bullets causing the injuries.

The injured man was rushed to the San Ignacio Town Hospital and later

Human Right Advocate Claims Police Brutality In Dangriga

DANGRIGA TOWN, Stann Creek District, Wednesday, May 21, 2008:

On Friday May 16, Dangriga resident **Rhold Henry** had a dispute at the Riverside area in Dangriga with off duty **Police Constable Keith Cruz.** During the dispute, other police came to the scene and P.C. Cruz stabbed Henry in his left thigh with Henry's own knife.

According to Henry, he was bleeding profusely from the injury and was left to sit for 20 minutes before the police took him to the Southern Regional Hospital to receive medical treatment. By that time, when he was admitted to hospital, he was in shock and loosing consciousness.

While this may seem bad enough what happened next is beyond belief even for those who have witnessed rampant police misconduct.

While Henry was under police guard sleeping in his hospital bed, three police officers, including P.C. Cruz, Sgt. Reyes and an unnamed police constable, approached him. The unnamed officer handcuffed Henry's right hand to the bed, told Henry he was under arrest, and as Henry turned his head he saw P.C. Cruz striking him with a shotgun.

In an effort to protect himself, Henry raised his left arm that was attached to an intravenous device. The police pulled the IV out of Henry's arm. Henry covered his head and face as best he could with his arm as P.C.

Cruz beat him in the hospital bed. Henry's left arm and shoulder sustained the majority of blows.

Henry began to scream and a nurse came to the door to find it closed. The police officer who had been on duty was guarding the door while the beating was taking place.

The nurse observed that the IV was out of Henry's arm and that blood was covering the bed. When the nurse arrived, the police left and Henry was treated for the new set of injuries.

When Henry was released from hospital on Tuesday, he was charged for a variety of offences, including aggravated assault, insulting words and threat of death to Keith Cruz.

A complaint against P.C. Cruz and Sgt. Reyes has been lodged with the Police Department's Internal Affairs and Discipline Unit in Belmopan.

We are yet to be notified of the commencement of an investigation into this matter.

Attorney Antoinette Moore who is representing Henry, said, "In the many years I have monitored and fought against police brutality in Belize, this is one of the most outrageous cases I have encountered. For the police to enter a hospital ward handcuff an immobilized patient and beat him in his hospital bed shows how bold and lawless some of our law enforcement officers have become.

The authorities must realize that they cannot separate the fight against the scourge of violent crime in the streets from the cancer of violence and abuse that exists within the police."

Ed. Note: In sharing this information with Commissioner of Police Gerald Westby, he informed that he is just back in the country. but is nevertheless aware that an investigation is underway by the IAD, Dangriga.

Lawyers for Sagis Investments/Belize Bank/Michael Ashcroft have taken the extraordinary step of publishing this morning a whole page advertisement in the UDP newspaper, GUARDIAN, discussing a Supreme Court matter which is awaiting the judgement of the Chief Justice, Dr. Abdulai Conteh. We must respond

This is an attempt to lobby Belizean public support for Sagis/Belize Bank/Ashcroft, and to smear the reputation of KREM Ltd.

The evidence in Supreme Court shows that the loan package prepared for KREM on June of 1994 involved the attorney Dickie Bradley, in the first instance, and following that, the attorney and then PUP Deputy Leader, Said Musa, who ended up acting as the attorney for KREM, even though it was Bradley who had been the KREM attorney.

Amandala business manager, Jacinta Hyde Garnett, confirmed a long time before the Sagis litigation of March 28, 2007, that Amandala had paid off the Belize Bank \$75,000 commitment with newspaper advertisements over a period of years. Sagis does not want to talk about that, because, whereas their people were behaving one way from 1994 onwards, they began behaving in a disrespectful and bullying manner in 2007.

According to the Sagis statement in the GUARDIAN this morning, "Michael Ashcroft no longer has an interest in Sagis ..." So who is it that does, have an interest in the mysterious Sagis, that is? Since he "no longer" has "an interest," when did Lord Ashcroft have it and for how long did he have it?

After 1994, it did not matter to Sagis and Ashcroft about the 10% KREM shares. Lord Ashcroft was seeking a change of government from UDP to PUP, which took place in 1998. That change benefited his businesses greatly. KREM was considered PUP in 1994, and was pro-PUP in both the 1998 and 2003 general elections. KREM Radio and the PUP began entering a relationship of antagonism in April of 2004.

KREM Radio was a business subsidized by Amandala Press from 1989 to 1998.

During his Supreme Court testimony on Monday afternoon, May 12, 2008, it was obvious that KREM director, Charles B. Hyde, who is 84 years old, had trouble hearing the lead attorney for Sagis, Vincent Nelson, Q.C., whose voice is a soft one. It also became clear that Mr. Hyde, general manager of KREM Radio in 1994, had independent authority at KREM, and sometimes opinions which were different from those of Evan X Hyde and Rufus X.

KREM Radio paid back the \$75,000 loan with advertisements in Amandala newspaper. Because the process was taking place at the time between reasonably friendly entities – Amandala and Belize Bank, it was not properly documented. Thus, in March of 2007, Sagis suddenly began claiming more than \$262,000, in principal and interest, for a 1994 loan which had been repaid.

Sagis/Belize Bank/Ashcroft neglected to complete the 10% KREM shares transaction, because it was too insignificant at the time. That was not KREM's fault. It became important for Market Square to complete the transaction in 2007 because KREM was criticizing Ashcroft, and the Lord wanted to discipline the radio station.

In 1994, nobody from the KREM board wanted to sell shares to Sagis, Ashcroft, or whomsoever. Between the attorney for KREM, Said Musa, and the Sagis/Belize Bank/Ashcroft people, they agreed/demanded that Evan X Hyde should sell 10% of KREM – his shares, to Sagis as a condition for the loan. This amounted to blackmail, to which KREM yielded. This was Shylock's "pound of flesh." As fate would have it, the transaction was never completed. Thanks to that.





Soldier Dies Under Mysterious Circumstances

SAN IGNACIO TOWN, Cavo District, Wednesday, May 21, 2008:

A post mortem examination conducted today on the body of BDF **Lance Corporal Warren Jeffrey** Cho, a resident of Maya Mopan Village in Southern Stann Creek District revealed the cause of death as "Acute Pulmonary Odema due to paradigm bleeding of the right lung due to abdominal trauma and laceration."

In layman's terms Cho sustained a blow to the abdomen damaging his right lung causing it to bleed with the internal bleeding suffocating him.

Although the circumstances surrounding Corporal Cho's death remain mysterious, San Ignacio Police are basically treating it as an accident primarily resulting from disorientation caused by the excessive consumption of alcoholic beverages.

Reports reaching us indicate that L/Corporal Warren Jeffery Cho, accompanied by a female soldier, both stationed at Belizario Camp, Central Farm, Cayo, were out on the town last Thursday night having fun.

It was sometime between 8 and 9:00 pm when they entered the Pit Pan Bar, inside the Manzanero Complex, and began drinking beers for which Cho was paying.

They remained in the bar right up to around midnight when the consumption of alcohol began to produce effects on the behavior of the soldier.

Although not disturbing other customers, he began jumping around in the establishment.

At one point the female companion became concerned about his behavior and despite his request for more beers, she was discretely telling the bartender and barmaids not to sell him any more beer.

The female suggested that he go to the police station and take a rest in the care of the policemen but Cho remained adamant that he wanted to have more beers.

It was when he made an attempt to urinate on a pile of sand in front of the bar that the two Security Guards became concerned and asked him to conduct himself.

Becoming more concerned about his behavior, the female companion requested a taxi for the ride back to Belizario Camp while the security guards were trying to get him into the taxi. They placed a cuff on his left wrist, Cho broke away and ran up the street towards Burns Avenue just as the female was paying for the taxi ride back to camp.

That was the last they saw Lance Corporal Cho alive. The female reentered the Pit Pan Bar and departed with the DJ at closing time around 3:00 a.m.

It was shortly after 2:00 am when the attention of the police was drawn to a loud groaning on the San Ignacio Bank of the Macal River directly under the Hawksworth Bridge.

When police visited the area they found a male person of Mayan decent unable to speak and groaning loudly. He was wearing a gray sleeveless T-shirt and a khaki 3/4 pants with a handcuff on his left wrist.

The person's body, except for the head, was in the river. The police returned to the station for a stretcher which was used to transport the person to the San Ignacio Hospital where he later passed away.

Police suspect that he might have been staggering on the road under the bridge and might have lost his footing thereby falling down the bank and on to the edge of the river where he was found.

At round 5:30 am that Friday morning the police noticed a male person of Hispanic decent seeking a ride at the foot of the Hawksworth Bridge, upon being questioned, the person informed that he is BDF soldier Bolon stationed at Belizario Camp. He accompanied the police to the San Ignacio Hospital where he identified the other person as Lance Corporal Cho also attached to Camp Belizario.

The police reported the incident to officials at Camp Belizario who promptly visited the San Ignacio Police Station. They were briefed on the matter and the case was handed over to the army.

Other Conditions of the Scholarship Award

Each Scholarship recipient will be required to return to Belize whenever he/she successfully completes his/her course of study and to serve the Government of Belize (or with the permission of the Government of Belize, serve in the private sector in his profession or calling) for a period of four years commencing from the date of employment in Belize. Applicants will be required to sign a Bond Agreement with the Government of Belize in this respect.

The scholarship is normally for the duration of the program of studies and requires that the scholarship holder maintains passing grades at the University where he/she is enrolled.

Application Forms can be obtained from the District Education Centers or at the Ministry of Education in Belmopan.

All completed Forms must reach the Ministry of Education in Belmopan no later than Friday, June 6, 2008.

I placed my hands in my pocket and I found out that my \$70.00 in cash was missing. I believe that when I fell to the ground that was the time these boys took my money."

Residents in the area of the Low Line Bar informed that Eneldo Martinez' experience is nothing strange.

Such incidents are regular occurrences in the neighborhood, as several residents of the area find themselves frequently coming to the rescue of persons who are routinely attacked by a group of boys who lurk in the shadows ready to pounce upon, rob and injure vulnerable persons in the area.
