

# **Georgeville Beauty Pagent Ends In Tragedy**

#### SAN IGNACIO TOWN, Cayo District, Thursday, September 18, 2008:

The festive mood in the western village of Georgeville ended in tragedy last Saturday morning as one villager lost his life and another was charged with murder.

The deceased was identified as Orlando "Chippy" Myers, 24 while the accused was identified as Ealsine Gentle, 28, both Belizean laborers from Georgeville Village.

Reports reaching us indicate that residents from the village and neighboring communities came out to the community center last Friday night, September 12 to witness the selection of Miss Georgeville Independence 2008-09.

Organizers of the event informed that

all was going well until just about the time when the function was drawing to a close. An altercation reportedly erupted between a group of villagers in attendance.

Police investigations revealed that one of the male persons, a relative of the deceased, emerged from the initial squabble with an injury to the forehead. He departed the location and was reportedly walking towards his home along with the deceased when they were followed and confronted on the nearby basketball court by the same person who had caused the original injury, the accused Ealsine Gentle.

In an attempt to defend his relative, the deceased reportedly positioned himself between the two men when it is alleged that the accused pulled out a large knife and inflicted two stab wounds to the left side of the victim's abdomen.

The victim fell on the basketball

court and the accused disappeared into the darkness. The injured man was rushed to the San Ignacio Town Hospital.

Police report that at around 2:30 that Saturday morning, September 13, they arrived at the hospital where they encountered the victim, in an unconscious state, undergoing emergency medical treatment for "*a cut wound under the left armpit*". The victim passed away shortly thereafter.

About seven hours later the accused was in police custody. It was around 10:00 a.m., that Saturday morning when he entered the San Ignacio Police Station accompanied by his mother who lives in Teakettle Village. He was instantly detained and later formally arrested and charged for the murder. He was subsequently remanded to the Central Prison in Hattieville.

The accused is no stranger to the law as at the time of his arrest, he was out on bail on a theft charge.

**Orlando "Chippy" Myers** is survived by his mother **Dorla Myers**, father **Ralph Williams, several** brothers and sisters and a host of other relatives and friends. He was laid to rest in the village of Georgeville on Tuesday, September 16, following 2:00 p.m., funeral services.

## **Restoring Law And Order In A Lawless Society**

The documentary on the gang/ cocaine situation in Belize City produced by award winning UK Journalist, **Ross Kemp**, sparked much discussion over the past several days.

While we will agree that the publication is bad for Belize's image abroad and that it can produce some negative effects on Belize's tourism industry, Kemp's effort was an eye opener for many of us.

The documentary revealed precisely what the authorities have been hiding from us all these years.

In terms of the frequent shooting deaths in the streets of Belize City, all they tell us is "another young man has been shot dead" and as to the motive behind each killing the usual official line is "as a result of an old beef".

Just as Kemp's documentary was being aired, another young man was shot in the streets of the city and while, in an interview, the victim's sister revealed the name of the shooter as identified by the victim, none other than the head of the Crimes Investigation Branch chose to withhold the name of the shooter from the same reporter.

There are those who are of the opinion that although Kemp's revelation might be true, it must be condemned because "we must protect the image of Belize". This is tantamount to living in denial. It is an established fact that recovery begins first by admitting the existence of a problem then every effort **MUST** be expended to eliminate that problem. As we continue to live in denial, the situation is only getting worse. We now find ourselves venturing into the stage where the lawless are graduating into using weapons of mass destruction, like grenades, to settle "*old beefs*" while threatening the safety of a larger number of innocent individuals.

Four months ago, in May of this year, a boy was arrested and charged for setting off a grenade in a Belize City neighborhood. One person was instantly killed and a dozen others were injured in the blast.

It looks like the authorities are content with this arrest as there appears to have been no further effort to trace the origin of this weapon of mass destruction. Could it be that the trail has stopped at the doorsteps of one of the untouchables among us? Why is it that, on a matter of such serious national security concern, someone in a more senior capacity is not asking for a *FULL* report subsequent to this boy's arrest?

While we appear not to have moved any further beyond the arrest of the boy charged with setting off the May grenade on Mayflower Street, a second one was launched four months later in the midst of a much larger gathering. We must be thankful that this second, more destructive, grenade did not explode.

Kemp's documentary revealed, *"from the horse's mouth"*, that there is a Belizean in our midst



who was prepared to "*jack*" an entire shipment of cocaine. We must again be thankful that the attempt failed as the havoc that the introduction of such large amount of cocaine would have inflicted on the Belizean society would have been tremendous.

It's high time for us to pull our heads out of the sand. There is a deep rooted problem in Belize. The problem is guns and drugs. Unless we seriously tackle these problems, as sure as day follows night, many more of us will hold our heads and cry as another relative is shot down and killed in the streets and even in our homes.

There is much that we could learn from our neighbors immediately north of the border. A few months ago, three Belizeans were arrested and charged for merely attempting to introduce guns into Chetumal. Today despite much outcry coupled with the local societal status of one of the detainees, they remain locked up in Mexican jail. They did not shoot anyone. They did not kill anyone. The charge against them is entering the national territory of Mexico with guns.

Many are those in Belize who are today walking free from murder charges.

Countless are those in Belize who are walking free from charges of causing injuries to others with guns.

It somehow appears that the fear of increasing the prison population, with corresponding increase in prison maintenance costs, is thwarting the effort to get tough on crime.

In the short term, prison population will certainly increase but as the reality of the situation begins to sink into the minds of those with criminal intent, the numbers are bound to gradually taper off as law and order is restored within a lawless society.

# Fire Destroys The Childhood Home Of Santa Elena Businessman

SANTA ELENA TOWN, Cayo, Thursday, September 11, 2008:

It was one of the first buildings erected on Salazar Street in Santa Elena Town, Cayo and today the childhood home of Santa Elena businessman, **Michael "Max" Salazar Jr.** was destroyed by fire.

An official from the local fire service reported receiving the first call at around 6:30 on the morning of Thursday, September 11 and by the time they arrived on the scene, the two storey building was engulfed in flames.

Despite the presence of two fire tenders, the inadequacy of the fire fighting equipment was obvious as it took well over an hour to bring the blaze under control. Fortunately, there was no other structure in close







proximity of the blazing building.

A member of the Perez family, occupying the building at the time of the incident informed that the fire started inside a back room, quite possibly from an electrical problem produced by a overheated fan. **Mrs. Vanessa Perez** who was at home with her 10 and 12 year old sons told investigators that it was shortly after 6:00 o'clock that morning when she was awakened by her 10 year old son who told her that his room was on fire. They rushed outside the building managing to save only a few items of clothing.

Owner of the building, Michael Salazar and the Perez family estimate the combined value of the loss at around one hundred and seven thousand dollars. Neither the building nor any of its contents was insured.

No one was injured in the blaze.



# Accused CP Burglar On Bail One Item of Jewelry Recovered

SANTA ELENA, Cayo, Thursday, September 4, 2008:

After spending a week in jail accused burglar **Jose de la Fuente** was today released on \$10,000 bail and ordered to return to court on Tuesday, September 23, 2008.

De la Fuente stands accused of the August 25, 2008 burglary of CP Gas Station located at the corner of Carillo Puerto Avenue and the Western Highway in Santa Elena, Cayo.

Police reports that on the day in question **Norberto Rancharan**, Belizean businessman and manager of the gas station reported that sometime between 10:30 p.m. the previous day and 6:15 a.m. the following day his gas station was burglarized.

Rancharan reported that a fire proof combination safe containing an assortment of personal documents and jewelry, with an estimated valued of \$30,000, was missing.

In order to claim the prize, "winners" are instructed to first make a cash deposit into a Guatemalan bank to begin the process of obtaining their prize.

Several unsuspecting persons have reportedly fallen victims to this scam and are reported to have deposited a few hundred dollars as instructed after which communication is severed by the prize agent and it is only then that they realize the they have been tricked.

Latest information reaching us indicate that a 14 carat gold bracelet with diamond stones valued at \$3,000 was subsequently found in the possession of **Maria Vitzi**l a resident of Benque Viejo Town. The bracelet was positively identified by Rancharan as being his property.

Maria Vitzil, 43, Guatemalan lottery vender of a Kennedy Street address

in Benque Viejo Town was consequently arrested and charged for the crime of handling stolen goods. The matter has since been transferred for hearing in Benque Viejo's Magistrate Court. When she first appeared in court on September 9, Vitzil pled no guilty to the charge.

As the investigation continues, San Ignacio police advises the public in general and pawn brokers in particular to be on the lookout for any suspicious items of jewelry that might come their way and to report any such incidents without delay.

It is therefore safe to conclude that Brother Victor August has dedicated his entire life to his family, his church and indeed the people of Belize.


He excelled in the church. He excelled in politics as is evident by the fact that he served two terms as the Mayor of his beloved twin towns of San Ignacio and Santa Elena.



## Why Kenyan Women Crave Stones

**Nancy Akoth** is four months pregnant and like many women in her state has strange cravings.

Some women eat coal, gherkins or soap but Mrs Akoth craves soft stones, known in Kenya, where she lives, as "*odowa*".

"I just have this urge to eat these stones. I do very crazy things, I would even wake up at night and go looking for them," she told the BBC.

"I consulted my doctor and all he told me is that maybe I'm lacking iron and gave me medication on iron, but I still have the urge to eat those stones."

Luckily for Mrs Akoth, she is not alone in craving stones and they are easily found on sale in Nairobi's sprawling Gikomba market.

Among the fish-mongers and dealers in second-hand goods who flock to the market are traders who specialise in odowa.

Stone-seller **Stephen Ndirangu** unsurprisingly says women are his main customers.

"Most of them buy the stones to go and sell them to women who are pregnant," Mr Ndirangu says. He says he sells one 90kg sack for about \$6.

Although they are stones, they are too soft to break the teeth of Mrs Akoth and her fellow cravers.

Nutritionist **Alice Ndong** says the stones have a bland taste.

"It's a pleasant taste. It doesn't have a tangy flavour or a salty or a sugary flavour. It's a bit like eating flour," she told the BBC.

She says that because of their abrasive nature, the stones actually clean the teeth as the stone is chewed and the finer particles pass through the mouth.

However, she warns this should not be used as an excuse to eat the stones as the habit can also have harmful consequences.

"If somebody eats those stones and they don't take enough water, then they will actually get severe constipation... It can actually be very dangerous," she says. the Pumwani Maternity Hospital in Nairobi.

At least 800 of those interviewed said they ate soil, stones and other non-food items during their pregnancy.

But it is not only those who are pregnant who indulge in this habit.

**Sylvia Moi** still finds the soft stones irresistible, 14 years after she gave birth.

"I cannot do without it... Walking without it makes me feel bad, as if I'm lacking something [or] I'm hungry," Mrs Moi says.

She says she would like to quit the habit but just cannot stop herself.

"When you eat it you look awkward, people think: 'What is it that you lack in you that makes you eat that awkward stone," she says.

Experts say that the craving to eat odowa is largely due to a deficiency of vital minerals, like calcium, in the body.

"Unfortunately, these stones

don't offer a lot of calcium. They offer some other forms of minerals like magnesium but not much calcium," says Mrs Ndong.

Research shows that these habits have negative side-effects on the women's health, ranging from parasitic infestations, anaemia and intestinal complications

"The problem with these stones is sometimes they're not hygienic. I remember up-country I've seen people just go somewhere, dig up and maybe people urinate in that spot," she says.

Experts warn pregnant women and others who enjoy eating odowa to try to ignore these cravings for the sake of their health.

The researchers say that the women are better off eating a balanced diet, than remaining hooked to the myth that their changing bodies need soft stones and soil.





"It can actually cause things like kidney damage and liver damage, if you don't take enough fluid because it will form a mass that cannot be excreted."

"When you eat these stones, it's like eating metal. The particles because it's not food - are not digested as finely as fruits or vegetables," she says.

The phenomenon of craving non-food items like soil or soft stones is referred to as pica, a Latin word for magpie, the bird notorious for eating almost anything.

Researchers from the University of Nigeria interviewed 1,071 pregnant women attending a prenatal clinic at

### PUBLIC NOTICE

#### Public Utilities Commission (PUC)

Pursuant to Decision 6(b) of the Final Decision issued by the PUC on June 26, 2008, in relation to the 2008 Annual Review Proceeding (ARP) for the Belize Electricity Limited (BEL), the PUC hereby notifies the general public that a new Rate Setting Methodology (RSM) has been implemented effective September 1, 2008.

The new RSM is intended to provide for more timely collection of the costs paid by BEL for wholesale power and to encourage more efficient consumption of electricity by consumers.

The entire RSM will be posted on the PUC's website and made public in due course. Following are the general principles and a summary of the methodology of the new RSM:

#### General Principles of new RSM:

- a) The new RSM contains amendments for sections dealing solely with the cost of power component of the approved Mean Electricity Rate (MER). There are no amendments for the Value Added of Delivery (VAD), Rate Stabilization Account (RSA) Recovery and Corrections components of the MER, and these will remain fixed over the course of the current Annual Tariff Period (ATP), which runs from July 1, 2008, to June 30, 2009.
- b) The Social Rate tariffs approved in Decision 10 of the Final Decision will remain fixed over the ATP.
- c) The new RSM will seek to allow BEL to recover the full cost of power over the ATP, save for any excess costs that may occur in the final month of the ATP, which naturally has to be recovered in the subsequent ATP.
- d) The forecasts for electricity sales and cost of power that were employed during the 2008 ARP to set the MER are those that will apply during the current period of the ATP, being July 1, 2008, to December 31, 2008.

#### Summary of Methodology:

- a) BEL will provide the PUC with Forecast Sale of Power (FSP) and Forecast Cost of Power (FCP) over the ATP, to be updated/revised over the period as required by the PUC.
- b) Based on approved demand and supply forecasts, the PUC will set the Reference Price of Power (RPP the cost of power component of the MER) on two occasions over an ATP, which should allow BEL to recover the full cost of power over the period. The RPP for the period July 1, 2008, to December 31, 2008, is \$0.312/KWh as set in the Final Decision. In December, a new RPP will be set by the PUC, which is to be applied over the period January 1, 2009, to June 30, 2009.
- c) Based on the Reference Price of Power, the Forecast Sale of Power and the Forecast Cost of Power, the PUC shall determine on a monthly basis, the expected variance in the costs BEL incurs for its supply and the amount collected from consumers for delivering such supply (Forecast Cost of Power Variance FCPV).
- d) The monthly Forecast Cost of Power Variance will be credited or debited to a Forecast Cost of Power Variance Account (FCPVA), as the case may be. Any positive balance in the FCPVA will indicate expected amounts owing to BEL while any negative balance will indicate expected amounts owing to consumers.
- e) On or about the tenth day of each month in the ATP, starting with the second month, BEL will provide the PUC with actual figures for Actual Sale of Power (ASP) and Actual Cost of Power (ACP) for the previous month.
- f) Based on the Reference Price of Power, the Actual Sale of Power and the Actual Cost of Power, the PUC will determine on a monthly basis, the actual variance in the costs BEL incurs for its supply and the amount collected from consumers for delivering such supply (Actual Cost of Power Variance ACPV).
- g) The monthly Actual Cost of Power Variance will be credited or debited to an Actual Cost of Power Variance Account (ACPVA), as the case may be. Any positive balance in the ACPVA will indicate amounts owing to BEL while any negative balance will indicate amounts owing to consumers.
- h) On a monthly basis, the PUC will compare the forecast balance in the Forecast Cost of Power Variance Account with the actual balance in the Actual Cost of Power Variance Account, and determine if there is any need to apply a recovery rate (Cost of Power Recovery CPR) to consumers' bills, based on the following criteria:
  - i) Where the actual balance is fairly equal to the forecast balance, there will be no need to apply any Cost of Power Recovery, subject to vi) below. (Please Turn To Page 17)

- ii) Where the actual balance is lower than the forecast balance, it will be the discretion of the PUC whether to apply a Cost of Power Recovery.
- iii) Where the actual balance exceeds the forecast balance by 10% or more, there will be an automatic Cost of Power Recovery applied to consumers' bills to recover the excess above the forecast balance. Where the excess is less than 10%, it shall be the discretion of the PUC whether to apply an immediate Cost of Power Recovery.
- iv) Any excess costs or payments to be addressed by the Cost of Power Recovery will be immediately subtracted from the actual balance, and distributed amongst the various classes of consumers according to the cost allocation formula applied to the Tariff Basket Revenue (TBR) contained in Decision 6(a) of the Final Decision.
- v) The excess costs or payments allocated to each class of consumers will be shared amongst individual consumers based on actual consumption registered during the period of the ATP that applies to the excess costs or payments, and the appropriate amount will be posted directly to the consumer's bill as a credit to the consumer or as a receivable for BEL.
- vi) Where the PUC is satisfied that some imminent event may materially affect the Forecast Cost of Power or the Forecast Sale of Power, it may apply a forward-looking Cost of Power Recovery to mitigate the expected effect of such an event.
- i) On or about the fifteenth day of each month, the PUC will make a determination whether any Cost of Power Recovery will be applied to consumers' bills, and will issue a Public Notice to notify consumers and stakeholders of the total amount to be recovered from or rebated to consumers. The new Reference Price of Power for the period January 1, 2009, to June 30, 2009, will be published on or about December 15, 2008.

The new RSM has been applied in September, 2008, and BEL has provided the Actual Cost of Power and Actual Sale of Power for the months of July and August, 2008. The result of applying the new RSM is presented below in the format that will be employed for future public notices.








Uganda seeking miniskirt ban Uganda's Ethics and Integrity Minister says miniskirts should be banned - because women wearing them distract drivers and cause traffic accidents.

Ethics and Integrity Minister Nsaba Buturo told journalists in Kampala that *wearing a miniskirt was like walking naked in the streets.* 

"What's wrong with a miniskirt? You can cause an accident because some of our people are weak mentally," he said.

The BBC's Joshua Mmali in Kampala, the capital, said journalists found the minister's comments extremely funny.

Wearing a miniskirt should be regarded as *"indecent"*, which would be punishable under Ugandan law, Mr Buturo said.

And he railed against the dangers facing those inadvertently distracted




by short skirts.

"If you find a naked person you begin to concentrate on the make-up of that person and yet you are driving," he said.

"These days you hardly know who is a mother from a daughter, they are all naked."

According to the minister, indecent dressing is just one of many vices





facing Ugandan society.

"Theft and embezzlement of public funds, sub-standard service delivery, greed, infidelity, prostitution, homosexuality [and] sectarianism..." he said.

Earlier this year, Kampala's Makerere University decided to impose a dress code for women at the institution, our reporter says.

The miniskirt and tight trousers ban has yet to be implemented, but

our correspondent sought the opinions of women on campus about the minister's opinions.

"If one wants to wear a miniskirt, it's ok. If another wants to put on a long skirt, then that's ok," one woman said.

But others had more sympathy with Mr Buturo.

"I think skimpy things are not good. We are keeping the dignity of Africa as ladies and we have to cover ourselves up," one woman, called Sharon, told the BBC.
