

VELASQUEZ AND VASQUEZ SENTENCED FO SPEND THE NEXT 6 1/2 YEARS IN JAIL

SAN IGNACIO TOWN, Cayo, Monday, January 26, 2009:

The crime occurred over three years ago. Initial investigation led to the arrest of four Santa Elena men. The trial ended last week with the conviction and sentencing of two of them.

On October 27, 2005, Oscar Chapeau, 63 at the time, reported to San Ignacio Police that he and a Chinese female companion were attacked and robbed whilst at his River Walk Farm located across from Floral Park, at mile 63 on the Western Highway.

In a statement to the police, Chapeau reported that the items stolen included a gold and diamond ring valued at \$10,000., one computer and accessories valued at

He landed in Belize as a tourist on January 5, 2009, but after being in the country for only two weeks he caught up with a foreign team engaged in community construction projects.

Robert "Bob" Davis is an American national from Wisconsin USA. He is on his second trip to Belize. His first visit was over 14 years ago, in 1994.

We met him over the weekend at Pop's Restaurant on West Street in San Ignacio Town and what an interesting story he had to offer. He told us that he spent his first week at a guest house in San

wrist watch valued at \$250., one brown leather wallet valued at \$25., one Belize Driver's Permit valued at \$20., one \$20., telephone card and \$1,500., in cash, all for a total value of \$13,315.

The report also included allegations of the attempt rape of the Chinese woman.

Swift police investigation led to the arrest of Reymundo "Mundo" Vasquez, Nelson Velasquez, Luis Castellanos and Mark Trapp Gentle.

When the case was first heard in San Ignacio's magistrate court it was submitted for trial on indictment in the Supreme Court but as the matter proceeded, it was subsequently reverted to the magistrate court for summary trial.

Nelson Velasquez, 20

defendants pleading not guilty to charges of robbery, wounding and harm, the trial proceeded as scheduled and after hearing arguments from the defense and the prosecution, Magistrate Harrison Hulett, deputizing for Magistrate Kathleen Lewis, found two of the defendants, Reymundo "Mundo" Vasquez and Nelson Velasquez guilty for the crimes of robbery, wounding and harm.

The other defendants Luis **Castellanos** and **Mark Trapp** Gentle were acquitted of all charges. All four accused persons were undefended in court.

Velasquez and Vasquez were consequently sentenced to 5 years for robbery, 1 year for wounding and 6 months for harm. Magistrate Hulett ordered that the sentences are to run consecutively for a total of 6 ¹/₂ years imprisonment.

After several adjournments the case was set for hearing on January 23, 2009. With all four

Belizean Man Found Dead In Melchor, Guatemala

MELCHOR DE MENCOS, Peten, G u a t e m a l a , Monday, January 26, 2009:

Another Belizean is dead in the neighboring Western border community of Melchor De Mencos, Peten, Guatemala.

Our investigation revealed that it was shortly after 9:00 p.m., on Friday, January 24, when Guatemalan firemen and policemen from

the Policia Nacional Civil (PNC) responded to reports of a man on the ground near the Puerta Negra (Black Door) Bar in Melchor.

According to Guatemalan law, under these circumstances, permission must be obtained from a local judge for the removal of a body.

When the required permission was obtained, the body was transported to the nearby hospital where it was pronounced dead and identified as that of Belizean, **Johnny Cal**, 31 from the village of San Jose Succotz.

Belizean authorities at the

Western Border as well as Benque Viejo police were informed of the incident. The mother of the deceased traveled to Melchor where she positively identified the deceased as her son. At around 2:30 p.m., the following day, she crossed the border with her son's body.

We traveled to La Puerta Negra in Melchor where we spoke to the manager of the establishment "*Nelson*" He informed that the deceased is a regular patron of the establishment and that he had visited the bar earlier that Friday evening where he drank a liter of beer and left without incident. He said that, contrary to media reports, the incident did not take place inside the bar and that as a matter of fact, he was the first person to come upon the man on the ground about 25 feet outside the bar.

According to the Manager, he exited the bar, as he normally does when on duty, just to keep track of what his happening on the outside as with the loud music inside, it is often difficult to keep abreast of what is happening outside and so he make regular checks. SUSTAINABLE TOURISM PROGRAM <u>Terms of Reference</u> <u>for</u> <u>Project Director,</u> Project Coordinating Unit (PCU)



DUTY STATION: Belize PROJECT NAME: Sustainable Tourism Program PROJECT NO.: BL-L1003 OPERATION NO.: 2060/OC-BL

I. BACKGROUND

The Belize Sustainable Tourism Program is a response to challenges that must be faced if Belize's tourism sector is to grow in a manner that is economically, environmentally and socially sustainable. The intention is to strengthen the sector's contribution to the national economy by consolidating the overnight tourism market with investments and activities along three interrelated fronts: (i) enhancing the tourism experience and resource sustainability at consolidated destinations subject to pressure; (ii) diversifying tourism products in emerging destinations for the overnight market segment; and (iii) strengthening tourism institutions for policy, destination planning and management. The project is being funded by the Government of Belize and the Inter-American Development Bank (IDB) through a loan of US\$13.322M.

II. OBJECTIVES

The objective of this consultancy is to lead the IDB-funded Sustainable Tourism Program towards the achievement of its objectives and indicators and oversee the execution of the Project and the day-to-day running of the Project's activities.

III. CHARACTERISTICS OF THE POSITION

Starting Date and Duration: The Project Director shall be employed by the program for a four year period, starting on the date of contract signing. The contract shall be renewable on an annual basis based on performance.

Duties: The Project Director will be responsible for the overall management of the Project Coordinating Unit. Specific duties will include: (1) the planning and coordination of all aspects of program implementation; (2) monitoring of results and report preparation; (3) procurement in accordance with the agreed procurement plan; (4) disbursement of program resources; (5) coordination with the Bank and other relevant stakeholders.

Reporting Arrangements: The Project Director will report for contractual purposes to the Director of Tourism of the Belize Tourism Board.

Place of Work: The Project Director will work from an office provided the Belize Tourism Board in Belize City, Belize. Field trips are expected to take place throughout the country for the project duration.

Qualifications: The Project Director shall have a professional degree in Tourism Management, Environmental Science, Engineering, Business Administration, or related disciplines. Post graduate education in areas relevant to Tourism, such as, Sustainable Tourism Management and/or Destination Management is a plus. Previous professional experience in tourism-related projects is mandatory. In addition, he/she shall have at least five years experience in project management. Previous experience with projects from international funding agencies would be an asset. He/she must exhibit leadership qualities, strong interpersonal and communications skills and fluency in English. Fluency in Spanish and competency in computer software would be an asset.

IV. ACTIVITIES

- 1. The Project Director shall oversee all project activities, according to the Results Framework, the project operating regulations, the policy directives from the Government of Belize in accordance with the loan agreement. She/He will review all documentation relating to the project, in particular the Program Operation Manual for the Loan Agreement, and shall undertake work on the project in accordance with the Program Operation Manual, Annual Work Plans and IDB procurement policies.
- 2. The Project Director will manage the implementation of the Program including support for the recruitment, as well as management and supervision of personnel within the Project Coordinating Unit and consultants, in accordance with Bank procedures and after obtaining approval in accordance with the Operational Manual and the Bank. The Project Director will ensure the rational and transparent use of project funds in order to achieve project goals, establishing the necessary controls for its appropriate use, registration, and reporting to the Belize Tourism Board as Executing Agency and to the Inter-American Development Bank.
- 3. The Project Director will produce an Annual Work Plan and Procurement Plan with a detailed budget and schedule of activities based on the Results Framework and obtaining approval in accordance with the Program Operation Manual. The Project Director will be responsible for the monitoring of progress on a regular basis.

He/She will undertake the following:

- Confirm to the appropriate instructions which will be issued by the Executing Agencies.
- Represent the Project in its relationships with the IDB and third parties;
- Prepare or oversee the preparation and presentation of all necessary administrative, technical and financial submissions for the Bank and the Project Steering Committee;
- Serve as secretary of the Project Steering Committee;
- Manage and monitor all project implementation activities on a daily basis;
- Organize and convene project meetings;
- Conduct stakeholder meetings and coordination activities among and between stakeholders as needed;
- Submit a monthly report to the Project Steering Committee including activities undertaken and challenges to be addressed with recommendations for action;
- Produce progress and final project reports; and
- Prepare and submit post-project recommendations to the Government of Belize through the Ministry of Tourism & Civil Aviation and the Belize Tourism Board for follow up action.
- · Serve as facilitator for project related meetings and consultations with stakeholders.
- · Co-ordinate Public Relations efforts on behalf of the Sustainable Tourism Program.
- Any other responsibilities that may be assigned to ensure the successful implementation of the Sustainable Tourism Program.

In the implementation of these responsibilities the Project Director may be assisted by the staff of the BTB or other such public officers or other persons as may be appointed or

- designated for the purpose.
- The Project Director will prepare the following reports:
 - Initial work plan: Within two weeks of contract signing, an initial work plan with a detailed schedule of activities for the first year of implementation. The Project Director will also
 finalize the Program Operational Manual in consultation with the Belize Tourism Board and the Project Steering Committee
 - Subsequent Annual Work Plans, with a detailed schedule of activities for that particular year and an overall schedule that leads to successful implementation within the
 specified four year time frame.
 - Progress Reports: Semi-annual progress reports, to follow a pre-approved Bank format, due on January 31 and July 31 of each year detailing the (i) financial performance, (ii) breakdown of projects completed and findings on maintenance of civil works, (iii) findings on monitoring of environmental impacts and implementation of mitigation measures, and (iv) an analysis of problems encountered and steps taken to resolve them. and a plan of activities for the next period.
 - Quarterly Financial Reports: Progress reports, to follow a pre approved Bank format, due on March 31, June 30, September 30 and December 31 of each year detailing the expenditure for the previous period, problems found and how they were dealt with, and projected expenditure for the next quarter.
 - Final Report: a final report within 3 months of the end of execution of the program to follow a pre-approved bank format, including (i) the development of the program, lessons learned, conclusions reached and recommendations.
 - · Annexes of all reports shall include an execution chronogram.

V. PAYMENT SCHEDULE

The Project Director will be paid a monthly salary during the contract period, at a rate to be negotiated during contracting.

VI. COORDINATION

The Project Director shall work in close coordination with the Belize Tourism Board, Project Steering Committee, the Ministry of Tourism and the staff of the Project Co-ordination Unit.

Politics And The Law Should Not Be Mixed Dear Editor, more.

Thank you for allowing me a space in our Twin Town's STAR Newspaper. My intention in writing this piece is by no means to find argument for any back and forth on any particular topic, but to define and suggest recommendations for our Twin Towns forward movement as a vital part of our country's success.

My concern, as it is with many people that have made comment, is the POLICE CITIZEN SPECIAL CONSTABLES (PSCs).

First, I must applaud this idea. Anything that can help with the delivery of justice, on the side of the law is a plus in the society we live in - kudos to the Police for this important element of having private citizens help to provide us a safer community.

On the other hand, I believe that the process or criteria used to choose the people that are given the power to defend the law on our behalf, is flawed or perhaps, those in the position of choosing those PSCs have not proven that they can choose the most responsible people among us for this very important responsibility.

By no means are we saying that the system is flawed as far as the idea goes. But we are suggesting that the criteria need to be revisited because of some of the choices that we have seen. From talking to people who have had some qualms with (at least) a couple of the recently appointed PSCs, the general feeling is that, these individuals could use the law as a weapon against the very same citizens they are given the opportunity to protect. One potential case may be that **a** PSC may not have the decent ability to be objective when dealing with particular situations; a problem that could be decently dealt with could mushroom into something obnoxious where the REAL Police would have to then step in making the citizenry morale with Police confidence deplete even with 4X4 vehicles have a hard time driving to their houses when it rains.

Surely the Hon. Fernandez could request that the Ministry of Works send their grader out here to level our streets.

The town board elections are coming very soon. We would like to remind Mr. Fernandez that when area representatives forget and abandon us in Kontiki, we let them know of their failure on election day.

A release issued today by the Ministry of Economic Development, Commerce, Industry and Consumer Protection informs that it has come to the attention of the Belize Bureau of Standards that the price of butane sold by some distributors may exceed the current controlled price.

In light of this situation the general public is hereby informed that the current controlled prices for butane gas are as follows:

Corozal and Belize City: **\$86;** Orange Walk: **\$87;** Belmopan City and San Ignacio/Santa Elena: **\$88;** Benque Viejo del Carmen **\$89;** Dangriga: **\$90;** and Punta Gorda: **\$91.**

Consumers are advised to take note the current price and to alert the Ministry of infractions at **0-800-283-5587.**

Where there is failure to comply, consumers are reminded that the receipt is proof of purchase and this is important in seeking redress.

Distribution agents and the general public are hereby advised that selling above the controlled price is a serious offence under the Supplies Control Act Chapter 293 Section four (4) of the Laws of Belize.

Any person found in violation faces imprisonment for a term not exceeding six months or to a fine not exceeding one thousand dollars or to both fine and confinement.

2009's First Increase In Fuel Prices

SAN IGNACIO TOWN, Cavo, Wednesday, January 28, 2009:

Fuel prices in Belize increased today resulting from a rise in latest acquisition costs.

At the stroke of midnight, and as the date changed to Wednesday, January 28, 2009, fuel outlets across the nation ratcheted up the retail prices at their stations.

In San Ignacio/Santa Elena, the price of **Diesel** went up by 58 cents: From BZ\$4.85 to BZ\$5.43 -**Regular Gasoline** experienced a 93 cents increase from \$4.65 to \$5.58 and Super Gasoline went up from \$5.45 to **\$5.85**, an increase of 40 cents.

In July 2008, the world price of crude peaked at US\$147 per barrel. By the end of 2008, as most of the world fell into recession, prices plunged to below US\$49 a barrel.

The Commission intends to issue its decision to either confirm or further amend the AMENDMENT TO THE 2008 ANNUAL REVIEW PROCEEDING FINAL DECISION as previously issued on Friday, February 6, 2009.

Purpose for delay and consultation:

The purpose for the delay is to extend an opportunity to all Interested Persons to contribute to and perhaps improve upon the amendments made to the 2008 ANNUAL REVIEW PROCEEDING FINAL DECISION by the Commission.

Additionally, BEL filed an application with the Supreme Court for an injunction against and stay of the amendments until an appeal of the amendments filed by BEL with the Supreme Court is heard and determined. Rather than risk having the injunction and stay upheld and result in an undue delay in passing through the benefits of the lower cost of power (due to lower oil prices) to consumers, the Commission decided to make an undertaking to the Supreme Court to delay the implementation of the amendments for a potentially shorter period until a process of consultation is completed.

Assurance of pass through of benefits of reduced cost of power:

The Commission is required to set the Reference Price of Power (RPP – cost of power component of the Mean Electricity Rate) for the period January 1 to June 30, 2009, and by law the cost of power is a direct pass-through cost item. Despite any delays in the implementation of the amendments, the RPP is effective for that said period.

Therefore, the Commission hereby assures that consumers will enjoy any appropriate benefit that may accrue as a result of the reduction in the cost of power, as determined by the Commission, with effect January 1, 2009.

SAN PEDRO TOWN, Friday, January 30, 2009:

At about 6:00 pm today Police in San Pedro Town received information of a shooting incident in the Rock Point Area, North Ambergris Cave, about fifteen miles from San Pedro Town.

The suspects were reportedly making their way towards San Pedro in a white skiff with green and black stripes on the side, powered by a 150 HP Yamaha engine.

A joint Police/BDF team was dispatched to the area. Whilst travelling through the river in the Boca Del Rio area the team heard a boat approaching in the opposite direction and upon spotting a light on the skiff, they noticed that it fitted the description they had received.

The captain was directed to stop the boat but he reportedly refused to stop. The police continued in pursuit until it eventually stopped. Police observed one of the two occupants of the vessel standing with what appeared to be a gun in his hand and pointing it in their direction. The police fired at the person with the firearm. The individual then jumped overboard and escaped by swimming towards the mangroves.

Upon reaching the vessel, police came upon the captain of the boat, Eric Swan, with what appeared to be a gunshot wound to the upper right leg and a graze to the buttock. They also found six (6) live 7.62 rounds of ammunition, camouflage pants and a sea worthiness certificate in the name of Eric Swan inside the skiff.

Swan was taken to the San Pedro Poly Clinic and later transported to the KHMH where he remains in a stable condition under police guard.

Later that evening, Joseph Smith, 31, Belizean carpenter from the DFC area in San Pedro Town, whom police believe made the initial report, visited the station and reported that he was held up at gun point, in the Rocky Point area, by persons fitting the description of those inside the skiff. Smith informed that the individuals relieved him of two tanks of fuel. He was reportedly left drifting at sea in his skiff but managed to reach ashore safely.

At about 8 o'clock the following morning, Brionne Swift, 29 years, of Boca Del Rio area, San Pedro reported to police that he believed that his friend John Paul Saldivar was shot at around 4:00 pm the previous Friday evening, and that he might still be alive. On the basis of Swift's report, police visited an area about 16 miles North of Ambergris Caye, where they found a Hispanic, male person laying face up on the beach. The person had what appeared to be multiple gunshot wounds to the head and legs. The body also had several visible bruises. It was removed from the scene and transported to the San Pedro Poly Clinic where it was pronounced dead. The body was identified as that of John Paul Saldivar, originally of Corozal Town. A searched of the area resulted in the discovery of a 9mm Glock pistol along with a magazine with 13 live 9mm rounds. Also found in the area were two black warm caps adapted as masks, a flash light, a cellular phone and a large quantity

Is Someone Making A Mockery Of Our Constitution?

(Contributed) February 1, 2009:

I start my contribution to your newspaper by quoting from the Supreme Law of the Land – **The Constitution of Belize -** at Part II, Section 6.- (1) the Constitution states: "All persons are equal before the law and are entitled without any discrimination to the equal protection of the law."

A present preferential condition at our head station in San Ignacio has me seriously wondering if there are some people who are consciously making a mockery of the Supreme Law of the Land.

On January 21, 2009, **Ismael Correa** and **David Molina Jr.**, were denied bail and ordered by the court to be remanded to prison, until February 19, on a charge of Carnal Knowledge allegedly committed in Punta Gorda Town against a 15 old girl from San Ignacio Town.

With *all persons being equal before* the law, whenever the court orders an individual remanded to prison, that individual is transported to the Central Prison in Hattieville on the first available transport heading that way which, at the very most, is three days after the order has been issued.

Today however, a full ten days after the court order was issued for the remand of Correa and Molina, we are still holding and feeding them at the San Ignacio Police Station.

There are some among us who say that we are still holding them at the station because one of the remanded prisoners has a friend in our midst who is above our pay scale and that this person is stalling from sending them to Hattieville as he awaits the processing of bail for them through the Supreme Court. Quite frankly, I doubt very much however, that this individual is our Commanding Officer, as he has displayed exemplary character since his arrival here in San Ignacio. Probably it's the amount of paper work that crosses our Commander's desk each day but by now he should have been questioning why these two names have been appearing daily on the prisoner's list for over a week.

This situation certainly gives the impression that, in violation of the Constitution, not all of us are equal

before the law. Alternatively, since information sometimes takes a long time to trickle down to the lower ranks, maybe the holding of remanded prisoners at district stations, until Supreme Court bail is secured, is a new standard of the department. On second thought I doubt that this is the case because, within the past week, several other remanded prisoners were placed on board the next train to Hattieville.

In a nut shell, this situation does not look good for Section 6 (1) of our Constitution. peace by emphasizing brotherhood and respect, which of course are values instilled in the sport.

This is the first in a series of articles about the game of chess. In the

coming weeks the column will teach how to play chess, set some puzzles for those who know how to play and give some interesting facts about the game.

Chess is the fastest growing sport in Belize, it is rapidly being introduced across the country in primary schools as an educational and motivational tool.

Chess helps to develop many

academic and social skills.

The game is played on a board which is the same as a checkers board but unlike checkers, in chess, every square is used. You will notice that the board has letters and numbers, this helps identify every square and we can describe moves using the letter and number.

On the board there are 16 white pieces and 16 black pieces. The pieces on row 1 are as follows; a1 is a Rook, b1 is a Knight, c1 is a Bishop, d1 is the Queen, e1 the King. F1, g1 and h1 have another Bishop, Knight and Rook.

The black pieces are similar, the Queens always start on d1 and d8, to remember this, note that 'white Queen on white square, black Queen on black square'.

Each week we will look at how pieces move. First the Pawns on row 2 for white and 7 for black. At first, each of the pawns can move either one or two squares straight forward. After the first move each pawn can then only move forward one square at a time.

Pawns are the only piece that capture in a different way than they move forward, they capture one square at an angle,

diagonally. Another example, if white moves e2 to e4 and black moves f7 to f5 white can then capture the pawn by e4 captures f5.

You can practice playing with pawns only, even if you do not have a chess set, with a checkers board you can use beans instead of pawns (black eye beans and red beans!) set up 8 of each on the 2nd and 7th row and try a game.



Important reminders: Pawns never can move backwards, they only move at an angle when they capture, they never jump over another pawn, they capture on the same colour square. In chess, you do not have to capture, it is your choice to capture or not.

Fact: More books have been written about chess than any other sport or game.
