

Three Cayo Villagers Remanded For Arson

SAN IGNACIO TOWN, Cayo District, Wednesday, February 25, 2009:

Although they were arrested and taken to court today on a joint charge of arson, San Ignacio police say that they will also be pressing a joint burglary charge against three men from western villages in connection with a related incident.

On Friday, February 20, 2009, Godwin Sutherland made a first report to police in which he informed that his house, situated in the Little Vaquero area of the Mountain Pine Ridge was burglarized and that stolen therefore was an assortment of furniture, construction supplies and tools.

Although a statement was recorded from Sutherland and he was advised that the matter would

have been investigated, police did not as much as visit the scene of the crime.

Three days later however, on Monday, February 23, at about 9:30 pm, the police sprang into action upon receiving information that a

grey van with Cayo license plate CY-C-10235 was traveling from the Mountain Pine Ridge area with a cargo of suspected stolen items. Police rushed to the area and intercepted the van near Cristo Rey Village. When it was searched, it was found to contain a sofa, six

plastic chairs, 6 boxes of ceramic tiles, five one gallon tins of paint, one orange hand pump, one yellow playground slide and one battery operated toy jeep.

When questioned, the driver, Rene Rivera, 26, Belizean laborer from Santa Familia Village, was unable to provide the police with a credible account of the origin of the cargo he was transporting. Rivera was consequently detained and, along with the van and its cargo, was transported to the San Ignacio police station.

The items were identified by Godwin Sutherland as his property. The investigation also led to the arrest of **Gabriel Martin Canto**, 28 and **Albert Woodye**, 39,both Belizean laborers from Cristo Rey Village.

Police suspect that the trio was responsible for the first burglary and that they returned a few days later thereby proceeding to remove the remaining items from the house after which they set it on fire.

When police visited the scene,

Accused Of Jacking A 9 Year Old Boy

SAN IGNACIO TOWN, Cayo District, Monday, February 23, 2009:

San Ignacio Police are today looking for one **Jerome "Jerry" Pascacio** as he somehow managed to slip away from the courtroom after he was ordered remanded to the central prison on a robbery charge.

Jerome Pascacio, 23, Belizean laborer of a Santa Elena Town address, was arrested and charged with robbery and an alleged accomplice, **Simeon Bateman**, 20, also a Belizean laborer of Santa Elena Town was charged for theft in connection with the same incident. They both pleaded not

guilty to individual charges.

It was shortly after 5:00 p.m. on Friday, February 20 when a 34 year old Guatemalan woman visited the police station accompanied by her 9 year old son. The child told the police that it was about half an hour

earlier, while he was pushing his mother's three wheel vending cart on Carillo Puerto Avenue in Santa Elena Town, he was stopped by the accused Pascacio and Bateman. Pascacio reportedly proceeded to take one bag of plantain chips, one bag of chicharon, one bag of pepitos and a bag of boiled corn from the cart. When he requested the four dollar payment, Pascacio reportedly refused to pay. In the statement, the child informed that Bateman then grabbed him from behind and pushed his hand into the front pocket of the child's pants removing therefrom a plastic bag containing eighty dollars belonging

Just as we were returning from the distribution routine, my cellular telephone alerted of a text message and when I checked it, I momentarily went numb as the following message appeared. JUSTICE HAS BEEN SERVED. GOD IS GREAT! LIFE IS FREE! LONG LIVE LIFE. From:+5016070780. I instantly recognized the number to be that of Alfonso Cruz.

The first reaction was that this man seeking a leadership position could not be so heartless and so, giving him the benefit of the doubt, while at the same time calming my reaction, I attributed the insensitive text to be the actions of one of those irresponsible individuals with whom he surrounds himself.

It happened that at around 10:00 a.m., the following morning while on business in San Ignacio Town, I saw Cruz standing in the Columbus Park facing the police station. I drove up to him and inquired about the



Harim & Lenny Remanded On Rape Charg

SAN IGNACIO TOWN, Cayo District, Monday, February 23, 2009:

San Ignacio police are, this week, reporting the remanding of two men facing separate rape charges.

In the first reported incident, police informed that a 25 year old female Belizean public officer residing in Esperanza village reported that at 6:45 p.m. on Monday, February 16, she was standing on the side of the Western Highway in Blackman Eddy Village waiting for the bus for the return trip to her home after visiting her sister in Blackman Eddy Village. She informed that while waiting for the bus, a vehicle with a sole male driver stopped and offered her a ride. She reportedly boarded the vehicle and the driver introduced himself as Carlos.

The complainant informed that upon reaching on the stretch of the highway between Running W and Esperanza, the driver reportedly stopped the vehicle and with a threat of harm he allegedly raped her. She informed that whilst in the act she managed to escape from the assailant and fled in the nude leaving her clothing and other

personal belongings, amounting to \$856.80, in the vehicle.

She visited the police station at around 9:00 p.m. that same night and filed the report which included a detailed description of the vehicle along with its license plate number, a cracked windshield, and a for sale sign.

An alert Special Constable later observed a vehicle, in town, fitting the description and with the assistance of a uniformed policeman the driver was detained and escorted to the police station where he was reportedly identified by the complainant.

The accused, **Harim Perez**, of a Spanish Lookout address in the

Cayo District was consequently arrested and charged for rape. He was remanded to prison until Thursday, February 26, 2009.

In the second incident police inform of the arrest of Israel "Lenny" Parham, Belizean driver of a Cider Street, Santiago Juan Layout, San Ignacio Town address. Police reports that the alleged rape occurred sometime during the final hours on Wednesday, February 18 and the early hours on Thursday, February 19.

The complainant, a Belizean housewife of an Eduardo Juan

The emergency number worldwide for Mobile is 112.

If you find yourself out of the coverage area of your mobile network and there is an Emergency, dial 112 and the mobile will search any existing network to establish the emergency number for you, and interestingly, this

number 112 can be dialed even if the keypad is locked. Try it out.

SECOND

Have you locked your keys in the car? Does your car have remote keyless entry? This may come in handy someday. Good reason to own a cell phone: If you lock your keys in the car and the spare keys are at home, call someone at home on their cell phone from your cell phone. Hold your cell phone about a foot from your car door and have the person at your home press the unlock button, holding it near the mobile phone on their end. Your car will unlock. This saves someone from having to bring your keys to you. Distance is no object. You could be hundreds of miles away, and if you can reach someone who has the other 'remote key' for your car, you can unlock the doors (or the trunk).

THIRD: Hidden Battery Power

Imagine your cell battery is very low. To activate, press the keys *3370#. Your cell phone will restart with this reserve and the instrument will show a 50% increase in battery. This reserve will get charged when you charge your cell phone next time.

AND FOURTH - IF EVERYBODY DOES THIS, THERE WOULD BE NO POINT IN PEOPLE STEALING MOBILE PHONES.

How to disable a STOLEN mobile phone? To check your Mobile phone's serial number, key in the following digits on your phone: *#06#. A 15-digit coded IMEI number will appear on the screen. This number is unique to your handset. Write it down and keep it somewhere safe.

When your phone get stolen, you can phone your service provider and give them this code. They will then be able to block your handset so even if the thief changes the SIM card, your phone will be totally useless. You probably won't get your phone back, but at least you know that whoever stole it can't use/sell it either.

TESTIMONIAL: I just got a new phone and this came in handy. I knew about the coded IMEI number and used it when I had a phone stolen.

I know it works because a woman called me. She had bought my phone at a swap meet and it was locked. She asked me if I would unlock it because she was a poor mom who needed a phone. 

Two More Young Men Remanded For Robbery

SAN IGNACIO TOWN, Cayo District, Monday, February 23, 2009:

While the court continues to take a hard stance on crimes of dishonesty in the Cayo Judicial District, two more Santa Elena youth were today remanded to the central prison for robbing a Santa Elena woman of the last sixty five dollars she had in her possession.

Police reports that at around 7:30 pm on Saturday, February 21, Sonia Baldera, 19, Belizean sales person, residing in the Trapiche Area of Santa Elena Town, was on her way home in the company of her two nephews, ages 13 and 14, when upon entering a dark area near her home, a male person of Hispanic descent suddenly sprang out in front of them from the bushes and

to his mother.

With the mother and child in the police vehicle, a search began for the two accused. The child reportedly spotted and identified Bateman on Carmen Street where he was hanging out and he was taken into custody.

The search continued, and it was sometime shortly after 8:00 pm that same night when Pascacio was found and detained.

They spent the weekend in the police lockup and were taken to court on Monday morning where they pleaded not guilty to the charge. In court, the prosecution informed of the existence of a statement from the child's mother informing that at around 5:30 pm on Sunday, February 22, she was first approached by the mother of one of the accused who reportedly offered to pay her the \$4.00 in exchange for withdrawing the charge against her son. She informed that about an hour later the father of one of the accused also visited her home and offered to reimburse the eighty dollars on the condition that she discontinue the proceeding against his son. In the statement, the mother informed that she did not accept the money from none of the parents but that she is no longer interested in proceeding with the charge as she does not want any problems with the accused or members of their families. She additionally informed that she was neither threatened nor offered a bribe. The court however, declined to accept the mother's request as there is a possibility that the court could very likely invoke "Refractory Witness" provision of the Summary Jurisdiction Procedure Act 28, Chapter 99 of the laws of Belize which specifically seeks to address this matter. This is the same provision of the Act which the Chief Justice recently urged magistrates to begin utilizing in these specific instances.

Prosecutor George Gomez objected to bail and Magistrate Kathlene Lewis concurred. Pascacio and Bateman were consequently remanded to prison until Tuesday, March 17, 2009. Pascasio managed to sneak out of court and up to press time this Friday morning, he is still at large.
