Police, a move intended to usher a new management style into the department.

On hand for the official introduction was National Security Minister, **Hon. Carlos Perdomo**.

During the brief ceremony Minister Perdomo introduced

Commissioner of Police **Crispin Lincoln Jefferies** along with Assistant Commissioners of Police, **Noel Miguel Leal** (*Head of the Police Special Branch*); **Elodio Aragon Jr.** (*Management Services*); **Miguel Segura** (*Commander, National Crime Investigation Branch*); **David Henderson** (*Remains as the Officer Commanding Eastern Division*) and **James Magdaleno** (*Takes over from Jeffries as the Commander of Operations*).

Minister Perdomo informed that the new thrust of the department is production oriented and is intended to address the supervisory shortcomings that has been festering within the Department over the years. For his part Commissioner Jefferies informed that his primary concentration will be geared towards equipping and training the department.

Today's official introduction follows on the heels of last Thursday's official change of the department's command. The event took place at the National Police Training Academy in Belmopan on Thursday, April 30 whereby outgoing Commissioner of Police Gerald Lincoln Westby officially passed the department's colors to the new Commissioner Crispin Lincoln Jefferies.

The program began at noon with a lunch inside the police canteen after which the ceremony moved into an adjoining room with **Assistant Superintendent of Police Bart Jones**, serving as Master of Ceremony followed by **Pastor Luis Wade Sr.**, with the



Prime Minister's Wife Touring Children's Homes

Belize's First Lady, **Mrs. Kim Simplis-Barrow** is currently on a tour of children's homes countrywide.

The tour began this past Monday, April 27, 2009. The First Lady has indicated that she intends to visit all such facilities across the country. The tour is a part of her ongoing efforts to familiarize herself with the situation of children in Belize.

In the latter part of last year Mrs. Barrow was appointed by Cabinet as Belize's Special Envoy for Children.

Mrs. Barrow's appointment is in keeping with the results of the last Special Meeting on Children of CARICOM's Council on Human and Social Development held in February 2008 which called for the up scaling of efforts by member countries to promote and safeguard the rights of children in the region.

The meeting called for the identification of regional and national "*Champions for children*" as one strategy to focus attention on children's rights issues.

The Special Envoy for Children, which is an unpaid position, is intended to be the Belizean champion for children.

The Special Envoy works primarily in collaboration with the Ministry of Human Development and Social Transformation and the National Committee for Families and Children to fulfill the following duties:

a) Engage in public awareness and education activities designed to sensitize the general public to issues affecting children.

b) Collaborate with

government and quasi-government bodies to present projects seeking financial resources at home and abroad to support government programmes and initiatives for children

c) Advocate for and influence the development of social policies and legislation in defence of children.

d) Advocate for the implementation of programmes and initiatives that benefit children and their families and promote their rights.

e) Participate in delegations

that represent the Government of Belize at international and national forums relating to children.

In 2009, Mrs. Barrow intends to focus on the issue of commercial sexual exploitation of children and children with disabilities. She will be accompanied on her tour by **Ms. Judith Alpuche**, Chief Executive Officer of the Ministry of Human Development and Social Transformation and other officials of that Ministry, as well as from the Ministry of Foreign Affairs.

What You Should Know About The H1N1 Influenza

PUBLISHED BY THE FEDERAL REPUBLIC OF MEXICO

Mexico City, Sunday, April 26, 2009:

I. THE VIRUS

1. What is influenza?

It is a highly contagious respiratory disease of viral origin.

2. Is the virus a bacteria? If not, how long can it remain active outside a human carrier?

The virus is not a bacteria. Rather it is known as a complex supra-molecular structure which to replicate or reproduce itself requires a suitable host cell.

It is possible for the influenza virus to remain active on different surfaces, which is why it is recommendable to follow the hygiene measures that the Ministry of Health has made public.

3. What type of influenza is affecting Mexico? Is it the same as seasonal influenza?

No. This influenza, known as swine influenza, is different from those known so far which have affected human beings. The virus is A (H1N1).

4. What are the symptoms of this virus?

*Fever higher than 39 degrees centigrade (102.2°F)

*Dry cough and runny nose

*Sore muscles and headache

*Nausea or diarrhea

5. How is influenza diagnosed?

The diagnosis is done by a doctor by identifying the virus in nose or throat secretions (*viral isolation*) in the first 24-72 hours after the illness has begun, or by means of a blood test to identify antibodies.

6. How does a doctor confirm the presence of influenza in a patient?

Through a special laboratory test.

7. What can happen to me if I catch this virus?

The swine influenza virus can be controlled if detected in time, which is why it is very important to see a doctor as soon as the symptoms appear.

8. Is it possible to be ill from influenza without yet showing any symptoms?

Yes. The symptoms can appear after you have caught the virus.

9. They say young people between the ages of 25 and 45 are the most vulnerable. Why?

The groups at highest risk are children under 5 and the aged, or people with manifestations that diminish their immunological capacity. People who smoke, live with diabetes or some other chronic disease are at greater risk. In the current epidemic young adults have been in closer contact with the virus because of their mobility.

10. How is influenza transmitted from one person to another?

By direct contact between people or with objects containing the virus which then

have access to the respiratory tract.

11. Is it possible for the virus to travel and be transmitted by means other than human contact? For example, is it possible for the virus to be suspended in the air or contained in food or export goods?

The virus is transmitted from person to person, whether by contact with saliva droplets (*coughing or sneezing*) or with contaminated surfaces and materials, including hands, toys, plates, glasses, computer keyboards, telephones, door handles, bathroom faucets and other commonly used utensils.

12. Will the rainy season represent a major problem in terms of transmission of the virus?

There is no relation whatsoever.

13. Where do I go if I have symptoms?

To health center or any clinic or hospital.

14. Is it possible to acquire the illness through Mexican export products, whether fresh or canned, or through correspondence and parcels from Mexico?

No. The virus is active only for a few minutes outside the organism. Canned goods are not virus transmitters. Fresh produce should be handled with the usual hygiene measures to avoid transmission of diverse diseases.

15. Can I eat pork?

Infection is viral, transmitted from person to person, so there is no problem with eating pork.

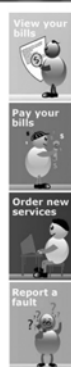

Like The Late Great Martin Luther King "I Have A Dream"

SANTA ELENA TOWN, Cayo District, Wednesday, April 29, 2009:

In the past, many good sons and daughters of this beautiful jewel of ours have passed away as a result of chronic diseases.

It is in this connection that I find it necessary to relate my story and to let you know what is presently transpiring in my life.

In September 2006, I went completely blind as a result of diabetic retinopathy and glaucoma. I was subsequently retired on medical grounds from the job I held with the Ministry of Agriculture. Since I only had 3 ½ years of service with the Government of Belize, I did not qualify for a pension.

In November 2006, I was diagnosed with polycystic kidneys. As a result I must undergo dialysis treatment three times each week.

This procedure is done only at Belize Health Care Partners in Belize City at a cost of \$680 for each session.

The Government of Belize, through the Ministry of Health is currently subsidizing this treatment. However; transportation, medication, blood tests and

emergency fees along with accesses, are not covered. These peripheral costs run anywhere between \$600 and \$800 weekly. This cost is posing severe challenges especially since I am both unemployed and without a pension.

Fortunately, some good Samaritans from time to time, render financial assistance and with the grace of God, I have been surviving.

I have encountered numerous other challenges resulting from this disability.

I must tell you however, that as I continue surviving, I have had people violently confronting me

because they assume that I am drunk and rude especially when I would accidentally bump into them as I maneuver in public.

Who feels it knows it. So to them I say, I am sorry and I forgive them as I continue to ask God to bless them.

Please be aware that I am in need, I am sick, unemployed and with mounting medical bills.

Despite this ability, and like the late great Martin Luther King "I have a dream".

I have a dream to one day be able to raise the necessary funds to build a kidney center.

I am working very hard on this dream as I would like no one else to be in my shoe.

I realize that this is no easy task. I

realize that it takes time and money to fulfill this dream. However, upon completion, a facility of this kind will serve the general public and maybe even members of my own family especially given the fact that this illness is hereditary.

I therefore take this opportunity to inform the general public that on Thursday, May 14, PLUS TV will be hosting a four-hour live telethon from 6:00 p.m. to 10:00 p.m. to raise funds for me and three other patients. The event will be broadcasted live on television. **Save us! Help us! It could be you tomorrow.**

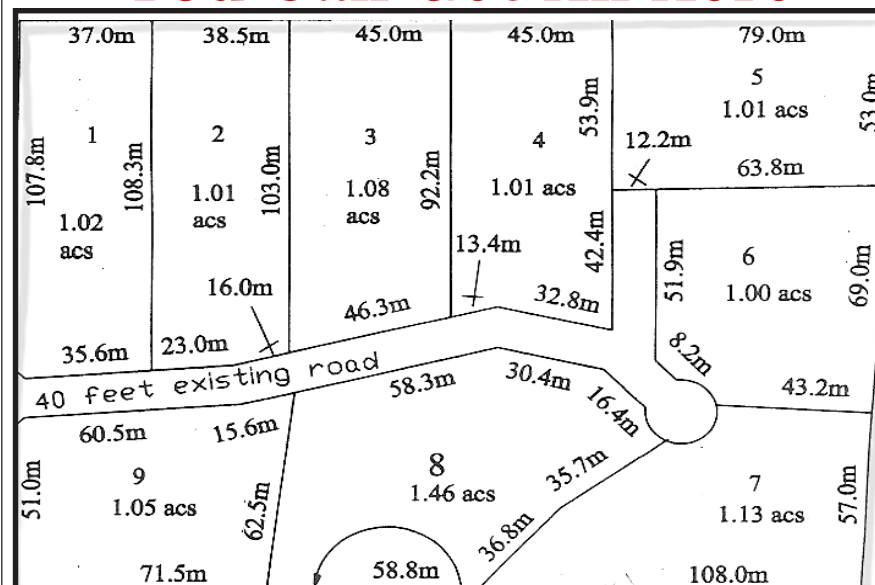

invocation.

Deputy Commissioner of Police / Chief Executive Officer Designate in the Ministry of National Security, **Allen Whylie**, gave the welcome address and introduced the outgoing Commissioner.

In his presentation Whylie described Westby as a humble man, hardworking and dedicated. He informed that **Gerald Lincoln Westby**, born on November 18, 1955, was just approaching 20 years of age when he enlisted in the Police Force on October 16, 1975 with regulation number 372. As a young constable he was first posted to the police patrol branch in Belize City. In 1977, he was transferred to Special Branch where on December 1st 1980 he received his first promotion to the rank of Acting Corporal. He went through every single rank right up to Commissioner of Police in March 2005. Apart from

My grandmother is certainly not the type to brag and boast of an award as prestigious as the one she's receiving tonight. So I will do the bragging for her. She deserves it.

Soon after, the name was changed from "Elvi's Burger Isle" to "Elvi's Kitchen". The restaurant continued to grow in popularity, the takeout stand was closed and the entire area, flamboyant tree and all, was enclosed to become the restaurant we all know and love today. It wasn't easy work. There were long nights, hot days and many tears. But there was also laughter and wonderful memories. Now, 35 years later, Elvi's Kitchen is a national icon, a popular restaurant known around the country and around the world for its delicious food, trademark dishes, friendly service and unique atmosphere.

At 77 years old, my grandmother has earned the right to retire and let others carry on the work she started. But anyone who knows her will tell you that Elvia Staines can't simply walk away from Elvi's Kitchen because it is as much a part of her as she is a part of it. One cannot flourish without the other. My grandmother is happiest when she's chopping fragrant cilantro or boiling lobsters or when she's making her signature mango sauce or her famous flan. She is completely at peace when she's cooking tamales, mole and other exotic native dishes. Always proud of the country's heritage, my grandmother introduced the Friday night Mayan Buffet to Elvi's Kitchen, where guests can enjoy traditional Mayan food lovingly prepared by Elvia and her staff. In her own way, she is reminding guests of Belize's rich culture and history.

And whether she knows it or not, she is an ambassador of sorts. She is on the front lines of the tourism industry, greeting visitors to our nation and showing them an extremely vital part of Belizean life and culture: it's food.

Who would have thought that Miss Elvi, as she's known, the wife of the late Enrique Staines Sr. and the mother of six children, would become such a prominent figure in the tourism community?

Some of you may know her from a friendly smile and handshake at the restaurant, or from photos in the many newspaper and magazine articles written about Elvi's Kitchen. And this award may be an indication of her work ethic and her character. But please know that Elvia Staines is first and foremost a patient mother and loving grandmother and great-grandmother. She has built her career on her love of cooking and a love for the island she has always called home.

And maybe that's what it all boils down to and what this award is truly about. Elvia Staines represents the best of that wonderful place we call San Pedro. She embodies its traditions and its history, the strong work ethic mixed with the casual, friendly attitude. Like its sandy beaches, she is warm and inviting. She is generous like the sea and as dependable as the tides. And like San Pedro itself, Dona Elvia is uniquely and unapologetically, Belizean.

Improving Rice Production In Toledo

BELMOPAN, Monday, April 27, 2009:

The Ministry of Agriculture in partnership with the Republic of China Taiwan Technical Mission (TTM) of Belize held a Rice Seed Production Field Day last Friday in the Toledo District.

The Field Day was held at the Poppy Show Rice Farm located approximately six miles from Punta Gorda Town.

The Poppy Show Rice Farm yields an average of 5 to 6,000 lbs per acre of improved rice varieties under an irrigation system through assistance from the TTM.

The objective of the project is to introduce superior rice varieties, establish a seed propagation system, expand the scale of seed production and produce stock seeds and commercial seeds with excellent quality for farmers of the Toledo District.

During the event, Chief Executive Officer in the Ministry of Agriculture and Fisheries, **Gabino Canto**

highlighted the importance of the rice seed production project which was restarted in December 2008 to contribute to food security in Belize. He thanked the Tawianese Mission for their assistance in the rice seed project, as well as assisting with mechanical harvesting

equipments and the training of extension officers within the Ministry.

Area Representative for Toledo West, **Hon. Juan Coy**, expressed his gratitude for the assistance from the Taiwanese Mission. He pledged on behalf of his constituency to do their

part to make the project a success in order to improve the livelihood of farmers in the Toledo District. The Hon. Juan Coy further informed that with this assistance, farmers are anticipating an increase in rice production in the district.

The Republic of China Taiwan Technical Mission of Belize has been working in collaboration with the Ministry of Agriculture and Fisheries since 1991.

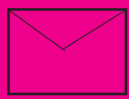

Re.: Mr. Wellington C. Ramos' article in the STAR Newspaper, Sunday, April 26, 2009, page 13. *"The United States Of America Should Normalize Relations With Cuba"*

Perhaps, Mr. Ramos should be reminded of the key issues related to Cuba and normalization of U.S-Cuba relations:

* *Human rights abuses,*
* *Freedom of the press and expression (as an International Correspondent I'm sure you know there's no freedom of the press in Cuba), and*
* *Political prisoners*

(but perhaps Mr. Ramos doesn't have a relative imprisoned in Cuba for political reasons, so they don't count).

To this we should add no free elections for half a century, making it, effectively, into an hereditary dictatorship (*first Fidel, now Raul*).

Has Cuba really played *"a vital role in the social, economic and political development"* of the region?

Let's see, the Cuba regime has consistently supported armed insurrection against democratically elected leaders in Peru (*through Sendero Luminoso*), Colombia (*through the FARC*), Argentina (*through the Montoneros*), etc.

Not to mention that these groups so beloved by the Castro regime have committed, and are still committing, heinous crimes against the population such as mass murders, extortion, kidnappings, assassinations, torturing, and displacement of millions of people within countries.

Mr Ramos, The Castro regime is not the altruistic, humanitarian enterprise you try to portray in your article.

Since its inception, the Castro regime has been based in the systematic slaughter of thousands of Cuban citizens who opposed or even disagreed with its policies.

Why do you think so many Cubans have been fleeing the country, who, if caught, have

even faced the death penalty?

I wonder if the author has ever lived in a totalitarian tyranny in which your thoughts are controlled and you can be jailed on suspicion alone.

Yes, it's nice to get some *"freebies"* like scholarships, or free medical treatment, while placed in the best accommodations that the Cuban government can offer to foreigners. Can you honestly tell all this wonderful things to the families of the murdered victims drowned when Cuban Navy boats rammed their rickety boats while fleeing the island, or to the families of those still imprisoned or shot to death for disagreeing, or to those youngsters punished/jailed for listening to rock and roll?

At the Summit of the Americas, **US President Barak Obama "called on Cuba to release political prisoners and reduce taxes on remittances from the U.S."** (*The Reporter, Sunday, April 26, 2009, p. 31*). I'm including the following quotes from that same edition of the Reporter because they might clarify why the embargo goes on: *"Fidel Castro says President Barak Obama, misinterpreted' his brother Raul's remarks regarding the United States and bristled at the suggestion that Cuba should free political prisoners or cut taxes on dollars to the island."* So Fidel Castro wants his cake and eat it too... without providing a crumb of humanitarian concessions to his own people.

If the Cuban regime wants to be included in the community of continental American nations, it must free its political prisoners, allow access to prisons to the UN and Human Rights organizations, have free elections, have freedom of the press and freedom of expression, allow its citizens free movement inside and outside of the country, allow it's citizens to get employment where they want to work...in other words, allow the minimum rights that you and I and all fellow Belizeans enjoy today without even thinking about them.

Four New Primary School In The Stann Creek District

BELMOPAN, Monday, May 4, 2009:

The Ministry of Education today informs that Education Minister, **Hon. Patrick Faber** will, on Wednesday May 6, be inaugurating four new schools in the Stann Creek District

The visit to the Stann Creek District is part of the Minister's countrywide tour of all schools throughout the country.

Minister Faber will join representatives of the European Union in Belize and the Social Investment Fund in the inauguration of the new Bella Vista RC Primary School, Trio Government School, San Juan Primary School and United Community School projects.

Some 1,978 school children will benefit from the four projects, which were implemented by the Social Investment Fund and financed under the European Union Banana Support Programme to Belize at a total cost of BZ\$1.4 Million.

Villagers in each of the receiving communities join in by contributing labor towards the projects.

The E.U. Banana Support program is focusing on the following three critical areas:

(a) market and transit facilities in the banana belt.

(b) Improved access to technical high school education and

(c) Improved access to adult skills training.

With the exception of United Community, the new school buildings in Trio, Bella Vista and San Juan are similar in size and design. The work scope for the project in these communities included the construction of a 3,600 sq ft single-storey reinforced concrete school building measuring 30 ft wide by 120 ft long. The building is

comprised of four classrooms with one movable partition wall between two classrooms, a female and male bathroom block and an administration office.

The work scope for the United Community School project entailed the construction of a two-storey reinforced concrete building, which measures 60 ft 10 inches long by 31 ft 2 inches wide. Each level has two and half classrooms 24ft long by 25 ft wide and a front verandah. The half classroom space will be used as a male and female sanitary block on the ground level and a Principal's Office and teacher's bathroom space on the upper level. The project entailed the provision of two stairways, electrical installation, and a standard septic tank with soak away for the sanitary blocks.

Furniture was also supplied to the schools as part of the project. The buildings are designed to withstand category 5 hurricane winds.

Other guest speakers for the occasion will include **Mr. Ian McMillan**, Executive Director of the Social Investment Fund, **Ms. Isabel Gayot**, Country Representative of the European Union, Area Representative For Stann Creek West Constituency, **Hon. Melvin Hulse** and Area Representative for Toledo East, **Hon. Peter Eden Martinez**.

The Minister of Education's tour of schools throughout Belize started last year right after he assumed his ministerial role.

The objective of the tour is for the Minister to visit all schools and to hear the concerns of stakeholders and see the conditions of schools countrywide. So far, he has visited schools in all six Districts and the tour resumes on its second leg to achieve the objective set out.

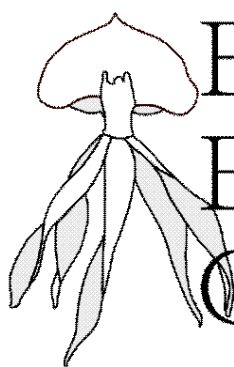

that those who burglarized the building exited through a back door by first breaking the wooden door and then prying open the burglar barred door behind it.

Investigators are of the opinion that the smaller safe was removed from the building by placing it on a secretarial chair, with wheels, and that the chair, with the safe on top, was pushed to the area where it was found.

The total removal of the safe from the compound might have been foiled when some youngsters, returning home from a night of partying, came upon two masked persons in the area. Suspecting that the intended target was the nearby, barber shop and mini boutique, which had fallen victims of burglary in the past, the youngsters drove around the corner to the police station and reported the sighting and their suspicion.

Police visited the area, checked the barbershop and mini boutique, but failed to check the Credit Union Building and compound across the street.

After leaving the station, the girls drove back to the area,

dropped off their friend and proceeded to their home located in another part of San Ignacio Town. Coincidentally or otherwise, when they woke up the next morning they found the back windshield of their car smashed.

While the burglars might have been disappointed that their effort to remove the safe from the compound was disrupted, especially given that it took tremendous effort by five male persons to get it back into the building, the disappointment of the burglars would have been much greater had they actually
