

CORPORAL THOMAS WILL BE LAID TO REST WITH FULL POLICE HONORS

SANTA ELENA TOWN, Cayo, Thursday, May 28, 2009:

Ten days after celebrating his 48th birthday, Police Corporal **Errol “Pidding” Thomas** passed away on May 16 whilst undergoing medical treatment at a hospital in Chicago, Illinois, USA.

Relatives informed that it was less than four months ago when Corporal Thomas began complaining of chest pains. He was granted medical leave and on February 20 he traveled to Chicago where 5 of his siblings - *3 brothers and 2 sisters* - reside.

Upon arrival he was immediately taken for medical evaluation and remained hospitalized until he passed away on Saturday, May 16.

Errol Thomas, Pidding as he was fondly known, was born on

May 6, 1961. He grew up and attended primary school in Santa Elena, Cayo.

He was part of Recruit Squad #47 graduating from the Police Training School on December 1, 1984 along with other serving members of the department which includes **Assistant Commissioner of Police Noel Miguel Leal, Supt. Linden Flowers, ASP (60) Roy Joseph, Insp. (#140) David Chi and Constable (re-enlisted) #733 Lucio Tun** who is currently attached the Benque Viejo Sub Formation.

During the over 24 years of unbroken service in the Police Department, Corporal Thomas has been posted to Mango Creek Village and every District Town, except Corozal Town.

He was last posted as a relief commander at the Police Station

Belizean Mechanic Arrested For The Murder Of A Guatemalan Laborer

SAN IGNACIO TOWN, Wednesday, May 27, 2009:

Nine days after the May 18, discovery of the burnt remains of a Guatemalan laborer, San Ignacio police today arrested and charged a Belizean Mechanic for murder.

Acting upon information received, San Ignacio police, at around 9:30 on the morning of Monday, May 18, 2009 arrived at a farm located approximately

4 miles from the village of Buena Vista where they came upon a crime scene.

The first thing that came to the attention of the police was the burnt remains of what was once a small house measuring approximately 12 feet by 10 feet which had a thatched roof. The farm in question is the property of **Guillermo Sibrain, 44**, Belizean farmer of Buena Vista Village, Cayo District.

Police were also directed to the burnt decapitated remains of **Juan Carlos Castillo Valenzuela, 26**, Guatemalan laborer from Buena Vista Village. The remains was found lying face upwards on the ground in the middle of the ashes.

Initial investigation revealed that Guillermo Sibrain hired the deceased to

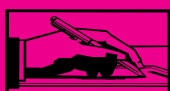

Editorial



There Are Still Some Policemen Who Simply Cannot Write

The primary function of a policeman/woman is to record a statement and write a report. If any member of this department lacks the ability to perform this basic function then that individual should **NEVER** be allowed to join the ranks of the department and if allowed to do so, that person might very well be collecting a salary under false pretense.

Notwithstanding, many are the *“policemen/women”* who lack this fundamental skill. Although the lack of this basis ability will never be acceptable, some justification for this shortcoming can be blamed on the criterion of years gone by when the minimum educational requirement for enlistment into the Belize Police Force was a primary school certificate. However, this minimum educational qualification was elevated a few years ago to a high school diploma. The harsh current reality however is that there are still some policemen who simply cannot write.

A policeman must possess the ability to listen to a complaint and put that complaint properly in writing. Hence the reason why the victim of a crime is legally referred to as the *complainant* and hence the reason when a policeman, giving evidence in court, acknowledges the swearing to an *“information and complaint”*. Therefore, if an individual lacks the ability to record a *complaint* then that person has no place in the department which primarily deals with *information and complaint*.

The presence of these individuals on active duty is creating major challenges for the department while simultaneously eroding the credibility of the department and seriously jeopardizing the dispensing of justice.

It is no secret within the department, that as they continue to conceal their inability to record a statement, these individuals would oftentimes encourage complainants not to provide statements by finding excuses like: *“If you proceed with this case, it will take up a lot of your time because you will have to come to court a lot and you will lose time from work, I will just go out there and talk to this person for you”* etc. Or like the policeman who was posted in Santa Familia a few years ago, telling a complainant who reported personally seeing Mr. X stealing his cattle, that it was a civil matter and that he should take out a civil suit against Mr. X, thereby washing his hands clean of an obviously criminal matter and not having to record a single statement.

When recording a statement or writing a report, the basic rule in policing is that the author can never provide too much information. However, because of the lack of writing skills, the statements and reports that these individuals produce are short both in length and in substance consequently making it much harder for investigators to formulate the elements of criminal charges and for prosecutors to marshal evidence in court which ultimately reduces the number of offenders brought to justice as well as the rate of convictions.

One therefore wonders, how did those Commandants of the Police Training Academy sign these person's graduation certificates and allowed them to emerge from the academy with a regulation number.

There is the excuse that these individuals might have slipped through the cracks due to political intervention. If this is the case then we ask politicians to please halt this practice. Mr. Politician, if you are seeking employment for a voter who lacks the basic ability to write; the delicate functions for effective policing in these modern times is certainly not the place for this voter. For the love of your country and the security of the nation, please look elsewhere for a job for these voters.

We have presented the problem. Now, for a possible solution: We are not reinventing the wheel and we will not be suggesting anything new. In fact the current Minister of Education has already taken the lead in this regard.

The Ministry of Education is no longer tolerating unqualified teachers to instruct the generations of the future. The Minister of Education said it best in addressing teachers: *“If you do not qualify yourselves, then there is no place for you in the classroom”*.

It is in this light that we call on the new Commissioner of Police to draw the line. Mr. Commissioner, it's time to conduct an audit of the police personnel under your command. Formation Commanders across the nation must be tasked, within a recorded period of time, to identify all those policemen who lack the ability to record a statement and write a report. These individuals must be reverts to the training academy for a time recommended by literary professionals, and if at the culmination of the training there remains persons who continue to lack this skill, then like the Minister of Education would say, *there is no place for them in the Police Department*.

Why the need to record the time during which Formation Commanders

must identify those in need of being reverted to the training academy? Well, like in all organizations, they have buddies under their command who they might shield, eventually however, those shielded buddies could be transferred to another formation at which point their shortcoming will come to light and so in finding out how these individuals managed to slip through the crack, all that needs to be done is to determine where that individual was posted during the recorded period of the audit and after independently certifying that the individual indeed lacks the skill, then the Commander who failed to bring the matter to light, must be made to answer for his actions.

San Ignacio police is keeping a close watch on a Belize City boy in custody as he awaits trial for a May 24 burglary of a house in San Ignacio Town.

The incident began shortly after 4:30 on the morning of Sunday, May 24 when an alert police constable and corporal on mobile patrol in San Ignacio Town spotted the boy with in possession of a laptop computer,

Later that day, a San Ignacio resident, **Elder Acosta**, 68, US national, visited the police station and reported that during the hours of 7:00 am and 7:00 pm on Saturday, 23 May, his house, located at #25 Ford Young Drive in the Cahal Pech Area of San Ignacio was burglarized. Acosta informed that the missing items included an HP XL laptop computer with power cord valued at \$3,060; a Kodak digital camera, valued at \$600; a silver ring and a silver chain valued at \$100 each, all for a total value of \$3,860.

At around 7:00 pm that same Sunday night, police made a check inside the nearby detention cell and found out that the boy was gone. Check revealed that he escaped by prying away the celotex

An alert was instantly communicated to all police formations countrywide. The hunt for the escapee eventually ending when he was detained in Belize City. He was brought

US Naval Frigate On 5 Day Visit To Belize



The USS Kauffman On The High Seas

BELMOPAN, Tuesday, May 26, 2009:

A release from the US Embassy in Belmopan informed of today's arrival in Belize of the US Military Ship, the USS Kauffman from the U.S. Southern Command Naval Base.

The US Naval Vessel will be in Belize as part of Operation Southern Seas 2009 which is a six-month naval deployment to the Caribbean, Central and South American region.

The vessel's five-day visit to Belize ends on Sunday, May 31, 2009. While in Belize, the crew will paint several buildings at the Stella Maris School in Belize City.

The crew will also conduct training exercises with the Belize Defense Force in areas such as small arms repairs and search procedures.

This visit provides an opportunity for nations in the Caribbean, Central America, and South America to build and maintain

regional partnerships, to develop professional understanding in the region, and to increase regional stability through enhancing inter-operability in combating illicit maritime activities.

The USS Kauffman is one of only twelve Frigates with the enhanced MK 92 MOD 6 CORT Fire Control System which, when combined with the ship's two helicopters, 76mm gun, and state of the art anti-submarine warfare system, provides the USS Kauffman with an effective offensive and defensive capability in today's multi-threat environment.

The vessel has a crew of approximately 250 personnel. This relatively small crew size results in a close knit team that relies heavily on the technical skills and leadership abilities of each and every Sailor while providing ample opportunities for professional and personal growth.

The vessel is named after **US Vice Admiral James Laurence Kauffman (1887-1963)** who served in the navy for 41 years. He was only 21 years of age when he graduated from the US Naval Academy in 1908.

Admiral Kauffman held a variety of wide ranging command both afloat and ashore during World War 1. He provided 41 years of loyal service to the US Navy. He passed away at age 76 being 14 years after retiring for the arm of the US Military service he loved most.

And the clerk said, "**Because the 'TV' you want to buy is a microwave.**"

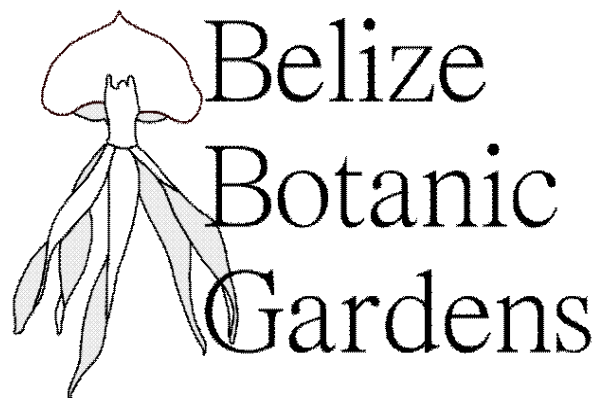
Another One Of Those Blonde Jokes

Two blonde men were working on a house. The one who was nailing down siding would reach into his nail pouch, pull out a nail and either toss it over his shoulder or nail it in.

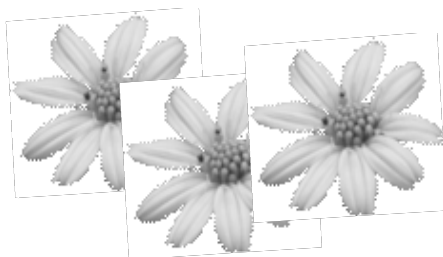
The other blonde guy, figuring this was worth looking into, asked, "**Why are you throwing those nails away?**"

Belize's Longest and Most Violent Tremor

JUST SOME FOOD FOR THOUGHT

It was around 2:30 on the morning of Thursday, May 28, when Belizeans experience the longest and most violent tremor of an earthquake in recent memory.

The earthquake was measured at 7.1 on the Richter Scale with its epicenter located about sixty miles northwest of La Ceiba Honduras and about 180 miles from the coast of Belize.

When the initial shock had passed, the tremor left in its wake the most personal and infrastructural damage that any tremor has ever felt in Belize.

Homes and public buildings were damaged primarily in the southern villages of Independence, Placencia and Monkey River.

The elevated concrete water reservoir in the village of

Independence collapsed and was left in rubbles on the ground.

This is certainly the worst tremor that many of us have experienced in Belize which from the lack of consultation with any geologist, reminds us of the predictions of the late Geologist, *James “Jungle Jim” Cavanaugh*, who in several of his writings warned of the effects that oil exploration in Belize could have on the instability of the earth below us.

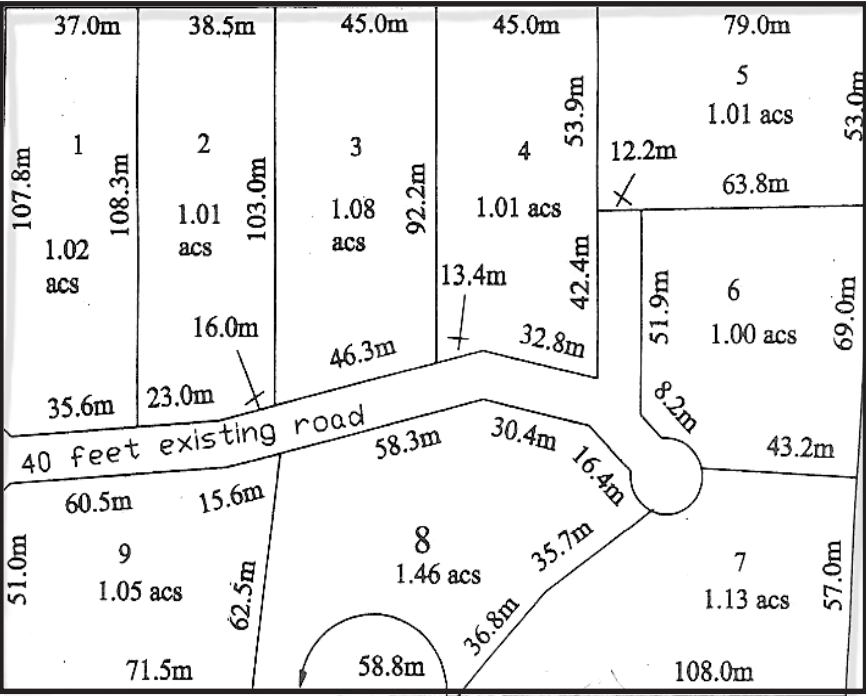

Vehicles, like other equipment in the world of business, are machines and with time they deteriorate and are replaced.

In business terms it is referred to as ***"depreciation"***.

In a more direct response to the concern you expressed regarding ***"People Di Suffa Out Ya"***, ask yourself the question, in terms of consumer prices, as a people, ***are we better now than we were 15 months ago?***

Take note of the following changes in consumer prices since the change of government 15 months ago:

1. Fuel prices have gone down from 12 change to 7 change a gallon.

2. The price of a sack of flour has gone down two times and it now costs 19 dollars less than it was prior to February 2008.

3. The most recent reduction in the price of butane is now recorded at 37 dollars less than what it was 15 months ago. This commodity has gone down from 126 to 89 dollars for a 100 lb cylinder.

4. The price of the Belizean staple, RK beans, has gone down from \$3.25 a pound to \$1.50 a pound.

Challilo Is Bad News

Colin bh, in his article “A new Commissioner is not enough” (Amandala 17 May 2009), sounded like someone honestly trying to make sense of Chalillo, after the fact, not realizing that the points he raises were raised at the time (*like bagasse as an alternative source of power generation*).

Unfortunately, most of what he raised came from the Fortis-BECOL propaganda. It has been said that if a lie is repeated enough, people come to accept it as truth. We seek to make sure that does not happen. The facts are that our electricity rates keep going up, the Macal River is polluted, and the dam poses a constant danger to those of us who live downstream.

The site chosen for the Chalillo is sandstone and shale, not granite, and was built on an earthquake fault line, which was erased from the geological map when they proposed to build the dam. We did not say this; geologists said it.

Those FACTS all came to light in the court case challenging the inaccuracies in the Chalillo Environmental Impact Assessment (EIA). In fact, the dam was re-designed because of the truths that came to light in that court drama.

The engineers that built the Chalillo were hired by Fortis. We asked to see the NEW design of the dam, and be informed of the added costs, but were not given access to that information; maybe Colin bh or other readers could ask BECOL to make these new designs and costs public.

About the reservoir being unable to sustain the required level of water during the dry season - that too came from geologists. The reservoir is built above a major Mayan site which was conveniently covered up - a large limestone system filled with caves. Again, geologists doubted it could maintain a high level of water, year round, not us.

We have not been provided information on the quality of the water in the Macal River, but we know that Belize Water Services is having a heck of a time trying to provide the twin towns with

clean water. BECOL was supposed to provide information on water quality but they haven't.

As to the mercury in the fish, Public Health has reported on the high levels of mercury in the fish and issued public warnings. They have not been forthcoming on updating and informing the public on the conditions and safety of eating the fish. We understand the financial constraints on government, but this is an expense that is supposed to be carried by BECOL. And the Department of Environment is supposed to be assuring this is done.

As to rates compared to other countries, BEL only shows us comparisons to Caribbean countries, islands!!! It does not compare our rates with other Central American countries. BEL claims our rates would have been much higher. But they have a long record of not being forthcoming about the facts.

The Chalillo and Mollejon have **NOT** brought electricity prices down – ask anyone who pays their own electric bill. We are still dependent on Mexico for half of our power (*that is hardly self-reliant*). And please, let's clear up the old mantra about

Chalillo reducing flooding. It is true it has reduced the amount of flash flooding which cleans the river. A reservoir that is built to produce electricity has the goal of being kept as full as possible. A reservoir to reduce flooding has the goal of keeping levels low, so it can hold floodwaters when they come. We have not forgotten there were two floods, the tropical wave and the June 1st tropical storm, when the water was pouring over the Chalillo as if there was no dam.

Ask the people living downstream how comfortable they feel with another hurricane season upon us. We still have

no dam break warning system and people have no idea of what to do in case of a dam failure. We do not want the dam to break; we do not want to say “*we told you so*”. We want to have protections in place. We want to feel safe in our homes.

Colin bh called us “*feisty*”. We can't argue with that. We did resent the names the former GOB and their cronies called us (such as “eco-terrorists”) for honestly speaking out and trying to set the record straight.

If we had it to do all over, we would approach the matter differently, but we would - and still do - oppose Chalillo. It is still a lie.

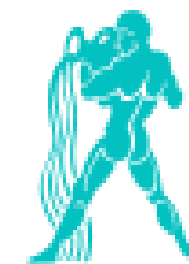

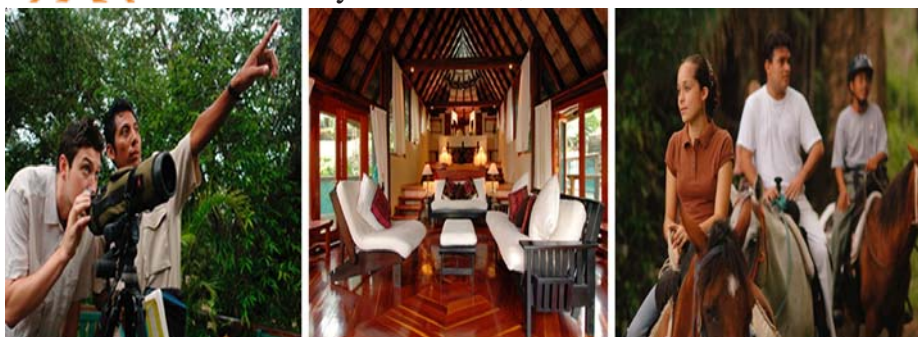
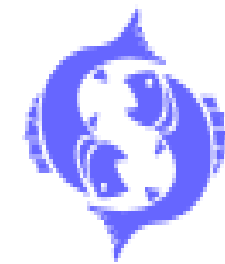

Education Week Celebrated 10th to 15th May

BELMOPAN, Monday, May 18, 2009:

Education Week was celebrated countrywide during the week of the 10th - 15th May, 2009.

The theme for this year's celebration was *"Better Schools, Better Citizens, Better Belize, whatever it takes: It's Everybody's Business!"*

Minister of Education, **Hon. Patrick Faber** opened the week with a radio and television address in which he described his experiences from an intensive tour of all schools which he has undertaken since taking office in February 2008.

Minister Faber said, *"I have visited schools...where children come to school barefooted. I have seen overcrowded classrooms. I have heard of young children going through the garbage in search of food to eat, I have met teachers whose only qualification is a high school diploma or an Associate Degree in a field other than education, I hear complaints of schools wanting to register some students of one religion before others."*

These observations are only a few which capsule the minister's experience. He additionally highlighted the need for change through the joint efforts of all - *"Children and Young People, Parents and Guardians, Teachers, Principals and Managements, Religious Organizations, Community Organizations,*

and other Social Sector Organizations, NGO's and Private Sector Actors, Politicians of whatever color or creed, Fellow Citizens and Residents of Belize. Let us come together for each other as we make Better Schools, Better Citizens, Better Belize, whatever it takes: It's Everybody's Business!"

As a true leader setting the right example the minister translated his words into action by holding a meeting with two former Ministers of Education, **Hon. Francis Fonseca** and **Mr. Elodio Aragon**, primarily to discuss a bi-partisan approach to improving and creating a successful educational system for our nation. During this meeting Minister Faber extended an invitation to both gentlemen to become active participants within his ministry. This gesture of humility by the minister emphasizes the maturity, determination and willingness of the leadership in making education a priority.

Also in commemoration of Education Week, other officials from the Ministry went on various morning shows to discuss the products and services offered by the different units within the Ministry. The week should have culminated with a grand expo at the UB campus in Belmopan, but due to the threat of the Influenza A H1N1 it was

enthusiasm from the students, teachers, managements and parents. He learned of the hardships confronting them such as overcrowded schools and a significant percentage of untrained teachers. While these concerns are not unique to San Pedro Town, the Minister gave his assurance that priority will be afforded to their concerns.

Issues such as crime, unemployment and education were high on the list of concerns. The group came up with some strategies which will be implemented over the next few months. The Minister expressed his hopes that these consultative and partnership meetings can be held on a regular basis so that the work can continue in building a peaceful and constructive society strengthening the future for all young Belizeans.

chop and clean the farm. He began working on Monday May 18. Reports indicate that the deceased was last seen alive at around 6 o'clock that same Monday morning when he visited his employer's house for food to take to the farm.

Police reports that on Tuesday, May 19 farm owner sent his 18 year old son, **Rudy Bautista**, to plant some corn on the farm. Upon arrival, shortly before 8:00 am, Bautista found the farm house burnt to the ground along with the burnt remains of a human body almost in the center of what was once the farm house. He rushed back to his father's house in Buena Vista Village and reported the matter to him. The owner of the farm subsequently contacted

the police thereby triggering the investigation which consequently led to the arrest, on a singular murder charge, of Victor Vargas, 32, Belizean mechanic also from the neighboring village of Buena Vista.

Reports suggest that as a result of their dependency on drugs, the deceased and the suspect were acquaintances.

While one lead is suggesting that they were involved in an argument over some lumber and a few sheets of zinc; another path that the investigation is reportedly taking is that the murder was actually a paid hit and that the victim's head was the proof of "**mission completed**" requested by those who ordered and paid for the killing.
