in which he arrived earlier at the night club.

A team of police officers rushed to Awe's Cahal Pech Area residence where the blue car was seen parked nearby thereby indicating that he was at home. He reportedly promptly responded to the police call and, without any difficulty, handed himself over to the police. He also retrieved the suspected murder weapon from one of the drawers of a chest of drawers and handed the gun along with an empty magazine to the police. The gun was identified as a black and chrome nine millimeter pistol, model 910S, Smith & Wesson brand with serial number BDX2478.

With no bullets handed over in the magazine of the gun, investigators are of the opinion that the accused might have emptied the gun on the deceased.

The accused was transported to the police station where he reportedly gave a caution statement after which he was placed inside a holding cell.

Reports reaching us indicate an ongoing dispute between the accused and the deceased, reportedly with a female friend of both in the middle. In the course of the dispute, about a month ago the deceased reportedly punched the accused in the mouth while he was purchasing food from a Burns Avenue street vendor. It is further alleged that a few weeks ago, the accused reportedly found a bottle near the doorway

of his house said to have contained a threatening note to the effect that the accused and his family will be killed.

It is further reported that a few hours prior to this incident, the accused and the deceased met at the Sunset Bar in the Savannah Area of San Ignacio Town where an exchange reportedly occurred after which the deceased departed en-route to the Legends 2000 Night Club. Shortly thereafter the accused reportedly arrived after which another exchange occurred which reportedly resulted in the accused pulling out his licensed pistol firing the barrage of shots from almost point blank range at the deceased. A preliminary inspection of the body revealed at least nine wounds all to the upper chest area of the body of the deceased.

The body remained on the scene for almost two hours after which it was transported by police mobile to the nearby San Ignacio Community Hospital where, upon arrival at exactly 3:40 am, it was officially pronounce dead by the Medical Officer on duty, **Dr. Fidel Cuellar**.

The body of **Beel Efrain "Paing" Cruz**, brother of **Alfonso "Ponches" Cruz**, former Mayor of San Ignacio/ Santa Elena, now awaits the legally required post mortem examination while the accused, **Emilio Alfonso "Chubs" Awe** remains in police custody waiting to be formally arrested and charged.

Sr. Supt. Chester Williams Is Cayo's New Police Chief

Chester Williams was only 17 years of age when he enlisted in the police department in March 1991.

After successfully completing recruit training in 1991, the young Police Constable #350 Chester Williams was a part of the bulk of young constables assigned duties at Belize City's Eastern Division Patrol Branch where he spent the first 2 years of his career after which he was transferred to San Pedro Town then to San Ignacio where he was posted between 1994 and 1995. He later did a brief stint in Placencia Village before being reassigned to San Ignacio in

1996. He remained in San Ignacio for a year when in 1997 he was transferred to the Crimes Record Office (CRO) at Police Headquarters in the City of Belmopan.

From the CRO he was dispatched to Belize City on promotion to the rank of Sergeant and assigned as a Special Branch Desk Officer at Eastern Division. His next posting was in Dangriga where he took on responsibility as the head of Crimes Investigations Branch. It was whilst in Dangriga that he was first introduced to prosecution duties. It was also whilst in Dangriga

San Antonio Village Labourer Charged For The Attempt Murder Of His Brother

SAN ANTONIO VILLAGE, Cayo District, Sunday, July 11, 2010:

After evading the police for nine days, **Rigoberto Tzib, 22**, a resident of San Antonio Village, wanted on gun related charges, was detained on Tuesday, July 20.

San Ignacio police reports that at around 10:00 p.m. on Sunday, July, 11, **Amir Tzib, 19**, was at his home in the village when his brother Rigoberto Tzib reportedly entered with a silver handgun and pointed it at him.

Amir informed that the hammer from the gun was pulled backwards. He reportedly grabbed onto his brother's right hand in which he was holding the gun and twisted him in a chokehold. A single shot was fired from the gun which hit the floor landing between the feet of his 82 year old father, **Anastacio Tzib**.

Upon hearing the commotion, another brother, **Carlos Tzib**

who lives in the same yard rushed over to assist. They both managed to relieve Rigoberto of the gun. He reportedly ran away and disappeared into the darkness.

The gun was handed over to the father who in turn handed it over to the village **Police Constable #978 Kendis Mortis**. The gun, a chrome Smith & Wesson brand, point 38 special revolver with

serial number CAD 1569 along with two expended casings in the chamber was handed over by PC Mortis to San Ignacio police.

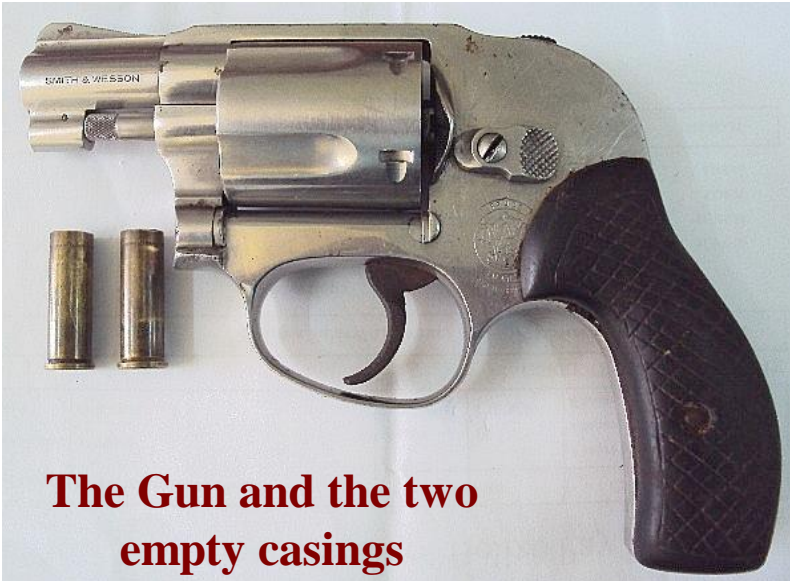
While only one shot was fired that night, police suspect that when the incident occurred the gun was loaded with only 1 live round along with an expended shell in the chamber.

At around 10:30 am on Tuesday, July 20, the

accused Rigoberto Tzib, 22, Belizean laborer of San Antonio Village was escorted into the San Ignacio Police Station by his father, and handed over to the police.

On Wednesday, July 21, he was formally arrested and charged for the attempted murder of his brother, Amir Tzib, and for keeping a firearm without a gun license.

Tzib will be appearing before San Ignacio's Magistrate, **Anna Rachel Montejo**, on Friday, July 23, 2010.

Venezuelan President Hugo Chavez Severs Ties With Colombia

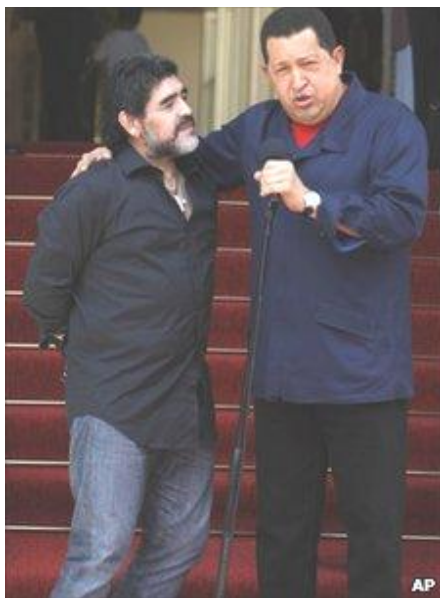
Venezuela has broken off diplomatic relations with Colombia.

In the latest turn for the worse in the strained relations between the two countries, the Venezuelan government ordered Colombian diplomats to leave by Sunday.

President Hugo Chavez said he had “no choice” after Colombia accused Venezuela of being a haven for guerrillas - a charge he denies.

He said that he was acting “out of dignity” in severing ties. He also ordered the military to be on maximum alert on Venezuela’s border with Colombia.

President Chavez made his announcement shortly after a meeting of the Organisation of American States (OAS) in Washington, at which Colombia presented videos, maps and photos to show that Marxist Farc and ELN rebels have bases in



President Hugo Chavez made the announcement as ex-football superstar, Diego Armando Maradona, visited Venezuela.

The Colombian Ambassador to the OAS, Luis Alfonso Hoyos, said the material was clear evidence that some 1,500 Colombian rebels were sheltering at numerous camps inside Venezuela.

Mr Hoyos said the photographs showed that the rebels had 39 camps in

Venezuela and that top guerrilla commanders were resident there.

His Venezuelan counterpart, Roy Chaderton, ridiculed the Colombian evidence, saying that the photos and videos could have been taken anywhere.

Mr Hoyos demanded that Venezuela fulfil its international obligations to fight terrorism and that it allow an international commission to visit suspect sites.

After the meeting, OAS Secretary-General Jose Miguel Insulza told reporters that the regional body could not mount an inspection mission without Venezuela’s consent.

President Chavez did not respond directly to the demand but said the US was using Colombia to undermine his country’s regional integration efforts.

A US official was quoted by AFP news agency as saying Venezuela breaking ties with Colombia was not a “proper way” to raise concerns.

The issue over whether Venezuela has rebels on its territory has dogged ties between the two South American nations for the past eight years.

But the latest exchange plunges bilateral relations to a new low.

The BBC’s Jeremy McDermott in Bogota says it also leaves Juan Manuel Santos, who takes over as Colombia’s president from Alvaro Uribe in two weeks, with a very difficult situation to handle.

Two Legal Guns Turned Illegal Now On The Streets One Illegal Gun Taken Out Of Circulation

In the first instance of a legal gun reported missing, **Sheraina Diaz** of 6 1/2 miles Stann Creek Valley Road visited the police station in Hattieville on Monday, July 19 where she reported that two days earlier, between the hours of 10:00 pm on Friday July 16 and 4:00 pm on Saturday, July 17, her licenced 9mm Glock Pistol with serial number PAG576 along with fifteen 9mm rounds was stolen from out of a friend's vehicle which was parked in the friend's yard at miles 20 on the Western Highway.

In the second reported case, **Anastacio HOARE**, Belizean constructions worker reported that at he was riding his bicycle on Santa Barbara Street, Belize City at around 11:00 am on Monday, July 19, when someone grabbed him from behind, a struggle ensued during which he was relieved of his licensed Smith and Wesson brand pistol bearing serial number UDC-

8405, model #5406 with a magazine containing fifteen 9mm bullets.

Also on Monday, July 19 the police reports the seizure of a gun in southern Belize.

Police reports that at around 4.00pm on Monday, July 19, a team of police officers on anti-drug and illegal firearm and ammunition operations in southern Belize, conducted a search in the village of Cowpen at the residence of **Carmen Duarte**, 50, Guatemalan business-woman. The search led to the discovery of a point 38 Smith and Wesson revolver with serial number BKVJ322, Model 10-9 with six live point 38 rounds of ammunition inside a cartoon box in a bedroom located in the lower flat of the building.

Apart from **Carmen Duarte**, also present at the time of the search were **Rodolfo Duarte**, 24, Belizean self employed, **Elia Ruth Garcia**, 21, Belizean housewife all three of whom


were arrested and jointly charged the offence of "**Kept firearm and**

ammunition without a gun license." Two minors were also present inside the house a the time of the discovery no charge was brought against them.

The Death Of 8 Year Old Marquis Mahler Should Be Enough To Resume Capital Punishment In Belize

When I heard that two men pulled out of a car with one carrying an AK-47 and started to fire shots in a private property killing 48 year old **Calvin Graham** instantly, then



turning the weapon on 8 year old **Marquis Mahler** severely wounding him, I was shocked and appalled at this senseless and brutal murder.

What is the reasoning for any individual to take the life of another human being without justifiable reason? The taking of a person's life brings about severe pain and suffering to the relatives, a pain that they must endure for many, many years.

It is reported that when this child saw this person carrying the weapon he yelled "**Gun Man**" and the man turned his gun on this poor innocent child and shot him like an animal several times.

In its entire history, Belize has never experienced a year like this where almost every day someone is killed on the streets, in their yards and inside their homes in Belize City. Many Belizeans are living in fear because of the amount of people that have been killed so far.

It is now time for the Government

of Belize to remind Belizeans that the punishment for committing murder in the country of Belize, according to the law, is still death by hanging. Despite the fact that a convicted murderer has not been hanged in Belize for many years, this punishment has not changed, it is still on the law books of Belize.

Up until June of this year, when jurisdiction was transferred to the regional Caribbean Court of Justice, for all crimes committed in Belize the final court of appeal was the Privy Council based in London, England. In the Privy Council, convictions were regularly reduced as just this week, (*Channel 5 News for July 21*) we received the report of the murder of **Kirk Gordon** reduced to manslaughter. In this matter, Belize's Supreme Court conviction was upheld by the Court of Appeal only to be overturned by the Privy Council. Convicted murderers are regularly spared the hangman's noose and instead sentenced to life imprisonment.

Many people will say that hanging is cruel and inhumane treatment but, in my opinion, the taking of a person's life for no justifiable reason is also cruel and inhumane punishment to the deceased and to relatives of the deceased.

The punishment starts with an individual's self decision to take the life of a fellow human being for no justifiable reason. We have been spending too many

years concerned about the human rights of criminals and less time focusing on the rights of victims and law abiding citizens.

The failure of our government to make an open declaration that as of now they will do whatever is necessary to ensure that these individuals are swiftly brought to justice and on conviction be dealt with in accordance with the laws of Belize.

Belizeans are becoming so disgusted with the on-going dilemma that one family recently indicated, that they are going to take the laws into their own hands in looking for the culprits and kill them. Before we reach the point of vigilante justice where Belizeans start to take the laws into their own hands, our government needs to reassure the general public that they have the crime situation under control and with little more patience the measures that they have put in place will soon bring about positive results.

Many Belizeans are beginning to believe that the government has lost control to the criminal elements especially those operating in Belize City.

Guns are coming into Belize in large numbers and we need to find out who are bringing in these guns. Minimizing the inflow of guns into Belize from neighbouring countries like Guatemala, Honduras, El Salvador, the United States and other countries in the region, should now be a top priority.

I have said in previous articles that if our government does not find a way to end this madness, criminals will soon begin to target members of our government and other high ranking officials. Government should not wait for this situation to get further out of control as it will demonstrate a clear failure in its fundamental responsibility for the national security of its people. A perpetuation of this trend will lead to the electorate losing confidence in the government ultimately resulting in replacing that failed administration.

The government of Belize recently outlined several new initiatives to deal with the reduction of crime in its "**Restore Belize**" project but instead of the violence decreasing it seems to be escalating. Granted that it normally takes some time to see if new policies are working after they are implemented, I just hope and pray that time does not run out on this government.

The crime problem is not only taking a human toll on our country but it is also costing the nation financially as tourist arrivals are decreasing.

We need to restore Belize's image to the secure, peaceful and friendly splendour it once boasted, a peaceful tranquil haven of democracy where visitors from every single corner of the globe can move freely and interact with the local populace without falling victims of crimes.

We cannot afford to give in to this small cluster of antisocial and lawless individuals because once we surrender, our country will be lost forever. "**Restore Belize And Restore It Now**".

Petters Research Institute Lecturer At Galen Univeristy

GALEN UNIVERSITY, Central Farm,Cayo.July 20, 2010:

Galen University was pleased to host a lecture by **Dr. Marcus Werner** on the mathematics and astronomy of the Maya on the ocassion of a lecture held on Galen Unversity campus on Saturday, July 17.

The attendees were welcomed by **Dr. Aaron Lewis** and **Dr. Arlie Petters**, who encouraged students to study the fields of math and science.

Dr. Filiberto Penados introduced Dr. Werner and brought the focus specifically to the ancient and contemporary Maya culture.

Dr. Werner, a mathematical physicist, educated at Cambridge University in the United Kingdom, teaches at Duke University in Durham, North Carolina, USA, with Dr. Petters.

His passion and respect for ancient Maya achievements in math and astronomy were very evident in his lecture.

Dr. Werner's lecture covered the variety of calendars of



the Maya and their amazing astronomical records, specifically in the Dresden Codex.


He focused on the Long Count calendar and how to translate dates in Maya numbers to the contemporary western calendar.

The example he shared with the audience was from a stela found at Ixkun, which shows the date of December 21, 2012, the end date of the current Maya epic.

This particular measure of time for the Maya lasts 5,125

years and began in August, 3114 B.C.

Dr. Werner then discussed the cycle of the planet Venus as it was recorded in the Dresden Codex, showing glyphs and numbers from the ancient Maya book.

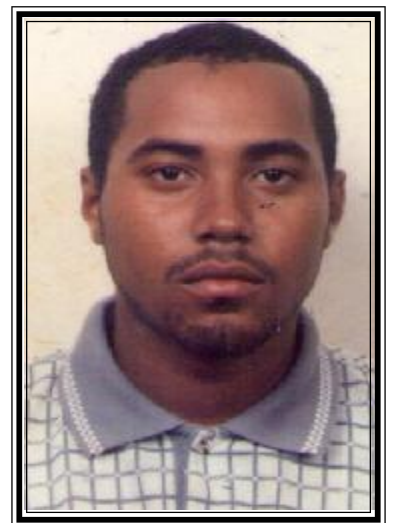

A Fake Special Constable Exposed, Arrested, Charged And Sent To Jail

we must admit that we were among those misled. We spotted him one weekday morning, about two months ago, in full police uniform on Albert Street in Belize City and we felt a sense of pride to see the Santa Elena youth rising from among a set of troubled twin brothers, joining the ranks of a "disciplined", uniform institution like the Belize Police Department.

Our sense of pride came tumbling down like a deck of cards when the story broke on Monday evening's television newscasts amidst official police statements that Wilson was in no way, shape or form ever appointed as a police special constable much less as a regular element of the Department.

The newspaper business requires frequent interactions with the police and so we make regular, almost daily, trips to the San Ignacio Police Station where we regularly saw Aaron Wilson and so we erroneously

assumed that he was an element in the San Ignacio Special Police Constabulary.

Our investigation revealed that his application to serve as a special constable was rejected and that he was employed as a security guard at a nightclub in the Savannah Area of San Ignacio Town.

Investigations further revealed that he was reportedly friendly with a police constable who was stationed in San Ignacio. His friendship with the constable resulted in frequent visits to the San Ignacio Police Station while this constable was on duty thereby creating the perception that he was a member of the San Ignacio Special Constabulary.

According to one media report, Aaron Wilson was identified with regulation #737 which incidentally is the regulation number legally assigned to his friend, the genuine **PC Saren Choc**, who was transferred from San Ignacio and is currently attached to the Intermediate Southern Formation (ISF) in

that he got the first opportunity to act as the formation's Deputy Commanding Officer during the absence, on vacation leave, of the substantive holder of that post.

In 2003 he was transferred, on promotion as an Inspector, to serve as the Commanding Officer, of the newly created Crimes Intelligence Unit (CIU) at Eastern Division in Belize City. Whilst at Eastern Division he also served as the Deputy Commander of Patrol Branch and as Officer Commanding Eastern Division's Crimes Intelligence Branch where he remained for almost three years. While still in Belize City he was promoted to Assistant

Superintendent of Police on January 1, 2005 and a few months later to Superintendent of Police. With the accelerated promotions came added responsibility and so as a senior officer he was called upon to serve as the Deputy Commander of the division during the period of the absence, on vacation leave, of the Divisional Commanding Officer, **Allen Whyllie**. In his capacity as Deputy OC ED he was promoted to the current rank of Senior Superintendent of Police on June 1, 2007.

His rapid promotions, created quite a stir within the department as within a four year period, between 2003 and 2007, he received four consecutive

promotions climbing the ranks from an Inspector to an Assistant Superintendent, Superintendent and finally to Sr. Superintendent. He now sits just three ranks short of the top seat in the department with another 20 left before reaching the mandatory retirement age of 55.

Apart from Assistant Commissioner of Police **Elodio Aragon Jr.** who is 36 years of age, Sr. Supt. Williams is the youngest high ranking police officer in the department.

In 2008, amidst some controversy, he was transferred to police Headquarters in the City of Belmopan in the capacity of Director of Training the post he currently holds as he prepares to take over command of the Cayo (Police) District.

We had a chance today to sit down with Sr. Supt. Chester Williams for a brief interview at the San Ignacio police station. In response to a question about his vision for the district Mr. Williams informed that he intends to build on the foundation of the good relationship with the business community and the populace as a whole, established by the outgoing Commanding Officer, **Assistant Commissioner of Police Paul Wade**.

"I intend to strengthen the police community relationship as it is only with fostering good relationships with the community that the police will be able to operate effectively. The welfare of the officers under my command will also be a top priority because at the end of the day their state of mind will determine the level of their production. I will also be looking at issues as it relates to traffic offenses as I am a firm believer in the broken window theory whereby small offences, if left unattended, eventually evolve into bigger things. I will not only be focusing on the San Ignacio/Santa Elena's theater of operations but as the district commander I will liaison very closely with other district formation sub-commanders in Benque Viejo and in the City of Belmopan which both currently falls under the jurisdiction of the Cayo (Police) District with

the primary objective of concentrating all of our efforts in the task of reducing crime and violence within the district. Coming from the directorate of training, I am a firm believer in this aspect of human development and as such it is by intention to provide the personnel under my command with training in all aspects of policing to develop their skills and knowledge thereby enhancing their level of professionalism and the effective execution of their duties. It is my intention also to foster a good working relationship with all media with a view to market the good works of the police as time and time again we have seen where the media is primarily focused on highlighting only the bad side of the police oftentimes neglecting to report on the hard work and good deeds of the police. As a department we are constantly criticized for various reasons, some of these criticisms are justified and can be considered necessary to guide us in the right direction. I will endeavor not to take criticism negatively but rather to use it to make positive changes in the way we do things for the betterment of the community we serve. Notwithstanding as human beings police officers are fallible but as professionals, we must endeavor at all times to minimize the amount of mistakes we make. I am looking forward to this new challenge with an open mind and with regards always for the human and constitutional rights of the people we are sworn to serve and protect."

We take this opportunity to welcome Sr. Supt. Chester Williams to San Ignacio/Santa Elena and to wish him all the very best in the challenging task ahead while simultaneously wishing the outgoing Commander, Assistant Commissioner of Police, Paul Wade, all the very best as he moves on to a more senior position within the department.

It was indeed a pleasure working with **ACP Paul Wade**. We hope to continue the same cordial relationship with **Sr. Supt. Chester Williams** as we move forward to doing our part in making the community a safer place to live.

A Fake Special Constable Exposed, Arrested, Charged And Sent To Jail

Independence Village, Stann Creek District.

The accused is reported to have applied and sat the recent police entry examination and would have been a part of the current police recruit squad in training if not for a harm conviction that came to light during the vetting process.

In 2009 he was arrested for handling stolen good when some stolen jewelry, belonging to a relative, was found in his possession. With the recovery of the missing jewelry, the charge was later withdrawn at the request of his relative, the virtual complainant.

On February 28 of the current year, a female American student visited the San Ignacio Police Station and reported that whilst socializing at the Faya Wata nightclub on Burns Avenue in San Ignacio Town, her bag containing a digital camera, a cellular telephone, \$150 in cash and her cash cards, for a total value of \$650, was stolen. Police investigations led to the arrest of Aaron Wilson on a theft charge as he reportedly attempted to use the victim's cash card at two Chinese stores. He appeared in San Ignacio's Magistrate court on March 3, where he pled guilty to the charge and was fined \$800 to be paid by March 31. He made an initial \$400 payment and when he failed to pay the remainder of the fine by the stipulated date, a commitment warrant was issued for his arrest. He was picked up on the commitment warrant and was released after the outstanding balance was paid.

The senior ranks of the Police Department are still baffled as to how this individual could have been bogusly operating in Belize City for such a long time especially amidst allegation that he signed for and was issued police regulation firearms on several occasions. While he has chosen to remain silent thus far, indications are that a few senior elements within the department are not sleeping well since the cover of this bogus cop was blown last Friday.

The deceptive lifestyle of the

accused began to unfold last Friday evening, July 17 when Belize City resident, **Shannon Martinez**, 19, visited the police station in Belize City and reported that she was at the BTL Park in the Newtown Barracks area when the accused, who was dressed in police uniform, in a private vehicle, offered her a ride. She said she accepted the offer and directed him to the house of a friend, **Malcolm Vasquez**, located at #5581 Princess Margaret Drive.

Martinez reported that upon arrival she got into an argument with Vasquez and that the accused threatened to shoot Vasquez. She told the police that after the incident she requested for the accused to take her to her nearby Baymen Avenue residence. However, according to Police Press Officer, **Sgt. Fitzroy Yearwood**, instead of complying with Shannon Martinez' request, the accused reportedly proceeded towards the Belize City Municipal Airstrip where he allegedly indecently assaulted her.

After refusing his advances and realizing that he was not getting anywhere, the accused reportedly dropped her off at her Baymen Avenue residence. When she exited the vehicle she reportedly realized that her cellular telephone was left in the vehicle and before he moved off she reportedly asked to search the vehicle for the telephone. He reportedly refused the request and instead sped off. She used another telephone and dialed the police emergency hotline at 911. Within minutes Crime Investigation Branch personnel responded to the scene and transported the victim to the police station where an official report was made and a statement recorded. Shortly thereafter Aaron Adony Wilson was detained, still clad in the police uniform, and transported to the police station where he was instantly identified by the complainant. When searched he was found to be in possession of a police identification card which turned out to be bogus.

Since the arrest, several allegations of impropriety have surfaced against the accused. In one of the reported cases, he is

said to have misled officials from the Belize City Traffic Department where he successfully applied for and was issued a drivers' license. While the issuance of Belize City drivers' licenses is restricted to city residents, the process requires for the applicant to produce a utility bill in the applicant's name at a Belize City address. In the absence of this document, Wilson reportedly presented a correspondence, on what appeared to be official police stationery and purportedly signed by "**Linden Flowers Supt Officer Commanding Patrol Branch**". Among other things the correspondence introduced him as **Police Constable #406 Aaron Wilson** recently transferred from Cayo "**to the Headquarter at Raccoon Street**" and that he is residing with his girlfriend at #24 Frederick Street, Belize City. Interestingly however, police regulation #406 is actually assigned to **Police Constable Alejandro Rodriguez**, who is currently on vacation but attached to the Joint Intelligence Coordinating Center (**JICC**) at Police Headquarters in the City of Belmopan.

As the house of cards continues to crumble around the accused, another allegation surfaced, this time from **Jermyn Galvez**, the younger brother of the late **Christopher Galvez** who was murdered in December 2009 amidst allegations of police involvement.

According to the younger Galvez, the incident took place during the early morning hours on Friday, June 18 while he and his girlfriend along with friends were out on the town celebrating the Lakers' NBA championship victory.

Galvez alleges that while partying, at Thirsty Thursday, a popular nightspot in Newtown Barracks Belize City, the group got into an altercation with Wilson as he reportedly accused Galvez of throwing a drink at him. Galvez further alleges that in the course of the incident, the accused, who he thought was a genuine policeman, fired two shots at him, the first over his head and the next at his feet.

Friday night's report by Shannon Martinez led to the arrest of **Aaron Adony Wilson**, 20, on the following six charges:

1) *Forging an official document*, 2) *Possession of a false official document*, 3) *Unlawful possession of Police Department accoutrements*, 4) *Theft* 5) *Aggravated assault of an indecent nature* and 6) *threatening words*.

He appeared before Chief Magistrate **Margaret Gabb-McKenzie**, on Monday, July 19, where the first two charges were read to him, no pleas was entertained as Magistrate McKenzie informed that both charges will be heard on indictment in the Supreme Court. He then proceeded to plea not guilty on the other four charges after they were individually read to him.

Base on allegations of threats to the complainants, combined with the general seriousness of the allegations regarding the use of police uniform to commit crimes, Magistrate McKenzie informed the accused that she will not be granting bail and ordered that he be remanded to the central prison in Hattieville and be brought back court as early as Monday, July 26.

As a point of interest, today, almost one week later, the daily police bulletin is yet to make a single mention of this incident.

While he was at it, and as the magnitude of the fraud continues to unfold, one is left to wonder how much longer it would have taken the accused to come up with an "*official*" removal order and personally visit the central prison in Hattieville to secure the release of his brother, **Roland Wilson**, who is on remand in connection with the January 3, 2010 murder of San Ignacio resident, **Belizario Eck Jr.**

Officer Commanding Eastern (**Police**) Division, **Assistant Commissioner of Police David Henderson**, is reported to be proceeding with further investigations to determine the possibility of the involvement of the accused in other reported burglaries within the jurisdiction.

The leadership of the Police Department should heed suggestions from several concerned citizens, as expressed over the various morning radio talk shows, to seriously re-evaluate and re-assess the Special Constabulary Program with a view to avoid a recurrence of another such incident.
