# LOTTERY VENDOR SURVIVES ANOTHER ATTACK

SAN IGNACIO TOWN, Cayo District, Friday, August 20, 2010:

A male youth from the village of Georgeville, Cayo, will today be appearing in San Ignacio's Magistrate Court charged with two counts of violence in the latest of at least seven prior attacks committed against a popular Santa Elena, boledo/lottery vendor.

Police reports that at around 5:30 p.m. on Friday, August 13, 2010, Santa Elena veteran boledo/lottery vendor, **Godfrey Tillett**, 65, was on his regular run in the village of Georgeville when the incident occurred.

In a statement to the police Tillett informed that he was returning to his motorcycle parked on the side of the road as he was returning after transacting business with a regular customer residing about 500 meters on the Mountain Pine Ridge Road from its junction with the Western Highway.

Tillett told the police that as he was approaching his motorcycle, he saw a tall male person emerging from the bushes across the road with a gray piece of cloth partially covering his

face. Tillett informed that the person was carrying a large stick and rushing towards him with the stick raided. In the process of attempting to flee, Tillett reportedly tripped on the stand of the motorcycle and fell to the ground. The attacker reportedly stood over him and began beating him with the stick in the head and on his left hand which he was using to shield his head. With the defenseless and bleeding victim on the ground

the attacker reportedly pushed his hand into the front right pocket of his pants removing and taking possession of all the cash therein reportedly amounting to over \$600 after which he fled the scene.

While the severely injured Tillett could only identify the person as being of dark complexion due his exposed hands, the attacker was recognized by witnesses as one "Sootz" a resident of the village. Swift

police action later led to the detention of **Sherwin** "Sootz" **Dominguez**, 19, Belizean, laborer.

Tillett was taken to the San Ignacio Hospital where he was treated for injuries to the head and left arm. He is reported to have left the hospital with almost 30 stitches to the head. He is said to have been lucky to have survived the attack. He is now recuperating at him home in the

# **Old Meat Market Transformed Into Modern Library/Resource Center**

It gives us pleasure to report that residents of San Ignacio/Santa Elena and surrounding communities especially students, avid readers and researchers will soon be enjoying the spacious, modernized and new facilities of a library.

The Government of Belize funded project, executed by the Social Investment Fund, began a few months ago with the complete restoration of that deteriorating facility which for many years served as the community meat market.

Realizing that the era of public meat markets has long disappeared

Tillett has evidently become easy prey for robbers in the area as this latest incident is said to be the eighth one. Prior to this latest incident, he was robbed less than five months ago, when around 9:00 a.m. on Sunday, March 21, 2010 in Esperanza Village he was reportedly approached by a male person who pointed a handgun at his head demanding the black bag he was carrying. In this instance, he was relieved of \$300 in cash and four lottery books.

The incident led to the arrest, on a single conspiracy to commit robbery charge, of Joseph Gentle, 23, Belizean, laborer, residing in Esperanza Village. This matter is still pending in San Ignacio's Magistrate court.

Prior to the Esperanza incident on December 19, 2009 at around



6:30 p.m., he was reportedly attacked in Georgeville Village by two masked male persons dressed in dark clothing, both carrying firearms. He was relieved of the knapsack he carried containing 5 lottery and 2 jackpot books along with almost \$1500 in cash. Police later recovered the knapsack along with the 7 boledo/lottery books, about \$14 in coins and other personal belongings inside a house on a nearby citrus farm in Georgeville village. No one was inside the house at the time of the search. However, police also reported the discovery of a homemade chrome contraption bandaged with electrical tape which according to the police was designed to discharge 16 gauge cartridges. No arrest was made as the search was focused on a Guatemalan who according to the police is being sought in relation to similar incidents.

in the advent of several such privately owned business places within the community, the San Ignacio Town Council sought and received approval from Central Government for a complete remodeling of the building to house a new library/resource center as the present library situated downstairs of the Town Hall has long outgrown the allotted space.

According to the project contractor, Oscar Martinez, the

construction is on target with the handing over of the furnished facility set for the end of this month or early September at the latest.

# **Public Utilities Commission (PUC)**

The Public Utilities Commission (PUC) in its commitment to ensure public safety hereby advises the General Public that according to the **Electricity** (Licensing of Wiremen) Regulations:

- (1) No person shall perform any electrical work whatsoever unless that person is a holder of a valid wireman license issued by the PUC.
- (2) No person shall hire or engage any person who is not a licensed wireman to do any electrical work on their behalf or on their premises.
- (3) Any violation of the preceding is a punishable offence and may result in a fine of up to two thousand dollars and/or imprisonment of up to six months.

The PUC reminds all licensed wiremen that they are authorized to engage in electrical work only in the category for which they are licensed.

Now in its 7th year, teachers from the Edmonton area of Canada are back in Belize, instructing our school teachers on advanced learning strategies in Math, Science and Language Arts. From the early days when this programme was only offered in San Ignacio, it has expanded to include primary and high school teachers countrywide. Even school principals and members of the Department of Education staff are attending interesting and stimulating seminars in all districts of Belize. This Rotary project, initiated and directed through the Rotary Club of San Ignacio is the largest Rotary project ever undertaken in our country and involves every Rotary Club in Belize.

This project was developed by Rotarian and Chief Education Officer Chris Aird and Rotarian André Lopez in conjunction with Rotarians from Edmonton, Canada ,who applied for and received a large Grant from the Rotary Foundation which has now been supplemented by a grant from the Candia International Development Agency (CIDA). This huge nation-

wide project is managed in Belize by a committee of Rotarians, three from San Ignacio; André Lopez (Committee Chairman), Dr. Eve Aird and Chris Aird; and the following Rotarians from Belize City; Salvador Espat, Paul Hunt, Dr. Marcelo Coyi and Saira Mahibar.


Currently there is a team of 30 Canadian teachers from Canada, led by Rotarian Jennifer Lawly and her assistant Rotarian Dr. Lynne Paradis who have given up some of their holidays to come to Belize for two weeks to work with our teachers. Some of the workshops include Leadership training for Principals, and continuing workshops in Math, Science and Language Arts. During a second week of workshops 157 Belizean

teachers (Learning Coaches) who have been trained in these disciplines in previous years are now conducting workshops in the three disciplines already mentioned for their Belizean colleagues.

Additionally, this year a special Computer Learning class is being held at Faith Nazarene Primary in San Ignacio for teachers from Mary Hill R.C. school in Corozal; Louisiana Government in Orange Walk; Salvation Army in Belize City; Christ the King in Dangriga; and St. Peter Claver in Punta Gorda. Each of these six schools have been equipped, by Rotary and the BNE Trust, with a special computer lab containing 32 computers each, where the children of Standard Two and Standard Five classes will be doing much of their classroom computer work starting in September. Much of this work in developing computer labs for this project would not have been possible without the generous support of **BTL** who has donated t 2.5 megs of band width to each school.

Within the next three years it is hoped that every school that has internet access will be able to utilize computer learning for every Standard in the Primary education system.



# Possession Of His LICENSED Gun Whilst Under The Influence Of Alcohol Lands Cuban Man In Jail

SAN IGNACIO TOWN, Cayo District, Monday, August 16, 2010:

A Cuban man was today remanded to the Hattieville Prison after he was found in possession of his licensed 9 millimeter pistol whilst sitting at the bar inside a San Ignacio Nightclub reportedly intoxicated.

Acting upon information received, members of the San Ignacio police Quick Response Team (QRT), at around 11:30 pm on Saturday, August 14, visited the Legends 2000 Night Club located on Bullet Tree Road in San Ignacio Town, where they conducted a search on a male person of Hispanic descent sitting and drinking at the bar. The search led to the discovery of a chrome and black, Smith & Wesson brand, Model # 5906, 9 mm pistol, with a magazine containing 9 live rounds in a holster tucked in the back of his pants waist.

He was transported along with the gun to the San Ignacio police station where he was identified as **Ibey Miguel Cardinas**, 43, Cuban labourer, residing in the Bella Vista Area of San Ignacio Town. At the station he provided genuine documentation of being the owner of the licensed gun.

Police suspected that he was under the influence of alcohol but their effort to get medical confirmation was thwarted by the detainee's refusal to provide the blood or urine sample necessary for clinical testing.

The defendant was subsequently arrested and charged for possession of a firearm whilst under the influence of alcohol and for failure to provide specimen.

He appeared in San Ignacio's Magistrate court on Monday, August 16 where he pleaded not guilty to both charges. Since the case involved a gun, no bail could be offered and so he was remanded to Central Prison in Hattieville for a month. He will be brought back to court on Wednesday, September 15, 2010.

come to Los Angeles in order to be with his fellow Belizean brothers and sisters. Again at the conclusion of the event there was a meet and greet and photo opts.

Before the night of the gala event word was going around that all the 350 tickets for the banquet were sold out. The organizers of the event which included; Ambassador H.E. Nestor Mendez; Counsel General Hon. Roland Yoke and the Belizean Committee were all preparing an alternative plan to accommodate more Belizeans.

The gala event was ram jammed packed to capacity with surplus attendees settling for adjacent accommodations.

It was indeed a fun filled event with Belizeans were getting down Belizean style with their Prime Minister and one person started shouting; I want some "PUNTER" meaning "PUNTA". Belizeans were laughing because, despite the wrong pronunciation, they knew exactly what kind of music the person was asking for.

On Sunday evening Belizeans lined up to go through security checks to attend the Town Hall Meeting at the Recreation Center in the park.

The Hon. Roland Yorke was the Masters of Ceremony for the Town Hall meeting. After acknowledging the presence of dignitaries in attendance, he thanked the Belizean audience for attending the meeting and all the events that were held over the weekend.

In his presentation, Prime Minister Barrow informed of the state of affairs when his United Democratic Party took over the reigns of government from the People's United Party in February 2008. He highlights many of the positive accomplishments of his administration. He also spoke about the challenges that still lie ahead. In is trademark upbeat style, the Prime Minister indicated that despite the obstacles, the future looks good for Belize and things are beginning to look better. He informed that his government is expending major efforts in tackling the crime situation and he expects to see favourable results very soon.

During the Town Hall meeting, more Belizeans were coming but the place was too small so another meeting was arranged.

At the end of the Prime Minister's State of Belize Address, questions from the audience were mostly about acquiring lands in Belize and

the problems regarding Belizean Americans losing their land while are residing in the United States.

Other questions centred around the right of Belizeans living abroad to vote in Belize elections. The Prime Minister said that he is in favour of it but that the legislative framework and mechanism must be put into place.

Prime Barrow informed the gathering that the Dual Citizenship portion of the 7th amendment to the Constitution is currently on hold. He told the audience that there are plans to reintroduce the proposed amendment into the House of Representatives for debate and possible passage into law.

Belizeans who possess Dual Citizenships must become proactive

to assist the Prime Minister in making sure that this amendment is passed into law the next time around. Once this amendment is passed, the Government of Belize will have a constitutional obligation to Belizeans with Dual Citizenships that must be backed up by subsequent legislation and programs.

Highlights of all the events were carried

live via the air waves of Belize's leading radio station, Love FM, thereby affording Belizeans at home the opportunity to be a part of the even. Love FM's Chief, **Rene Villanueva** and his cameraman, **Harlem Wagner** were busy conducting interviews with Belizean Americans.

The event provide an excellent opportunity for Belizean in Los Angeles to interact with their Prime Minister and to get first hand information regarding his view on important issues.

The Prime Minister eloquently espoused his position on the major issues. It is now left to us as Belizean Americans to take him up ensure that he delivers on his promises.


