

YOUTH ON BAIL SERIOUSLY WOUNDED

SAN IGNACIO TOWN, Cayo District, Friday, November 26, 2010:

Two male youths from Cayo are today recuperating at the Western Regional Hospital in the City of Belmopan, from wounds sustained in separate incidents, within an hour of each other, on Tuesday, November 23, 2010.

In the first incident police reportedly responded to a stabbing incident, at around 7:30 pm in the village of Bullet Tree falls. Upon arrival police encountered a male person bleeding from a stab wound to the abdomen. The injured person was identified as **Nervin Tesecum**, 21, Belizean Student

attending the Cayo Center for Employment Training in San Ignacio.

Preliminary investigation revealed that a few minutes earlier Tesecum visited a house in the village and requested from the mother to see her 16 year old daughter who is also a student. The mother reportedly refused the request. She told the police that upon refusing the request and ordering Tesecum to leave her premises, she saw him reaching into the front pocket of his pants, pulling out a pocket knife, flipping out the blade and stabbing himself in the abdomen.

The injured and bleeding youth fell to the ground and the mother rushed over to the nearby

police substation in the village and reported the incident. The message was immediately relayed to the head station in San Ignacio.

The injured youth was first transported to the Community Hospital in San Ignacio where he received emergency treatment after which he was rushed by ambulance to the Western Regional Hospital in the City of Belmopan where he remains hospitalized in a stable condition.

In the second incident, police rushed to the Sabido Layout area, just off the road leading

We record the passing of **Ellis Leonard Copias better known as Rodman**, 41, who passed away quietly at his Carmen Street, Santa Elena Town residence on Wednesday, November 24, just five days short of his 42th birthday on November 29, 2010.


A close member of the family informed that, about two weeks ago, Rodman began complaining about not feeling well and since then he would spend a day or two undergoing treatment at the San Ignacio Community Hospital where he was known for frequent self discharges.

The last time he walked out of the hospital was shortly after

5:00 pm on Wednesday. He boarded a taxi for the ride to his home on Carmen Street in Santa Elena. He reportedly entered the house and took to the floor in the small living room. About half an hour later he was dead.

The police were called and the body was transported to the same hospital from which he walked out less than an hour

YOUTH ON BAIL SERIOUSLY WOUNDED

to the village of Bullet Tree Falls, in San Ignacio town where they came upon a male person bleeding profusely from a large cut wound across the lower section of the abdomen with his intestines protruding from the wound.

The injured youth was identified as **Trevor Lamb**, 20, Belizean Laborer of a 2nd Street, San Ignacio Town address. While a motive is yet to be determined, the investigation has thus far revealed that Lamb was hanging out in the area of a bridge leading to the nearby Bishop Martin, Roman Catholic Primary school when he got into a misunderstanding with another male person who reportedly inflicted the wound before quickly departing the scene.

The victim, intestines in hand, staggered into a nearby house where, the home owner quickly called the police and the fire station after which he told the youth to rest on his back on the sidewalk until assistance arrived. While waiting for assistance the victim reportedly told the man that if he should die, to tell his mother that (*he gave a name*) was the person who injured him.

The police arrived shortly thereafter and transported the victim to the nearby hospital in San Ignacio Town where he received emergency medical attention after which a second ambulance sped out of the

hospital compound on its way to the Western Regional Hospital in the City of Belmopan.

Police subsequently conducted a search of the scene of the incident where they found a point 38 Special, revolver, Ruger Brand, model number SP101, serial number 570-27657 with one live round of ammunition in the chamber. The investigation revealed that the gun has never been license in Belize thereby leading investigators to suspect that it could quiet possibly have its origin across the western border in Guatemala.

In the event that the name and photograph sound and look familiar that’s because **Trevor Lamb** is currently on bail along with **Adrian Arzu**, 33, on joint charges of abetment to commit murder, abetment to commit attempt murder and keeping unlicensed firearm in connection with the June 13 murder of **Alfredo Rivera Archilla** and the attempt murder of **Dean Dougall** which occurred in the center of downtown San Ignacio

on a rather busy early Sunday morning as nightclubs were letting patrons out at the close of business. The murder/attempt murder weapon was retrieved a few days later from inside a garbage drum that was on the San Ignacio bank of the Macal River where it was allegedly discarded by Lamb and was found to be a point three eighty Lorcin brand pistol with the serial number filed off.

Some Police Officers And Public Officers Are Corrupt And Cannot Be Trusted

When members of the Belize Police Force and the Public Service are corrupt, the public will lose trust and confidence in the incumbent government.

Ministers of Government, Police Officers and other public officials are hired by the Government and paid with tax dollars to enforce the laws, rules and regulations of our country with integrity and trust.

They are paid to carry out such duties without additional reward or monies also known as bribes.

If a Minister of Government,

Police Officer or other Public Official solicit from any citizen any money or any other forms of reward for the performance of their duties, that individual could be charged for Corruption or Extortion.

When any form of pressure or duress is used by these individuals to obtain rewards, the crime becomes more serious and it is called Extortion.

These crimes are clearly defined in the Criminal Laws of Belize.

It is therefore for the various Governmental Departments to use these existing laws for the institution of criminal proceedings against accused corrupt employees.

Even though most Belizeans are aware of the laws of the land, they tend to ignore these laws thereby perpetuating this corruption culture.

Studies conducted over the years on this topic indicate that the lower the wages Civil

Servants earn, the more vulnerable they are become engaged in crimes of corruption and extortion.

Sometimes, it is even more difficult to distinguish the difference between a reward and a bribe. Bribery is always seen as a form of corruption because in most cases it is used as the trigger to initiate the act of corruption. However, rewards are always given by people to show appreciation for doing something for them. Giving a person constant rewards over a period of time will arouse suspicion and could be deemed as bribery.

In Belize the Police Force is governed by the Police Ordinance Chapter 59 of the laws of Belize. This ordinance governs all rules and regulations pertaining to the conduct of Police Officers in performing their duties.

As a former Police Officer, I am very familiar with this ordinance and, in order to maintain discipline within the ranks, I used it on several occasions against offending Police Officers.

Most recently some members of the Police Force were caught at a place and at a time where they were not supposed to be. They now stand under suspicion of aiding and abetting in the landing of an aircraft in Belizean territory without lawful permission for the purposes of transporting illegal drugs through Belize. These are serious allegations that will involve extensive investigations over a period of time. The Government of Belize will be interested in knowing when this activity began? Who are the people initiating this activity and in what capacity of the Belize Government do they serve? Are they serving the Belizean Government at the Ministerial level? Do they have access to sensitive/classified information and thereby making subordinates afraid to cooperate with the investigation for fear of retaliation?

The US Drug Enforcement Agency (D.E.A.) and the Federal Bureau of Investigations (F.B.I.) will be involved in this investigation and they will

do their best to gather all the information they can.

From what I have been hearing, these activities have been taking place for a long time now.

One lingering question is if these activities were known and tolerated by the previous government during their ten year term in office?

This is an important question because there is at least one serious, maybe even credible, allegations of the involvement of high ranking Ministers from the previous government involved in these types of illegal activities.

We can even ask a bigger question which is: How instrumental are criminals and drug dealers, in financing campaigns for political parties in Belize, the Caribbean and Latin America?

No one is giving any person or group large amount of money without expecting something in return.

Last year I wrote an article in the Caribbean Net News about the conduct of Police Officers in the wake of a series of bank robberies taking place in Belize.

The Prime Minister and his Police Minister must be very careful of armed rogues parading as law enforcement officials.

The ensuing investigation in the wake of this recent cocaine seizure is said to be just a tip of the Iceberg. The coming weeks should provide more revealing information that could shock many of us. If those that are being investigated are within the organization, they will do everything in their capacity to undermine the investigation or destroy the evidence.

Some people, because of greed, will stop at nothing to engage in these illicit activities to further self enrichment.

In an effort to get to the very bottom of this dangerous activity and to attack corruption at its very root, the Government of Belize is best advised to conduct an intensive investigation with external technical assistance, if required, from the Government of the United States Government to bring all criminals involved to justice. This should, at the very least, serve to send a strong message to all those with criminal intent.

Three Police Sergeants, Two Corporals And A Customs Boatman Suspected Connection With A Major Cocaine Trafficking Enterprise

ORANGE WALK TOWN, Monday, November 22, 2010:

While the bulk of the 80 bales of Colombian cocaine, was destroyed by fire inside twin furnaces at the Tower Hill Sugar Cane Factory on the southern outskirts of Orange Walk Town on Monday, November 22, all six law enforcement officers, including five policemen and a customs Department boatman, remain on remand at the central prison in Hattieville as investigation continues with a view of uncovering evidence that could link them to the shipment of cocaine.

Police reports indicate that based on information received from public sources regarding the sound and spotting of a low flying aircraft in the vicinity of Bladen Village, at around 2:00 am on Saturday, November 13, a team of policemen from the Intermediate Southern Formation (ISF), as first responders with assistance from the Belize Special Assignment Group (BSAG), intercepted a white van in the area of the San Juan bus stop as they were leaving the area.

The driver of the van was identified as corporal of police, **Renel Grant**. The occupants were detained and escorted to the police station in Independence Village. They were identified as:

(1) **Sergeant Jacinto Roches**, 42, residing at #22 Tangerine Street, Belmopan. He is currently attached to the Internal Affairs Department (IAD) at National Police Headquarters, Belmopan;

(2) **Sergeant Vidal Cajun**, 46, from the Intermediate Southern Formation, in the Village of Independence, Stann Creek District where he also resides;

(3) **Sergeant Lawrence Humes**, 38, residing in the City of Belmopan;

(4) **Corporal Renel Grant**, 33, of a Libertad Village, Corozal District address, presently attached to Eastern Division's Traffic Department in Belize City;

(5) **Corporal Nelson Middleton**, 39, residing in Camalote Village, Cayo District, the assigned police driver for the Governor General and

(6) **Customs Boatman, Harold Usher**, 36, of a Finca Solana address in Corozal, a former policeman who was once attached to the Police Anti Drug Unit (ADU) before moving over to the Customs Department.

When the van was searched it was found to contain items of Belize Police Anti Drug unit kit including muddy boots and uniform. Also found were Atlas brand vehicle batteries, food stuff,



driver of the white van

tennis shoes and a licensed 9mm pistol in the name of the Customs Boatman, **Harold Usher**.

Further down the Southern Highway, between miles 56 and 57, the team came upon a white Super King Air 200, twin engine, 300-FA 137 beechcraft plane with tail number N786B, parked smack in the middle of the highway.

An inspection of the aircraft revealed that the tip of the left wing was damaged apparently from making contact with a small pine tree growing on the shoulder of the highway.

On the scene police found an additional Atlas brand 12 volts vehicle battery along with two lengths of boards, one on each sided of the highway, to which three lights each were attached.

This apparatus is suspected to have been used as makeshift landing lights.

Further checks between miles 59 and 60 led to a small white container truck with VIN# JDAMEO8J2RGF75162 that contained (23) 17-gallons plastic containers, (3) tank with about 500 gallons of aviation fuel and 3 fuel pumps. Also found were a total of 12 pine logs.

Searches by the police in the Hicatee Area about 5-10 yards inside some bushes led to the discovery of a GPS Garmin brand, a Iridium Satellite phone, four Hand Held radios, two RAYOVAC Flashlights, one Colt .223 semi-automatic rifle with Sr. No. 007865 with a magazine containing 5.56 rounds and two pairs of camouflage

jackets.

Fifteen hours after the initial low flying aircraft report was received; at around 5:00 pm the search ended in a road at mile 65, (*over 8 miles from the aircraft*), near the Genus Saw Mill, where about ¼ mile into the road, the police discovered 80 bails of suspected cocaine and 17 loose packs of suspected Cocaine which when later weighed amounted to 2,604 kilos.

The five policemen and the customs boatman, on a joint possession of unlicensed ammunition charge, appeared in Punta Magistrate Court on Monday, November 15, where the charge was read to them by **Magistrate Leslie Hamilton**. They all pleaded not guilty and were remanded to the Hattieville Prison. They are scheduled to return to court on Thursday, December 9, 2010.





He informed that he has over 200 historical photographs which he will be donating to the new House of Culture.

After the official opening ceremony and the tour of the building, invited guests interacted with each other while enjoying the food and drinks provided by organizers of the event.


