

Surveillance Camera Captures Image Of Man Found With Dan Silva's Stolen Gun

SAN IGNACIO TOWN, Cayo, Thursday, February 10, 2011:

The presence of a surveillance camera was instrumental in the quick solving of a case regarding a stolen loaded gun. At about 5:00 p.m. on Friday, February, 4, 2011, reports reaching us indicate that Belizean businessman and owner of Cahal Pech Village Resort, **Daniel Silva Jr., 55**, reported the theft of his chrome and black licensed 9mm Smith and Wesson pistol with serial number VCK-1587 loaded with six live rounds of ammunition.

In his report to the police Silva informed that the gun was kept locked inside a wooden safe in the lobby area of the resort accessible only to the night watchman. He further informed, that at about 9:00 p.m. on Thursday, February 3, the night watchman, **Calbert “Culebra” Neal**, reported for work and that at around 11:00 p.m. he took out the firearm and kept it in his possession while he patrolled.

During the course of the shift Neal reportedly fell asleep on duty and when he woke up at around 2:00 a.m. the first thing he noticed was that the loaded firearm was gone. Fortunately however, movements in and out of the area were recorded by the resort’s surveillance camera, a review of

which showed that at around 1:30 a.m. a man later identified as Marvin Virulla entered the restaurant area and was seen putting something inside the waistband of his pants as he exited the restaurant shortly after arrival.

The suspect was later detained and at around 5:30 p.m. that same day. He took the police to his Oscar Sabido Layout residence in San Ignacio Town where he first handed over a transparent plastic bag which was found to contain the magazine and all six live rounds of 9mm ammunition. He then escorted the police to a small wooden outhouse located about fifteen feet away from his unpainted house where he showed the police a black plastic bag indicating that the firearm was in it. The police took possession of the bag and when it was opened it was found to contain the stolen firearm.

Virulla appeared in court on Monday, February 7, where he was formally charged with possession of the unlicensed firearm and ammunition. He pled not guilty to both charges and was subsequently remanded to the central prison in Hattieville where he will remain until Thursday, March 31, when he is scheduled to reappear in San Ignacio’s Magistrate Court.

bicycle were transported to the police station in San Ignacio Town where he gave his name and other personal particulars as Ricardo Alvarado, 33 at the time, naturalized Belizean/ Honduran farmer of a Santiago Juan Layout address in San Ignacio Town.

The suspected marijuana was weighed in his presence with the first amount weighing half pound (**226.8 grams**) while the other parcel tipped the scales at one and three quarter pounds (**793.78 grams**). He was subsequently arrested and charged for two counts of drug trafficking and

one count of possession of an article with a blade.

While a ten thousand dollar fine was imposed for the two counts of drug trafficking, Alvarado was likewise found guilty of being in possession of an article with a blade for which he was fined \$200 to be paid also by May 3, 2011 in default one month in jail.

Alvarado appeared undefended in court and, in his own defense, he elected to give the court an unsworn statement from the dock which obviously did not convince Magistrate Cayetano of his innocence.

An official from the Red Cross was later contacted and upon checking the inventory, the official informed that nothing was removed from the building. Crow Fox will be appearing on Friday, February 11, before **Magistrate Dale Cayetano** on a singular burglary charge.

The Follow Up

Last week we spoke about the benefits of creating some healthy competition within the ranks of your staff.

We also spoke about the benefits you can see if you have a properly

implemented contest.

Now, the real secret behind having a successful competition relies heavily upon something that you as management must become adept at, and that's **"The Follow Up!"**

Your ability to follow up properly to get the most out of your competition is absolutely paramount. It is actually paramount to all aspects of your business; from employee development, to profit maximization. You as management need to be able to follow up in a consistent manner. So, how do you follow up on specific items within your business so that you can fully accomplish your goals?

You will need to implement 3 things in order for you to have a proper, consistent follow up

procedure.

1) You need to know what it is that you are trying to accomplish, and have it properly relayed to all the people who are involved with your goal. This must be as clear as day to everyone involved.

Why Third Parties Have Failed In Belize And Most Caribbean Countries

In Belize the Caribbean and to a large extent many other countries in the world, third political parties have failed in gaining ground due to poor planning, no grassroots campaign and the timing of their launch.

The two oldest active political parties in Belize today are the People's United Party (**PUP**) which was formed in 1950 and the United Democratic Party (**UDP**) a party that, in 1973, came out of the People's Democratic Movement (**PDM**), the Liberal Party and the National Independence Party (**NIP**).

There are other parties that were registered earlier in Belize's like the; Honduran Independence Party (**HIP**) and the Christian Democratic Party (**CDP**).

Since 1973 other political parties have been formed include: National Alliance for Belizean Rights (**NABR**) which came out of a split with UDP lead by the late Phillip S.W. Goldson; then there is the Vision Inspired by the People (**VIP**); We the People Reform Movement (**WTPRM**), People's National Party (**PNP**); the Corozal United Front (**CUF**); Democratic and Agricultural Labour Party (**DALP**), National Party (**NP**), People's Action Committee (**PAC**), People's Democratic Party (**PDP**), United Black Association for Development (**UBAD**), Toledo Progressive Party (**TPP**), San Pedro United Movement (**SPUM**) and National Reality Truth Progressive Party (**NRTPP**). Several of these other political appeared during general elections but disappeared after being badly defeated by either the UDP or the PUP.

In Belize today the dominant political parties are the United Democratic Party which is in Government and is led by **Prime Minister Dean Barrow**; then there is the People's United Party (**PUP**), lead by the **Hon John Briceno**; the Vision Inspired By The People

(**VIP**), was established in 2005 and is lead by **Paul Morgan**; The People's National Party (**PNP**), was founded in 2007 with Will **Maheia** as leader.

Since the founding of the VIP the party has not established any organization in all the six districts of Belize except in the Cayo District and mainly in the capital city of Belize, Belmopan. They contested the General Elections in February of 2008 in seven constituencies but were badly defeated at the polls.

In the Municipal Elections held in the city of Belmopan where most of the party members live, they had a full slate of candidates and won 23% of the votes cast. However, they failed to win a single seat on the City Council.

For its part, the PNP leader Will Maheia lives in Punta Gorda Town and has concentrated most of his efforts in the Toledo District where that town is located. There is no evidence that since these two parties lost the General, Municipal and Village council elections, that they have been engaged in any kind of national grassroots campaign to organize themselves throughout the entire country of Belize to win a general election.

General Elections in Belize are held every five years and Municipal Elections which includes Cities and Towns, every three years.

Village Council Elections are likewise held every three years and are considered important because of the amount of people that live in the villages and the constituencies that these villages are a part of.

There are thirty-one seats in Belize's House of Representatives and the party that wins the most seats out of this thirty-one is the party that forms the new government after the general elections to govern the country for the next five years.

Belize and all the former British colonies practice the Westminster model of government and the power lies with the Central Government.

Majority membership in the House of Representatives gives the political party all the power they need in the country. In the last elections that were held on February 7, 2008, the UDP defeated all the other parties by winning 25 out of 31 seats while the main opposition, PUP won the remaining six seats.

Municipal elections were last held in 2009 while Village Council Elections were held in 2010 result-

ing in UDP taking control of all 9 municipal governments and a majority of village councils. Knowing this to be true, one would think that these other two political parties would be actively organizing to get ready for the next general election which is due by February of 2013. Yet, they are complacent and the most they have done is to come up with a few press releases from time to time.

The third parties in Belize have the tendency to start mobilizing just before the general elections and after they lose the elections nothing else is heard from them until the next round of elections approach.

Based on some surveys that have been conducted, there is evidence that Belizeans are becoming dissatisfied with the two major political parties and would welcome another party if there was a real alternative.

Over the years, Belizeans have become more independent voters and on the streets of Belize they would tell you that they are tired of replacing monkey with a black dog. Which is the same as saying that the UDP and the PUP are

becoming more like Pepsi and Coke. Unemployment, poverty, crime, the unequal distribution of wealth, nepotism, patronism, drugs and many other major problems exist in Belize today.

Belizeans have always yearned to live a better life and the parties are not delivering their goods. Some people only go to vote when they are paid to vote which is bad for any democracy.

Last month almost 400 students graduated from the University of Belize to the world of unemployment. They have tuition loans to pay and families to maintain but without employment their graduation is not that significant because they need jobs to maintain themselves and their love ones. With the main opposition the PUP so fragmented, it looks like the UDP will be returned to government whenever the next general elections is called. Notwithstanding, however crime and employment will be the determining factors for the next general election in Belize and the UDP must come up with a solution for these two problems quickly to guarantee victory. Another PUP defeat will inevitably result in further fragmentation of the party and more political parties are bound to emerge in Belize.

Two New Schools Inaugurated

Belmopan, 9th February 2011:

Two major school projects, which will address the educational needs of children in the southern villages of San Vicente and Hope Creek in the Toledo and Stann Creek Districts respectively, was officially inaugurated this week.

The total cost of both projects is approximately \$1.3 Million and will benefit some 446 students.

Both projects were implemented by the Social Investment Fund (SIF), a statutory body under the auspices of the Ministry of Economic Development.

The new school building in San Vicente Village was inaugurated on Thursday, February 10. The project consisted of the construction and completion of a 25 ft wide by 240 ft long one-storey reinforced concrete building with timber and concrete roof with a strip and pad foundation, comprising of six classrooms, a library, a principal's office along with male and female bathrooms. All exterior doors are

solid timber panel and the windows are storm guard aluminum louvers. Also included in the project were the installation of electrical, lighting and plumbing fixtures, and a standard septic tank with soak-away waste water system and furniture, including teachers' tables and chairs, students' armchairs, cupboards and bookshelves.

The total cost of the San Vicente School project was \$414,000. Of this amount, \$331,000 was a grant from the Basic Needs Trust Fund (BNTF), a program promoting poverty reduction through socio-economic initiatives and community empowerment. BNTF is jointly financed by the Caribbean Development Bank (CDB), the Canadian International Development Agency (CIDA) and nine beneficiary governments, including Belize. The Government of Belize contributed \$83,000 in counterpart funding. Some 140 children will benefit from the new school, which will also serve as a hurricane shelter. Prior to the

project, the children were housed in an inadequate small wooden building.

San Vicente is a remote village located 40 miles northwest of Punta Gorda Town near Belize's southern border with Guatemalan being about 5 miles from Jalacte Village. The village was established around 1986 by farmers from Jalacte and surrounding areas. San Vicente has a population of 329 inhabitants.

Meanwhile, the new Hope Creek Methodist School was inaugurated on Friday February 11 in Hope Creek Village.

The project included the construction of a 8,800 square foot, two-storey reinforced concrete structure measuring 30.5ft wide by 144 ft long housing 4 classrooms, a library, an administration office along with female bathrooms on the ground floor. The first floor has an additional 4 classrooms, a computer laboratory along with male and female bathrooms.

Hope Creek Methodist School

has been growing in population since it was established seven years ago. Prior to the project, the students were housed in prefabricated buildings, which were in very poor condition. The new school building will, therefore, provide an enhanced educational environment for both students and teachers. A playground with swings, slides and seesaws, school furniture along with some landscaping was included in the project to further enhance the children's educational environment. Some 306 children will benefit from the project.

The new Hope Creek Methodist School was financed by the Government of Belize through the Commonwealth Debt Initiative (CDI) at a total cost of \$888,645.00. The community of Hope Creek contributed materials and labor for the project.

Hope Creek Village is situated in the Stann Creek Valley Area of the Stann Creek District along the Hummingbird Highway. It has a population of about 1,500 persons and was established in 1962.

The guest speaker at the inauguration of both projects was the **Hon Patrick Faber**, in his capacity as Minister of Education and Youth and the Respective Area Representatives, Hon. Juan Coy for Toledo East and Hon Arthur Roches for Dangriga. Also in attendance were representatives from the Social Investment Fund and other special invited guests.

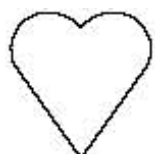

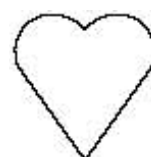

No Arrest Yet In The Luis Valdez Robbery

SANTA ELENA TOWN, Cayo, Thursday, February 10, 2011:

Exactly one week after the robbery of Santa Elena Town businessman, **Luis Valdez**, police is yet to arrest and charge anyone in connection with this crime.

In the course of the investigation thus far, several persons have been detained and subsequently released as the investigation continues.

According to the police report, at around 6:50 p.m. on Thursday, February 3, whilst inside his **Tienda La Gracia de Dios** Store located on the Western Highway in Santa Elena Town, Valdez was seated behind the counter with the shop clerk, **Miriam Nunez**, when he was reportedly approached by two male persons dressed in black with a blue cloth covering their

faces and heads one of whom, according to Valdez, was bare-footed.

Valdez told the police that one of the assailants, armed with what appeared to be a pistol pointed it at him and demanded money. He was then approached by the other man who searched the pockets of the pants he was wearing and in the process removing over \$7,000 in cash along with his cellular telephone valued at \$400.

The two men then rushed out of the shop and vanished into the darkness.

Today his family and many friends crowded his Cedar Bluff Ranch on the Cristo Rey Road on the outskirts of Santa Elena Town, Cayo, to bid final farewell to John Roberson Sr., who was described as a *"good man - a big man"* by his friend **Anthony Channona**, the former Mayor of Belmopan.

John C. Roberson Sr. is predeceased by his daughter, **Judy** and is survived by wife, **Beth Gould Roberson**; Sons: **John Jr., Mark, Jeff, Ralph** and **Court**; Daughters **Cindy** and **Derry**.

The solemn funeral service, coordinate by **Mark**, began promptly at 10:30 a.m. and included comments from family friends **Marjie Olson** and **John Carr** followed by granddaughter **Kristin Roberson Utsman** providing the lead for the singing of *Amazing Grace*; There was a History by **Derry** and comments by **Mark** and others including family friends like **Tony Channona**, **Albert Moore** and **Eddie Hill** among others. The message was delivered by **Alan King**, followed by everyone joining hands for the Lord's Prayer.

The week begins on Valentine's Day, Monday, February 14 with a Praise and Worship ceremony under the leadership of the Pastoral Department with the President of the Student Council welcoming students followed by the official opening of the week by **Dr. Eve Aird**, President of Sacred

The history, tearfully delivered by **Derry Roberson** follows:

John C. Roberson Sr. imported purebred Brahman cattle for a seed herd from the Heart Bar Ranch in Kissimmee, Florida. He also imported Misty Joe Whiz and several other Quarter Horse stallions which improved the national herd. The owner of Heart Bar was the tremendously successful Central Florida rancher, Geech Partin.

John came from a long line of sawmillers. His father, Lyman "Hoss" Roberson's tremendous sawyer talents made him almost legendary in the southern pine forests of the United States.

He came to Belize on October 1, 1960 and ran a timber operation in the Mountain Pine Ridge. He started an open range herd for Bull Run Overseas Ltd., owned by Bull Headly. One of his first agrarian ideas was to cultivate tobacco, a concept derived from his North Carolina heritage. He found that it grew quite well, but was premature for that era in British Honduras. He also planted 300 acres of citrus, which he immediately converted to pasture - he got tired of the constant bickering!

The first Belize Cattleman's Association meeting was held at the Roberson Dining room table. Present at those meetings were men like Guy Nord, Frank Norris, Escandar Bedran and Landy Orio: the true pioneers. They were all very good friends, and provided a base for today's industry. Similarly, he was a key member in both the Belize City and Cayo Jockey Clubs.

Papa, as all the grandchildren knew him, loved horse racing. Among his favorite were Leon Rojo, owned in equal partnership between Papa and Johnny Johnson. Rojo was the Secretariat of Belize with 26 starts and 21 wins. Another favorite and maybe the fastest horse he ever owned and raced in Belize was Leo. Other horses
