The Brutal Murder Of Julian Lara

SANTA ELENA TOWN, Cayo, Wednesday, March 23, 2011:

A 10:00 a.m. funeral service was held today for **Julian Lara**, 69, Honduran watchman of a Salazar Street address in Santa Elena Town, victim of the latest murder incident in San Ignacio

The investigation into the brutal murder reveals the sequence of events as follows: At about 10:30 a.m. on Saturday, March 19, the victim's son, **Jose Lara**, left his Salazar Street residence in Santa Elena Town enroute to his businessplace, *The Spot Bar*, located on the compound of Chuc's gas station on the Bullet Tree Road in San

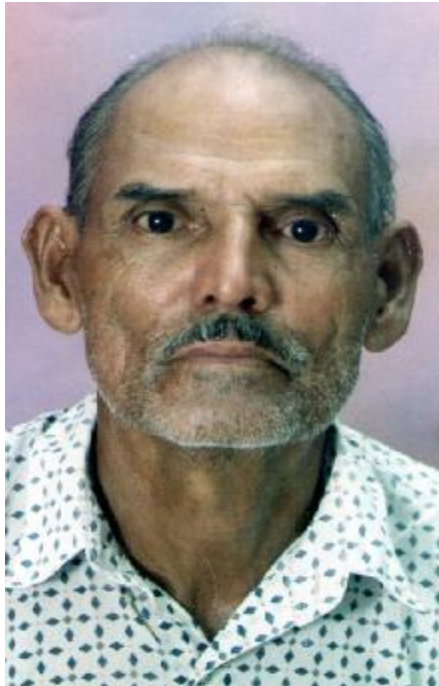

Ignacio Town. He arrived at around 11:00 am and opened for the business day. He remained

at the bar until about 5:30 p.m. when he was relieved by his common-law-wife, **Cristina Fabro** after which he left for home to refresh himself. Upon arriving at home, at around 6:00 pm, he met his father, the deceased, preparing for his usual watchman night shift at the gas station. The deceased had already prepared his food to take along but he instead offered the food to his son. He then proceeded to prepare new food for himself, after which, he left early for work.

He arrived on the job at around 7:00 p.m. to take on his 8:00 p.m. shift. At around 11:30 p.m. the deceased reportedly entered the bar and, at his request, was

given a soft drink with which he reportedly ate some of the food. He reportedly stored away the remainder of the food along with a thermos of coffee.

The son arrived a few hours later to find business going as per normal.

The couple was preparing to close for the night when, at around 12:10 a.m., two male persons arrived at the bar one of whom, known to the couple as **Shajeen Espat** ordered 2 cigarettes for which he paid with

Moving Towards Computer Application In Policing



The Third Segment Of Policemen in Computer Training

SAN IGNACIO TOWN, Cayo, Wednesday, March 23, 2011:

In catching up with current technology, the Belize Police Department is in the process of rolling out its Crime Information Management Systems (*CIMS*) countrywide.

three-day training in segments of fourteen at a time being the number of computer terminals used by the training unit. To date, two groups of fourteen have already undergone the certificate training with another two groups remaining to complete the training of all

central data bank with the capability of linking all entered information on any individual including complaints, arrests, convictions, associates and all other personal information on that individual entered into any terminal countrywide in a nutshell all police anywhere in the country, with the press of a button will know who you are and what you have criminally done.

The system is also designed to enhance police efficiency and reduce misbehavior especially in those many instances where police personnel fail to submit case files. It will eliminate the handwriting of statements and

other prescribed forms used by the police including the report diary. The system will automatically generate a case file with the recording of every statement. The only bug being in those instances where policemen do not record statements, in these instances, the system will be supported with the installation of cameras to monitor such activities. This system will be even more effective with complainants insisting on the recording of statements and in those instances where any police officer refuses to record a statement, a complaint should be made to the Officer Commanding that formation as once a statement is lodged in the system, no police officer will have the computer authorization to delete it. That officer will then be compelled to proceed with the process to its natural conclusion until it is dispensed with by the court. The system is also designed to alert when a complaint is nearing the statute bar limitation.

San Ignacio is scheduled to become “*CIMS live*” by April 1 after which 5 computer terminals will be permanently installed at the San Ignacio Police Station for the live implementation of CIMS. From San Ignacio the team moves to tackle the largest group in Belize City.

The PITU is aiming to have the entire county “*CIMS Live*” by the end of this year.

Training in the application of the computer software, under the auspices of the Police Information Technology Unit (*PITU*) headed by **Inspector Mario Alcoser**, began in Belmopan earlier this year. Belmopan is now “*CIMS live*”. The team is now in San Ignacio where training began last week inside the police conference room.

The training team, led by the Crimes Desk Manager in charge of the CIMS, **Sergeant Juanito Cocom**, includes **Corporal #796 Sheridan Lemoth** and **Constable #694 Ricardo Villafranco**. San Ignacio police personnel are undergoing the

police personnel attached to the San Ignacio Police formation.

The objective of this advancement in conducting police duties is a shift towards intelligence led policing using information technology in the fight against crime. Police personnel are being instructed in understanding the concept of policing using information technology. They are likewise receiving instructions in data entry, data retrieval and data storage. The system is designed to link crime patterns, analyze data and create statistical data. All information entered into the system will be fed into one

Stolen Ford Explorer Surfaces In San Ignacio Town

SAN IGNACIO TOWN, Cayo, Wednesday, March 23, 2011:

A vehicle which was reported to Ladyville police as stolen from Maxboro Community in the Belize District was today found abandoned, on a street-side in San Ignacio Town.

Responding to the report of a

mysterious vehicle, with Belize City license plates, parked for several hours, on the side of the street in San Ignacio Town, police, at around 5:00 pm on Sunday, March 20, arrived on 4th Street where they came upon a four-door, dark blue Ford, Sport Trac, Explorer with Belize City license plates BC-C-

33675.

Inside the glove compartment police found a US Certificate of Title in the name of **Sylvia Claudette Harris**.

With assistance from the Town Council, the vehicle was towed

into the police compound.

A subsequent investigation revealed that a house, in Maxboro Community was burglarized. The complainant however was unable to say what was stolen from inside the house as the property owner is currently in the United States. However, the one item that the complainant was able to ascertain as missing was the Ford Explorer.

The vehicle, now parked on the compound behind the police station in San Ignacio Town, is yet to be claimed by the owner. No arrest has been made.



Customer Relations Training For Frontline Tourism Personnel

Belize City, Belize, March 18, 2011:

The Belize Tourism Board (BTB) awarded certificates of completion today to twenty-five officers from the Customs Department, Immigration Department, Police Department, Border Management Authority and the Belize Agricultural Health Authority (BAHA), after a weeklong training course in Customer Relations that began on Monday, March 13, 2011.

SUCCESS IN YOUR BUSINESS

A Successful Business Meeting

This week we continuing our follow up on a successful business meeting.

There are so many aspects involved in having a successful business meeting.

In a previous article, we looked at the art of listening and how important that trait is in a business meeting. Now, we are going to concentrate on the type of notes that we will take.

Many people think that so long as you are writing, you are taking notes. That couldn't be further from the truth. Today, we are going to look at how we can properly prepare ourselves to take effective notes that we will be able to go over after the meeting and actually get something out of.

Remember, you as management should be directing the focus of the meeting. Your aim at taking good notes is to identify the feedback you are



getting from your staff. You can prepare your note taking process by having the meeting agenda on hand, and setting up headings where you are expecting feedback from your staff. Have this prepared in advance. If you have certain questions pertaining to a certain section of your agenda, write them down, and make sure that as you pass from one section to another, that you get the questions answered. If they aren't answered to your specificity during the meeting discussion, don't wait until the meetings completion, ask the questions as they pertain to the headings in your agenda. You want your staff to be focused on these areas when you ask the question, so make sure you interject them at effective intervals. This is easy if you are management and are at the helm of this discussion. The whole emphasis is on advanced preparation. Having your

subject topics in writing in front of you, and knowing what you want answered ahead of time. If you can do this, your note taking process should be fairly simple and straight forward. Make your notes easy for you to understand, and write legibly enough so that you don't miss the points of your notes.

Now, if you are not at the helm of the discussion, things get a little more challenging when it comes to taking good effective notes. If you are a staff member, good participation at a staff meeting will require that you read ahead in the agenda early, and focus your attention on questions that you need answers for as they pertain to the agenda. You may have to write down the questions as information is being relayed to you. Make sure that you do so in short order, as you want to be able to focus on the changing topics of conversation. In this instance, you will want to write down pertinent information that might not be available to you at a later date. When you jot down your questions, be specific and be short, so that you can ask them at the allotted time for your

input. Try not to concentrate too intently on what you are going to say, or the areas that you are familiar with, focus on the points in which you personally need clarification.

Business meetings are meant to be educational. If you are directed to take notes on specific matters, make sure you record these items. If not, direct your attention to areas that you don't necessarily know. Make sure that you write them down in a timely, but legible manner. And make sure you always write in terms that you will understand. Don't write in such short hand that you don't know what the point was at the time of the discussion. Make your notes something that you can use to educate yourself. This will help you to grow and will make all the murky things clearer especially if you approach your management to get these items clarified.

This is just an intro on how to prepare yourself to take appropriate notes.

One Week Extention For Scales To Measure The Sale Of Butane Gas

BELMOPAN, Wednesday, March 23, 2011:

The Government of Belize through the Bureau of Standards (BBS) today informed that Statutory Instrument No. 12 of 2011 for National Metrology Liquefied Petroleum Gas Regulation 2011 which requires

all suppliers of LPG to have measuring instruments at their depots and all motor vehicles used for delivering LPG was made effective on March 18, 2011. However there is the non-availability of the scales as specified in the regulations and considering the current situation,

the Bureau has extended the effective date to March 25, 2011.

All suppliers of LPG have had a total of 34 days to comply. To date the BBS has received two applications for the approval of scales being acquired.

The general public is informed that although the scales are being imported they will first have to be verified by the Bureau before they can be introduced for general trade.

The Bureau has taken the decision to extend the date of compliance on a case by case basis for all the suppliers that submit an application for approval by March 25, 2011 only.

If applications are not received by the aforementioned date, extensions will not be granted and LPG suppliers will be expected to comply with the law by this date or be subject to the penalties.

All suppliers of LPG are reminded that scales **cannot** be

used at the depots or on the delivery trucks, without following due process as prescribed in the recent legislation.

Patrick Faber's Third Endorsement To Contest General Elections For The UDP

Hundreds of UDP party supporter attended a packed Convention Rally in Belize City on Sunday the 20th of March 2011 to show their support for **Hon. Patrick Faber** the Minister of Education in the United Democratic Party Cabinet and current Chairman of the United Democratic Party who is representing Collet Division for two consecutive five year terms.

Present at this function was a former Leader of the Party the **Hon. Dean Lindo**, Former Minister of State who represented this same constituency in the past **Hon. Faith Bob**, Attorney General **Bernard Pitts**, Minister of Foreign Affairs and Foreign Trade **Wilfred Elrington**, Prime Minister **Hon. Dean Barrow** and his Cabinet, Officers of the executive body for the United Democratic Party, members of the Belize City Council and representatives from other District executive bodies for the party.

Currently, conventions are being held throughout the entire country by the two most popular political parties which

are the United Democratic Party UDP and the People's United Party PUP. The country of Belize will be holding Municipal Elections next year in March of 2012. The last general elections in Belize were held in February of 2008. The Prime Minister of Belize must call elections ninety days prior to that date by dissolving his Cabinet and inform the Governor General of the date of the next election. Due to the fact that early conventions are currently taking place, all indications are that elections could be held as early as November of 2012.

The program for the day started with a prayer, the playing of the Belize National Anthem, speeches by Ministers **Michael Finnegan**, **Eden Martinez**, **Gaspar Vega** Deputy Leader, Prime Minister **Dean Barrow**, endorsements by three

constituents and the reading of the Endorsement Pledge by former Minister **Faith Bob**. Prime Minister **Dean Barrow** spoke about his vision for his party and all the accomplishments his party has made over the years. He continued by pointing out all the major accomplishments Minister Faber has made as Minister of Education and the role he plays as one of the key players in his administration.

He stated that Minister Faber seat is so secured that he is willing to make a bet that this Minister will be re-elected whenever general elections are called without any difficulty. Minister of Human Development and Social Transformation **Hon. Eden Martinez** the Representative from Toledo West in the southern part of Belize spoke on behalf of the two southern districts Stann Creek and Toledo Districts. **Hon. Eden Martinez** is one of the four Garifuna Representatives in this current United Democratic Party administration along with Minister of State **Arthur Roches**, former Minister of State **Edmund Castro** and Minister of Works **Anthony "Boots" Martinez**. Minister Martinez congratulated Minister Faber for the assistance he has received over the years for many educational programs in his constituency. This included funding for the construction of new schools and supplies and equipments for most of them. At the conclusion of the ceremony, there was a party to celebrate the Minister's endorsement and his birthday in the next three days when he will be having his thirty-third birthday. Minister Faber is one of the youngest members of the United Democratic Party cabinet and is seen as a future leader of his party and possibly a potential Prime Minister of Belize if all continue to go well for him. At the last convention held by the party, he defeated another candidate who ran for the position of Party Chairman one of the highest ranking positions in the United Democratic Party. He ended up by thanking all those individuals who contributed to his political success such as his mother, wife, teacher, Minister **Faith Bob** relatives, friends and constituents from his Collet Division.

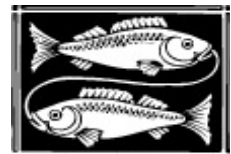

The Brutal Murder Of Julian Lara

an old US 1 dollar bill. He was served by Cristina with two colonial cigarettes and was given a Belize dollar coin in change. He requested a light which was given to him by Jose. Being acquainted with this individual, as he frequents the Salazar Street neighborhood, Jose reportedly commented to him that he was far from his neighborhood to which he reportedly responded that it was the girls who had him over there.

Both male persons left the bar and walked straight across the Bullet Tree Road neither turning left towards Bullet Tree nor right in the direction of downtown San Ignacio Town.

After dispatching the three barmaids to their respective homes, the couple left the bar enroute to their Salazar Street residence.

One hour later at exactly 1:10 a.m. San Ignacio Police received a telephone report of a burglary in progress at the gas station. Investigators are of the opinion that the caller's attention was drawn to the incident by the loud sound of the smashing of the thick glass on the main entrance door to the gas station. Within a few minutes of the report the police arrived on the scene where they found the door with the glass in the lower section smashed in. They began searching for the watchman and eventually found him on the tiled floor, in a large pool of blood, in an opened back portion of the bar near a billiards table.

His feet were tied at the ankle and his hands were tied behind the back with the lace from the pair of shoes he was wearing which was found next to him. The remainder of his food and the coffee were found in the bar along with his radio which was on and tuned in to LOVE FM. His wallet with its contents, scattered on the floor, was found near the body. The machete, with which he usually patrols the compound, was reportedly found on top of one of the gas pumps.

Jose and Cristina were informed, by the police, of the gruesome discovery. They arrived shortly thereafter and informed the police of their earlier encounter with Espot and

the other male person. It was at this point that the police reportedly recalled sighting Espot walking alone towards downtown San Ignacio as they were rushing to investigate the reported burglary.

The search immediately began for Espot. About an hour later police found him at Happy's Bar in Red Creek, on the eastern outskirt of Santa Elena Town. Upon careful inspection, sprinkles of blood were reportedly found on the clothes and on the tennis he wore. Espot was immediately detained and escorted to the police station in San Ignacio Town.

A flaw in the process was later realized as the subsequent information revealed that the other suspect was likewise at the bar spending, drinking and socializing. Since he was not initially identified on the scene, he escaped detention at the bar and, up to press time, he remains at large.

As the investigation began to unfold one policeman who was standing outside the station shortly after the incident recalled seeing Espot and a male person walking past the police station, over the Hawksworth Bridge, heading into Santa Elena Town.

The investigation revealed that while the gas station normally closes at 6:00 pm, an attendant remains on duty, serving fuel, until 10:00 pm. The attendant makes frequent cash drops, in sealed envelopes, through a slot in the cement side wall. The sealed envelopes are allowed to fall on the floor inside the closed building.

The gas station records revealed that, before reporting off duty, the attendant, **Daniel Montejo**, made five such cash drops, totaling \$1,776.37, all of which, along with a digital camera and a SMART Top-Up telephone with \$198 worth of credit for sale, were also missing from inside the gas station.

Given that the door is fitted with a dead lock, police suspect that entry and exit were gained through the hole created by the smashing of the glass.

Investigators are of the opinion that the watchman was first attacked after which the gas station was broken into.

The body, with two large

holes to the neck and a slashed throat, remained on the scene for about two hours, until at around 3:00 a.m., when it was transported to the nearby community hospital in San Ignacio where it was officially pronounced dead by the medical officer on duty and placed inside the morgue.

The legally required post mortem examination was conducted by forensic specialist, **Dr. Mario Estradabran** between 2:00 and 3:00 p.m. on Tuesday, March 21, at the Karl Heusner Memorial Hospital in Belize City. The examination certified the cause of death as *“exsanguination, external bleeding due to injury to internal and external carotid artery ventricular hemorrhage”*.

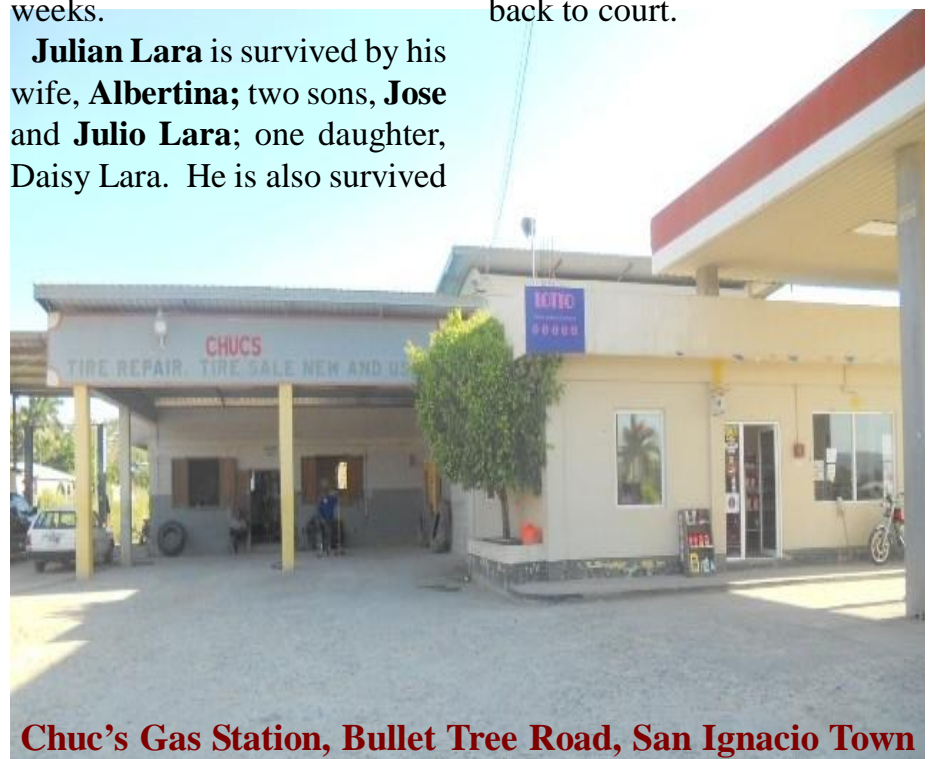
The deceased, originally from Honduras, migrated to Belize in 2004 following up on his son's football career. This endeavor took him to Mango Creek, San Pedro and eventually to Santa Elena where his son resides and plays for Benque Viejo's Verdes Football Club. He was working at the gas station for only five weeks.

Julian Lara is survived by his wife, **Albertina**; two sons, **Jose** and **Julio Lara**; one daughter, **Daisy Lara**. He is also survived

by daughter-in-law, **Cristina Fabro** and two grandsons **Brian** and **Luis Lara**.

The body was received at 10:00 a.m. on Wednesday, March 23, at St. Ignatius Church in Santa Elena for the funeral service. The body was laid to rest inside the Carmen Memorial Cemetery in Santa Elena.

After giving a cautioned statement, the accused, **Shajeen Espot**, 20, Belizean laborer of a Maria Gonzalez Street address in Santa Elena Town; on direction from the Director of Public Prosecutions, was arrested and formally charged for conspiracy to commit robbery. He appeared before **Magistrate Dale Cayetano**, in San Ignacio's magistrate court on Tuesday, March 22 where the charge was read to him. **Prosecutor George Gomez** objected to bail citing the connection of the charge to a murder investigation. Magistrate Cayetano concurred with the objection and remanded Espot to the central prison in Hattieville until Tuesday, June 7, 2011 when he will be brought back to court.
