## Three Jailed For Trafficking In Marijuana **One Escaped From The Police**

SAN IGNACIO TOWN, Cayo, Thursday, August 4, 2011:

A team of alert policemen on mobile patrol successfully apprehended three of four persons charged for transporting marijuana concealed inside the spare wheel of a vehicle.

At around 8:30 on the night of Tuesday, August 2, the team was patrolling in a private vehicle when between miles 68 and 69 on the Western Highway in the vicinity of Rumors Resort their attention was drawn to two vehicles parked off the highway heading in the direction of San Ignacio from Benque Viejo Town.

Sensing something suspicious about the movement of the persons around the two parked vehicles as they passed, the patrol turned back to investigate. The policemen came upon a green Geo Tracker and red Toyota pickup truck with one person passing a spare wheel from the Tracker to another person in back of the Toyota.

## San Perdomo Laid To Rest

BELMOPAN, Cayo, Wednesday, August 3, 2011:

A solemn funeral service was held today in Belmopan for pioneering Belizean politician, Santiago "San" Perdomo, 77, who passed away quietly on Sunday, July 31, 2011.

The well attended 3:00 pm mass of the resurrection was celebrated by Fr. Kurt Kassebeer inside Our Lady of Guadalupe Co-Cathedral in Belmopan with a large turnout of relatives and friends.

A page from the booklet distributed in church reads:


"Santiago Alberto Perdomo was born to Mr. Tiburcio Perdomo and Mrs. Epifania Perdomo on April *22, 1934.* 

He attended Holy Redeemer Primary School and Saint John's College where he was a good student but was better known for his excellence as a basketball player.

He left Belize City to travel to Dangriga to become one of the very first teachers at Lynam College.

Following his stint at Lynam College he went on to live in San Ignacio "El Cayo", which was the hometown of his wife Mrs. Lileth Perdomo nee Habet. They jointly owned and operated the "Regal" Restaurant.

It is in San Igancio that he

became involved in what would become a lifelong passion politics.

He became Mayor of San Ignacio in 1964.

He was then elected to the House of Representatives for the Cayo South Constituency.

His first appointment in cabinet was as Minister of Education. His next portfolio was Agriculture.

In his later years he was appointed as Ambassador to Central America.

Santiago Alberto Perdomo "SP" as he was commonly known was a champion of the chicleros, a lover of ladies, a man of the people and most of all he was a

humble servant. Rest in Peace "SP"."

Mr. Perdomo is survived by Alma Escalante; Children: Daniel, Tiburcio, Lileth, Victor, Lisan and Josie. He is also survived by four step children: Lynne, Derek, Roque and Enrique "Kiko" Escalante as

well as to one sister, Cruzita Swasey and two brothers: Bato Perdomo and the Hon. Carlos Perdomo. Minister of Defence and Immigration.

The body was laid to rest inside the Belmopan Cemetery.

celebrating a birthday party, when a group of five persons, heavily concealed in dark clothing and masks stormed into his house. Some of the intruders were reportedly armed with guns while others were allegedly armed with machetes.

The report indicated that Barrera, his family and guests were ordered into a room where they were reportedly tied up after which the intruders searched the house before departing with Barrera's \$60,000 green Isuzu D-Max truck (license plates SI-C01863-SE), his licensed 9mm Beretta brand pistol fitted with a magazine containing 14 live rounds of ammunition.

The invaders also reportedly

also made off with an assortment of jewelry and cash.

It is further alleged that the invaders also inappropriately touched an 18 and a 19 year old female guests.

In the process of the investigation, at around 12 noon on Wednesday, August 4, Barrera's vehicle was recovered intact off a feeder road in a pasture in the Trapiche area of Santa Elena town.

No one was found in the area. The vehicle was removed and driven to the San Ignacio police station where it was held overnight.

In a strange turn of events, while the investigation is yet in the preliminary stage, the vehicle, a major piece of evidence in the investigation, was promptly handed over, the

# A Sure Way To Kill A Nation

We know Dick Lamm as the three term former Governor of Colorado. In that context his thoughts are particularly poignant.

Last week there was an immigration overpopulation conference in Washington, DC, filled to capacity by many of America 's finest minds and leaders.

Abrilliant college professor by the name of **Victor Hansen Davis** talked about his latest book, '*Mexifornia*,' explaining how immigration - both legal and illegal was destroying the entire state of California. He said it would march across the country until it destroyed all vestiges of The American Dream.


Moments later, the former Governor of Colorado **Richard D. Lamm** stood up and gave a stunning speech on how to destroy America

The audience sat spellbound as he described eight methods for the destruction of the United States

He said, "If you believe that America is too smug, too self-satisfied, too rich, then let's destroy America. It is not that hard to do. No nation in history has survived the ravages of time. Arnold Toynbee observed that all great civilizations rise and fall and that - An autopsy of history would show that all great nations commit suicide."

"Here is how they do it," Lamm said:

'FIRST, to destroy America, turn America into a bilingual or multi-lingual and bicultural country. History shows that no nation can survive the tension, conflict, and antagonism of

two or more competing languages and cultures. It is a blessing for an individual to be bilingual; however, it is a curse for a society to be bilingual. historical scholar, Seymour Lipset, put it this way: 'The histories of bilingual and bicultural societies that do not assimilate are histories of turmoil, tension, and tragedy.' Canada, Belgium, Malaysia, and Lebanon all face crises of national existence in which minorities press for autonomy, if not independence. Pakistan and Cyprus have divided. Nigeria suppressed an ethnic rebellion. France faces difficulties with Basques, Bretons, Corsicans and Muslims.'

#### Lamm went on:

'SECOND, to destroy America, invent 'multiculturalism' and encourage immigrants to maintain their culture. Make it an article of belief that all

cultures are equal; that there are no cultural differences. Make it an article of faith that the Black and Hispanic dropout rates are due solely to prejudice and discrimination by the majority. Every other explanation is out of bounds.

'THIRD, we could make the United States an 'Hispanic Quebec ' without much effort. The key is to celebrate diversity rather than unity. As Benjamin Schwarz said in the Atlantic Monthly recently: 'The apparent success of our own multi-ethnic and multicultural experiment might have been achieved not by tolerance but by hegemony. Without the dominance that once dictated ethnocentriy and what it meant to be an American, we are left with only tolerance and pluralism to hold us together.'

Lamm said, 'I would encourage all immigrants to keep their own language and culture. I would replace the melting pot metaphor with the salad bowl metaphor. It is important to ensure that we have various cultural subgroups living in Ame rica enforcing their differences rather than as Americans, emphasizing their similarities.'

'FOURTH, I would make our fastest growing demographic group the least educated. I would add a second underclass, unassimilated, undereducated, and antagonistic to our population. I would have this second underclass have a 50% dropout rate from high school.'

'My FIFTH point for destroying America would be



Victor Hansen Davis talked about his latest book, 'Mexifornia,'

to get big foundations and business to give these efforts lots of money. I would invest in ethnic identity, and I would establish the cult of 'Victimology.' I would get all minorities to think that their lack of success was the fault of the majority. I would start a grievance industry blaming all minority failure on the majority population.'

'My SIXTH plan for America 's downfall would include dual citizenship, and promote divided loyalties. I would celebrate diversity over unity. I would stress differences rather than similarities. Diverse people worldwide are mostly engaged in hating each other - that when they are not killing each other. A diverse, peaceful, or stable society is against most historical precedent. People undervalue the unity it takes to keep a nation together. Look at the ancient Greeks. The Greeks believed that they belonged to the same race; they possessed a common language and literature; and they worshipped the same gods. All Greece took part in the Olympic games. ## An Unnatural Crime - Against The Order Of Nature

SAN IGNACIO TOWN, Cayo, Friday, August 5, 2011:

A 17-year old, Belizean boy from San Antonio Village, Cayo, appeared in court this morning where **Magistrate Dale Cayetano** read to him the singular indictable charge of committing an unnatural crime. He was offered and met bail in the sum of \$5,000 and ordered to return to court on Wednesday, November 2, 2011.

The charge against the village boy stems from an incident which reportedly occurred at around 9:30 on the morning of Sunday, July 31 in San Antonio Village.

At around 10:00 am on Tuesday, August 3, a nine year old male child from San Antonio village, accompanied by his father, arrived at the police station in San Ignacio Town where, in a statement to the police, recorded in the presence of the father, the child informed that two days earlier, at around 9:30 am he went over the neighboring residence of the accused who shortly after his arrival requested for the child to

accompany him to farm where he was going to chop bush. The child accompanied the accused to the location and was observing as the accused was working. It did not take long however for the accused to turn his attention from the chopping to the child.


The child alleges that in

exchange for a \$5 bill the accused requested for the child to take off his pants. The child reportedly refused and in the process indicating that he was returning to his house and this was when the incident became violent. It is alleged that the accused grabbed the child, forced him face downwards to the ground, pulled off his pants and proceeded to rape him "against the order of nature". In the absence of a pediatrician at the hospital in San Ignacio, the child was transported to the western Regional Hospital in Belmopan where he was examined by Dr. Edna Mendez, who not only confirmed that the child was molested, she also noted severe injuries in the region where he

was carnally known.

While the child was accompanied to Belmopan on Tuesday morning, another team of policemen, descended upon San Antonio Village in search of the accused but after unsuccessfully searching for several hours, they returned the San Ignacio empty handed. With the police presence in the village, news of the incident quickly enveloped the community and fearing for his son's safety at the hands of angry villagers, the father turned in the accused to the police.

It was shortly before 5:00 o'clock on Wednesday evening,



when the father strolled into the police station in San Ignacio and handed over his son to the police.

The child is recuperating at home in San Antonio Village.

## On the Minister of Sports, FIFA And The FFB

Belize's Minister of Sports, **Hon. John Saldivar,** can use his power to let the new football league form a national team

Since the President of the Football Federation of Belize (*FFB*) **Bertie Chimillio** did not make sure that his league met the requirements of the National Sports Council it is clear that he thinks he is above the laws of Belize.

The Government of Belize was elected by the citizens of the country and, as such, they have an obligation to carry out its function in the best interest of the people and country of Belize.

The FFB under the leadership of Bertie Chimillio, has been running football in Belize for many years now and they have not improved the sport or have developed any football team to make Belize competitive in the international arena as the record can attest.

Also, with the current scandals taking place with the FIFA organization, it is obvious that some of their officials who are incompetent were elected due to payoffs and bribes as opposed to their knowledge and professional expertise with the sport. This scandal will lead to more information that we were not aware of because many countries in the world will begin to investigate the FIFA representatives in their homelands.

Allowing the FFB to continue running football in Belize and expecting better results is wishful thinking because of their long history of failure.

Jack Warner, FIFA Vice-President and Mohammed Bin Hammam, were recently suspended by the league's disciplinary committee for inappropriate conduct over an alleged \$40,000.00 US bribe to regional delegates to secure

votes on behalf of aspiring FIFA President Mohammed Bin Hammam.

If found guilty by the committee during the trial phase, they could be banned for life for any further involvement with football anywhere in the world.

The Government of Belize cannot wait for FIFA to discipline their officials before they plan for the improvement of football in the country.

The Minster of Sports can now authorize the Belize National Football Association (*BNFA*) to form a Selection Committee to select the best players in the country to attend a football training camp.

Selecting a National Football Team over the years have always been unfair from my own personal experience when I was playing football in Belize.

Most of the people who were chosen were not picked because of their abilities and capabilities in playing the sport. The majority of them were selected because of favoritism. With a selection committee, they will have the opportunity to select three of the best players for each position and send them to the training camp to compete among themselves for those positions. However, they must bear in mind that some of our country's rated players are out of the country playing and they must meet their contractual obligations. These players should be given the opportunity to participate in this process as Belizeans.

I am not too sure about the new

way in selecting the country's national football team. I was told that over the years the country used the team that won the National Football tournament which in this case will be the Belize Defense Force, as the chore team and then picked other players from several teams to make up the national selection. I am opposed to this method and prefer when three of the best players countrywide for each position are chosen to compete against each other for the positions on the team. Belize have six districts and each have a President and committee members who are familiar with the players. Among themselves, they should be able to formulate the rules and regulation as to who are the best players for each position in their districts. Then,

common enemy, Persia, threatened their liberty. Yet all these bonds were not strong enough to overcome two factors: local patriotism and geographical conditions that nurtured political divisions. Greece fell. 'E. Pluribus Unum' -- From many, one - In that historical reality, if we put the emphasis on the 'pluribus' instead of the 'Unum,' we will 'Balkanize' America as surely as Kosovo.'

'NEXT TO LAST, I would place all subjects off limits. Make it taboo to talk about anything against the cult of 'diversity.' I would find a word similar to 'heretic' in the 16th century - that stopped discussion and paralyzed thinking. Words like 'racist' or 'xenophobe' halt discussion and debate. Having made America a bilingual/bicultural country, having established multi-culturalism, having the large foundations fund the doctrine of 'Victimology,' I would next make it impossible to enforce our immigration laws. I would develop a mantra: That because immigration has been good for America, it must always be good. I would make every individual immigrant symmetric and ignore the cumulative impact of millions of them.'

In the last minute of his speech, Governor Lamm wiped his brow. Profound silence followed. Finally he said, 'LASTLY, I would censor Victor Hanson Davis's book 'Mexifornia.' His book is

dangerous. It exposes the plan to destroy America. If you feel America deserves to be destroyed, don't read that book.'

There was no applause. A chilling fear quietly rose like an ominous cloud above every attendee at the conference.

Every American in that room knew that everything Lamm enumerated was proceeding methodically, quietly, darkly, yet pervasively across the United States today. Discussion is being suppressed. Over 100 languages are ripping the f oundation of our educational system and national cohesiveness. Even barbaric cultures that practice female genital mutilation are growing as we celebrate 'diversity.'

American jobs are vanishing into the Third World as corporations create a Third World in America, take note of California and other states. To date, ten million illegal aliens and growing fast. It is reminiscent of George Orwell's book '1984.' In that story, three slogans are engraved in the Ministry of Truth building: 'War is peace,' 'Freedom is slavery,' and 'Ignorance is strength.'

they would be searched for drugs, arms and ammunition.

Nothing incriminating was found on their person. However recalling the suspicious movement of the spare wheel, the police zeroed onto the 15 inch Good Year tire which was flat, but when pressed, it emitted a strong aroma of marijuana. Further checks revealed that it contained several packages wrapped in black plastic bags.

The driver of the Toyota was identified as **Marco Antonio Hernandez**, 26, Belizean carpenter of a Santa Cruz Area address in Santa Elena Town. Travelling with Hernandez in the red Toyota pickup truck was **Elias Zabaneh**, 26, unemployed Belizean of a Bullet Tree Falls village address.

The driver of the green Geo Tracker was **Hiram Avila** whose other personal particulars are unknown as upon observing that the marijuana was found in the tire and hearing that they would be detained and transported to the police station, ran off and quickly disappeared into the darkness of the night. Travelling with Avila in the Tracker was Wendy Zucely Monroy Morfin, 36, Guatemalan self-employed residing in Bario Suchitan, Melchor, Peten, Guatemala.

Upon arriving at the police station, the wheel was stripped and was found to contain six black plastic bags of marijuana which when weighed amounted 4,712 grams. **Hernandez**,

Zabaneh and Monroy Morfin were subsequently arrested and jointly charged for drug trafficking.

They appeared in court on Wednesday, August 3, where **Marco Antonio Hernandez**, pled guilty to the charge.

Magistrate **Dale Cayetano** proceeded to sentence him to three years in jail plus a fine of ten thousand dollars, half of which was to be paid forthwith in default of payment, he would spend an additional three years in jail. The sentence is to run concurrently meaning that he will have no need to pay the ten thousand dollar fine and it will be spent simultaneously with the imposed 3-year sentence.

The other two co-defendants **Elias Zabaneh** and **Wendy Zucely Monroy Morfin,** both pleaded not guilty to the charge.

Zabaneah was offered bail in the of ten thousand dollars and ordered to return court on Tuesday, September 27.

Because of the flight risk she presents, Monroy Morfin was denied bail and remanded to prison to be brought back to court also on Tuesday, September 27.

By the time the jail train left San Ignacio Town, Zabaneah was not able to meet bail and so all three of them were transported to the central prison in Hattieville which Hernandez will call home for the next three years, Monroy Morfin until September 27 and Zabaneah until he posts bail.
