# A Man And A Boy Found In Possession Of **Items Reported Stolen In A Home Invasion**

#### SAN IGNACIO TOWN, Cayo Thursday, August 18, 2011:

As investigation continues into the July 30 invasion of the Martin Galvez Street, San Ignacio Town residence of Salvadoran businessman, Saul **Barrera**, police report this week the arrest of a man and a boy found in possession of several items stolen in the home invasion.

At around 11:00 am on Wednesday, August 10, acting upon information received a team of policemen visited a residence located at #187

Western Highway, in that area popularly known as "Hot **Point"** where they recovered a white Wii Nintendo game with charger and 8 controls and with a black digital slide picture frame valued at \$1,200 and \$200 respectively. All items were positively identified by Barrera as his property being some of the items stolen in the July 30 invasion of his house.

The recovery led to the arrest of Harrison Wellington and a 15 year old boy who was present at the time of the search.

They were instantly detained

#### and transported to the police station in San Ignacio where they were later arrested and formally charged for handling stolen goods. They both pleaded not guilty to the charge and were remanded to the central prison in Hattieville and are scheduled to return to court on Tuesday, October 25, 2011.

While four members of a notorious San Ignacio gang were reportedly detained for the actual invasion, they were later released without charge as investigators were unable to come up with evidence to support charges against them.

Barrera's \$60,000 Isuzu D-Max, stolen in the incident, was recovered intact five days

### Police Finger Printing System Going Digital

### BELMOPAN, Thursday, August 18, 2011:

The Belize Police Department recieves automated fingerprint identification system (**AFIS**) through the Central American Regional Security Initiative (*CARCI*).

Several months ago, courtesy of the CARSI program and the United States Government, Belize received 6 electronic fingerprint scanning units.

A unit will be assigned to the police station in each district and this will allow for the convenient taking of fingerprints in each district.

Scenes of Crime personnel and police officers from each district formation have been trained in the proper use of this equipment.

Presently, the department has over 60,000 fingerprints which were taken manually over the past 40 years and need to be inputted into the database to facilitate quick comparisons and analysis.

As part of the contract, AFIX TECHNOLOGIES, the company that supplied the equipment, has sent four technicians to Belize to assist the Police Department with the inputting those 60,000 fingerprints through the use of high speed scanners and archiving system.

This assistance will allow the department to expedite the process of inputting fingerprints into the database in a much shorter period.

The Police Department is grateful for this assistance provided under the CARSI program.

#### Responds To Orders Issued Government By The Caribbean Court of Justice

Wednesday, BELMOPAN, August 17, 2011:

In responding to orders issued on Tuesday, August 16, by the Caribbean Court of Justice (CCJ), the Government of Belize informs that the applicants, Dean Boyce and British Caribbean Bank (BCB), were given leave to appeal against the refusal of the Belize Court of Appeal to make orders giving back Telemedia to the Ashcroft Alliance or giving damages to BCB.

Th CCJ pointed out that such an appeal would be futile unless the applicants could first get the Supreme Court of Belize to strike down the 2011 Act under which Government reacquired Telemedia; and unless the applicants could also get the Supreme Court to strike down the 9th Constitution Amendment Bill (validating that 2011 reacquisition Act) after it becomes law.

The CCJ, as it was bound to, refused the application for an injunction to stop the National Assembly from passing the 9th Amendment Bill. That is vindication of GOB's position that no court is above the Constitution of Belize or above the right the Constitution gives to the National Assembly to amend the Constitution.

The CCJ also gave an injunction restraining Government from selling shares in Telemedia until after CCJ has heard the appeal against the refusal of the Court of Appeal to give the orders the Ashcroft alliance wants. But once the 9th Amendment Bill is passed the appeal will inevitably fail, the injunction will fall away and Government will be free to continue sale of minority Telemedia shares, including to the employees.

The fact also is that the CCJ expressly recognized the right of the applicants (and all Belizeans) to go to court to challenge the 9th, or any, Constitutional amendment Bill. This proves that Government was always telling the truth when it insisted that no language or provision in the Bill would bar anyone from access to court.

In Government's view what was most important about yesterday's developments is the confirmation it provided of the Ashcroft Alliance's implacable determination to defeat the will and sovereignty of the Belizean people. It must be just as clear, though, that Government will never let that happen. But the greatest weapon to safeguard the now nationally owned Telemedia from Ashcroft's continuing billionaire power plays, is the 9th Amendment.

As per the CCJ, as long as that amendment is passed and protected the designs of Ashcroft will fail. Government therefore calls once again on all nationalistic Belizeans to support the Belize Constitution (9th Amendment) Bill.

Government knows that there is already near unanimity in our country when it comes to enshrining ownership of the utilities in the Constitution. But there were some that had

reservations about some of the language and provisions of the Bill.

Government hopes that the CCJ confirmation that the Bill does not and cannot deny access to the courts, will have satisfied those reservations. However, the rock solid national unity that will be required to see off the Ashcroft alliance once and for all, obliges Government to make assurance doubly sure.

Accordingly, Government will be meeting with various organizations and groups even outside of the official public consultation process.

These meetings, together with the broader consultations, will produce the kind of consensus, government is certain, which will unify and empower us as a nation to unwaveringly and successfully defend the 9th Amendment, and our patrimony, against all comers.

### Mayor John August Jr Leading The UDP Team Into Municipal Elections For The Third Time

SANTA ELENA TOWN, Cayo, Monday, August 15, 2011:

Two thousand two hundred and seventy five persons voted in the United Democratic Party (*UDP*) municipal convention held on Sunday, August 14 at St. Ignatius High School in Santa Elena Town.

A total of 115 councilor votes were spoilt mostly because of the voting for more than the required six candidates.

In a subsequent interview with the **STAR**, Mayor John August informed that, while he is saddened by the departure of Councilors Desol Neal and Eduardo Cano, the outcome of the convention is reflective of the wishes of the voters. "The new team", he said "appears tailor made in that apart from their individual competencies, the team is made up of three females and three males with two coming from each of the three electoral divisions in the municipality. We have two persons each from Cayo North, Cayo Central and Cayo Northeast."

"This make up" he said "will provide equal representation in the new Town Council."

The PUP convention is scheduled to be held between 9:00 am and 4:00 pm. on Sunday, August 28, at St. Andrews Anglican School in San Ignacio Town.

# STAR Delivering The Closing Remarks

The ocassion was the Friday, August 12, official inauguration of the Orange Walk East Sports Center in Orange Walk Town where STAR Publisher, **Alberto August** was invited to deliver these closing remarks.

Thank you very much Mr. Master of Ceremony.

Good night everyone. My name is **Alberto August.** I am one of three government representatives on a six member board of trustees of the Belize Natural Energy Trust with the other three members representing the Belize Natural Energy Limited.

Recognizing that delivering the closing remarks at any event



is usually confined to saying thank you to all the many persons who worked long hours to make the event possible, I would like, with your kind permission, to deviate for just a moment to do two things. First, I would like to speak just briefly about the Trust and secondly I would like to give you a brief overview of the project we are inaugurating today.

The Belize Natural Energy Trust is a partnership between the Government of Belize and the Belize Natural Energy Limited. It was born on February 25, 2008 with the signing of a Trust Deed by the Government of Belize and the Belize Natural Energy Limited.

Under this agreement, the Government of Belize has committed to forgo point nine percent of the gross revenues from oil to finance the projects and programs of the Trust.

The bulk of the funds therefore coming into the Trust is by way of quarterly remittances from the Belize Natural Energy Limited. These funds currently hovers around 2 million dollars per annum.

The Trust is mandated to manage these funds in a sustainable manner for General Education and Social Education purposes always with a view to unlocking potentials and empowering the Belizean people.

Under the Agreement, the Chairmanship of the Trust rotates every two years between the Government of Belize and the Belize Natural Energy Limited. The Government of Belize currently holds the chairmanship, up to March 2012, in the person of Mr. Orlando "Landy" Burns.

The Trust issues annual calls for proposals in keeping with its core functions, all such proposals are first reviewed by a project steering committee which recommends those for funding to the plenary of the Board.

In the current funding cycle, the Trust is managing 23 projects countrywide. This is one of those completed projects that we are today inaugurating.

In Orange Walk Town there is also an almost 100 thousand dollar expansion project either underway or soon to be started at St. Peter's Anglican Primary School. There is also, at least two or three other projects in this District.

Now to this particular project; this project was known to us on the Board, as the *Orange Walk East Committee Basketball project*. The contract was signed on April 27 of this year. It was completed around the end of July which was well within the three month schedule and for that we congratulate the contractor **Mr. Stanley Smith.** 

The scope of the works included the rehabilitation of the basketball court; The construction of a new ticket booth, extension of the bleachers, rehabilitation of the backboards, rehabilitation of the male and female bathroom, a cafeteria and necessary drainage.

Quite a lot of work indeed for less than 70 thousand dollars. It is therefore safe to say that we, all of us, got true value for monies spent. It is only fitting therefore that I ask you to join




### 2nd Quarter Report brings good tidings! BELIZE'S TOURISM INDUSTRY SHOWS RECORD-BREAKING INCREASES

#### **Total Overnight Tourist Arrivals**


The Belize Tourism Industry's overnight sector, emerging out of the pangs of the 2008 global recession, has recorded a 6.7% increase when compared to the same period in 2010. The BTB's Second Quarter Report attributes this impressive increase to April 2011, where a spike of 19.8% was recorded. In fact, the recordbreaking overnight arrival surpassed all other months in the second quarter of the last four years.

The first half of the year also shows a cumulative increase of 3.2% in the number of overnight arrivals, matching projections made by the United Nations World Tourism Organization (UNWTO).




#### **Airline Tourist Arrival**

This year's second quarter figures have also accounted for a notable 7.2% growth in the number of overnight tourists arriving via the Philip Goldson International Airport, marking an overall growth of 5.8% for the first half of 2011 as compared to this same period in 2010.



#### Cruise Tourist Arrivals

The cruise arrival figures for this year's second quarter, when measured against those for 2010, now boast a net increase of 10.8%. While an overall 11% decrease remains for the first half of the year, major increases in May and June signal the restart of a long-awaited impetus for the Belize Cruise Industry.

#### **Competitive Destinations**

Looking at the figures from a regional perspective, the report also shows that the fluctuations experienced in Belize ran parallel with the statistical norms in competing destinations such as Aruba and Barbados. This signals an important status change for Belize, as our country has with its much smaller budget—managed to match countries whose figures were known to surpass ours.
