

The Root Cause Of Crime In Cayo

In portraying a false sense of effectiveness, the police is keeping a lid on the number of reported thefts, burglaries, robberies and aggravated burglaries (*also known as home invasions*) occurring within the community. Despite their best efforts at concealment, the community is saying that the number of these incidents continue to rise.

The situation is compounded as many are the victims who just simply do not even bother to report lesser incidents like the stealing of a bicycle, a car battery, clothes and footwear off our outdoor line, refundable soft drinks and beer bottles, a garden hose or garden tools left in the yard and anything else that is not nailed down, chained up or locked away.

Many are those who say: *“Why bother wasting precious time to make a report when the rate of arrest for these crimes is downright low, the recovery of stolen property is even lower and the rate of an actual conviction sits at the lowest end of the scale.”*

It just simply cannot be that the police are the only ones in the community not actually seeing that the root cause of these crimes is crack addiction.

It just cannot be that the police, patrolling the streets day and night, paid to keep abreast of these things, do not know, while the magistrate, who comes into town only on weekdays and leaves sometimes long before the sun goes down, can look the accused burglar in the eye and tell him that he has a drug problem to which the accuse instantly agrees. The magistrate, in his wisdom, passes a custodial sentence instead of imposing a fine. And in passing sentence, the magistrate advises the burglar to enroll into a drug program while serving the time in jail.

The magistrate is seeing beyond the burglar. He sees the root cause of the problem – Why is it then that the police is not seeing what almost everyone else is or is it that they just simply do not want to see?

It was US President **Barak Obama**, on the campaign trail, who recently said *“We succeeded in putting man on the moon – something the critics said was impossible, why is it then that much simpler things seem so*

impossible to accomplish?”

This one is no rocket science – it’s far from putting man on another planet.

Much more than 50% of the crimes of dishonesty committed in this community stems from crack addiction.

It’s the crack heads who are breaking into our houses and our cars. They snatch even our wet clothes and footwear off our clothes lines. They even steal the empty soft drink and beer bottles from under our steps or from behind the house.

They are the ones walking into our yards and making off with everything that is not nailed down, chained up or locked away.

The crack head does not manufacture the crack. They get the crack from a crack dealer or from a crack house.

The police know who the crack dealers are. They know where the crack houses are located in the community. If there is any among them, from the highest to the lowest rank, who does not know, then they must either resign or be fired.

The crack head is unemployed and because of the addiction is oftentimes unemployable. The crack head is therefore a thief. The crack head steals our bicycles, our cellular telephones, they snatch our chains, they break our vehicle glass to pop the hood and make off with our battery.

They break into our houses in our absence and now more often in our presence. They take our household appliances, our sound systems, our computers, our jewelry, our money and whatever else they want.

They enter into our yards and walk away with empty bottles and anything they desire. They take these things to the crack house and exchange them, not for money, but for a hit.

The crack head is a thief and so, for two basic reasons, they are not allowed to hang around the crack house:

1) if they hang around they might steal from the crack dealer and

2) If they hang around it means that they are not on the streets spotting out the unattended bicycle or the garden hose and other things that they could snatch and rush back to the crack house with in order to exchange

it for another hit.

Having identified the root cause of this antisocial behavior, why then is there not a sustained offensive police operations against crack dealers and crack houses?

Armed with the knowledge of the trend of this scourge, everything inside a crack dealer’s house, yard or vehicle can be considered as proceeds from crack dealings.

The crack dealer is unleashing a selfish and merciless attack on the crack head and upon the community.

The crack dealer must therefore be dealt with an iron fist. In the sustained offensive, the police must remove everything from inside the house, inside the yard, from inside the dealer’s vehicle(s) and wherever else he has material possessions. These things must be transported and placed on display at the police station and members of the public must be invited to see and take back what’s theirs. And whatever is left, the crack dealer must assemble and take back home.

The crack dealer is in a special

category and as such, the crack dealer must be required to present a receipt for every material possession. Anything for which a receipt cannot be presented upon request will be considered stolen by a crack head from a third party somewhere.

The offensive must be sustained until the drug dealer comes to the realization that dealing in this antisocial commodity is just simply not worth it.

The community knows who the crack dealers are. We know where these crack houses are located; having established that fact which one of these individuals would dare take to the media or anywhere in search of public sympathy for the sustained police offensive.

As with everything however, these offensives must be conducted in the most professional manner always.

When one crack dealer is decommissioned and a crack house is closed, another might spring up elsewhere. Whenever this happens, the very same principle must be applied until this scourge is finally eliminated from our midst and civility is restored.

plastic bowl containing about \$80 in assorted coins. He then returned to where Keisha was standing behind the counter, and likewise patted her down before joining his partner in crime at the entrance door.

They both rushed out of the store and disappeared into the nearby alley linking the Western Highway in the front with George Price Avenue in the back. It is believed that they might have ran down the hill, over the temporary wooden bridge and in San Ignacio as information revealed that the one

wearing the long sleeve red sweater below the camouflage military jacket, was reportedly spotted, shortly after the incident, inside a nightclub in San Ignacio with a large amount of coins which he was using to purchase drinks.

The investigation led to the detention of two persons. They were later released when the police was unable to come up with the evidence needed to formally arrest and charge them.

The police is asking anyone with information to kindly visit the police station in San Ignacio of call the nearest police station.

Under the World Bank Infrastructure Project three(3) streets will be rehabilitated in the twin towns of San Ignacio/Santa Elena:

- 18th, Street(San Ignacio) -West Street(San Ignacio) -Eden Road(Santa Elena)

·The project has been approved by the Project Steering Committee (PSC).

·The Subproject Agreement has been signed. This agreement outlines the respective responsibilities, rights and obligations of the Social Investment Fund and the San Ignacio/ Santa Elena Town Council.

·The San Ignacio/Santa Elena Town Council has deposited an amount equal to 1% of the estimated cost of the project as a counterpart contribution.

·Anthony Thurton and Associates, an engineering consultancy firm, have been hired to prepare the designs, costs estimates and technical specifications for the four streets and work have begun on the designs etc. which is expected to be completed by the end of January 2012

Ministry of Health Improves On The Surveillance Of Food Borne Disease (FBD)

The Ministry of Health conducted Laboratory training this month for the staff of the Western Regional Hospital, Central Medical Laboratory, San Ignacio Laboratory and La Loma Luz Hospital.

The training focused on the isolation of Food samples that will better assist with Food Borne Disease surveillance.

The training covered the identification of a wide scope of microorganisms that cause Food Borne Diseases. It looked at improving the early detection of cases using surveillance and sampling techniques for collection amongst those affected.

The training also helped to prepare and increase surveillance and laboratory response of the disease.

The Ministry also anticipates that this training will assist the doctors and nurses to better care and manage cases at health care facilities across the country and it will also develop and execute the best possible public health interventions and programs to decrease the burden of the disease across Belize.

Minister of Health, **Hon. Pablo Marin**, along with the Epidemiology Unit of the Ministry is committed to improve on the surveillance of all diseases in Belize.

The Ministry of Health celebrates the success of many of its activities carried out in conjunction with the commemoration of World AIDS Day and National Testing Day on December 1st, 2011.

Activities were carried out across the country in collaboration with the National AIDS Commission under the theme, "Getting to Zero."

Some of the activities included Health fairs, Peer counselling sessions, Candlelight vigils, Walks for HIV and AIDS and a national bicycle race on December 4th, 2011.

In Belmopan, the Western Regional Hospital held a walkathon around the Ring Road on the morning of Thursday, December 1st and a Health Fair at the Market area on Friday, December 2. The staff reported that 54 persons visited the booth and volunteered to know their HIV status by getting tested.

The Ministry of Health encourages everyone to continue in the "Know Your HIV Status" campaign and to assist in reducing the stigma and discrimination of persons living with HIV and AIDS.

More Belizeans Countrywide Benefit From Dental Service

The Dental Department of the Ministry of Health, in collaboration with Belize Mission Project, teamed up recently to once again provide free dental service across the country.

The Dental Department is especially pleased that this effort assisted thirty four Belizeans with false teeth.

Dr. Raphael Samos explained that the team was happy to provide the dentures that will improve an individual's speech and digestion but most of all improve that person's self esteem and physical appearance.

The team, headed by **Dr. Frank Whipps**, included volunteer Dentists, Medical Practitioners, Dental Hygienists, Dental Assistants and Lab Technicians

from the United States. They carried out fillings, cleaning, fluoride treatments, sealants and tooth brushing drills in the rural and urban communities in the Corozal, Belize, Stann Creek and The Toledo Districts.

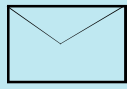
The target population were children at the primary schools level as well as persons who visited the Community Health Centers.

Dear Editor;

My name is **Patricia Dunlap**. Born on March 18, 1954. I am 57 years of age. I reside at Kismet Inn in Hopkins Village, Stann Creek District.

Please allow me the opportunity to share with your readers a recent unfortunate incident that befell me.

My Scotia Bank card went missing and I immediately reported the loss to the bank.

A few days later, on November 21, 2011 when I made a deposit into my account, I found out that \$500 from my account was missing.

I paid the bank the requested \$22.00 for a copy of that segment of the ATM video recording on the date and the time the money was withdrawn from my account.

The video clearly showed a man withdrawing the money from my account and putting it into his pocket before leaving the ATM.

An official from the bank told me that they would reimburse my money only to later say that they would not do so and that I should make a report to the police.

I first visited the police station in Hopkins and made a report to one **PC Choco** which he said would be passed onto the head station in Dangriga Town.

A few days later I called Dangriga police to find out how the investigation was going. They told me that I should find out from Hopkins police. I called Hopkins police and they told me to call Dangriga police.

With the video evidence, this case is so simple to investigate. Why not just investigate and help me, the victim.

Hanging up the telephone on victims seem to be the consistent rude police behavior.

I called the bank only to be told that no one at the bank has done any investigation into this clear case of grand larceny.

I do not understand why they are refusing to give me man's name and address so that I could do my own investigation so that I can speak with this man personally and ask or demand the return of my money or that I may commence civil action against him to get back my money since the police obviously do not want to take criminal actions against him.

The police is telling me that *"It is not my job"*. If it's not the police job then whose job is it to investigate the Scotia Bank customer who we clearly saw, on the ATM video on November 21 2011, stealing my \$500?

I would like the same attention any victim should receive and have the Scotia Bank customer that stole my \$500 investigated.

It is extremely frustrating that Officer Choco has the nerve to hang up the phone on a victim. It shows how much he interest he has in doing the job for which is paid.

All I am asking is for a response and action to my dilemma please.

Members of the public may also make comments at a Public Hearing to be held on Wednesday, December 21, 2011, at 7:00 p.m. at the Princess Hotel on Newtown Barracks in Belize City. BEL shall participate in the Public Hearing.

Members of the public will be allotted a maximum of five minutes at the Public Hearing in which to present comments and information, as time permits.

Persons wishing to make comments at the Public Hearing are advised to contact the PUC by 5:00 pm on Tuesday, December 20, 2011, to ensure participation.

Where any person submits comments or information purported to be factual, such comments or information shall be accompanied by a sworn affidavit.

Three copies of all applications, reports, documents, comments or information provided by members of the public shall be filed at the PUC'S office and a copy shall be provided to the licensee at his principal office of business on the same day.
