# FBI Investigating Murder In Cayo

SAN JOSE SUCCOTZ, Cayo, **Friday, January 15, 2016:** 

Officers of the Federal Bureau of Investigations are in Cayo to assist officers of the Belize Police Department in their investigation of Anne Elizabeth McComb Swaney's murder.

Swaney is a news producer from Rockwell Chicago, Illinois. She had been vacationing in Belize, staying at the Nabitunich Resort near San Jose Succotz Village in the Cayo District, when she was reported missing on Thursday, January 14. Her lifeless body was found in the Mopan River one day later with clear signs of foul play. Officers reported that there were "injuries to the head and what appears to be bruise marks around the neck". A post mortem examination determined that the

cause of death was asphyxia due to compression of the neck area, throttling (manual strangulation) and blunt force traumatic injuries to the head and neck region. Swaney was attacked and suffered an extremely violent death.

Investigators have tried to piece together the last hours of Swaney's life. In an interview with Swaney's news station, ABC7, Nabitunich Resort owner, Santiago Juan, recounted the last time he saw Swasey on Thursday, January 14. He said, "She had

breakfast and she had her coffee and she came to the stables that she normally greets the horses in the morning. And she was going to do her stretches, her yoga... Her intentions were to do her stretches, do her yoga, maybe get a ride in and buy some gifts in San Ignacio, the local town... because she was already halfway through her holiday and she wanted to bring gifts back to her loved ones."

In search of a serene environment to practice yoga, Swaney walked down a path to a wooden platform near the Mopan River that is about half a mile away from the resort. This is where police believe she was attacked and later thrown into the river. Her body was found in the water the next day, about 300 yards downriver.

# Franks Eddy Businessman **Accused Of Ordering Hit**

BELMOPAN, Cayo, Thursday, **January 14, 2016:** 

The owner of Dark Night Cave Tubing, American businessman **Bradley Paumen** is out on bail of \$50,000 plus one surety of the same amount after he was arraigned in the Supreme Court for allegedly ordering a hit on four individuals. Paumen was charged in the San Ignacio Magistrates Court with the offense of abetment to murder against four men, including American-Iranian Faroud Michael Modiri over a land dispute.

Paumen, resident of Franks Eddie Village, Cayo, was represented by Senior Counsel Ellis Arnold when he appeared before Justice Antoinette **Moore** on Thursday, January 14, for a bail hearing. Paumen is facing charges of abetment to commit

passionately that Paumen should be remanded because he is a flight risk. Vidal also informed Justice Moore that Paumen is expected to be levied with additional charges in connection to the same matter. Arnold said the question as it relates to bail is whether or not the defendant will appear in court on dates set by the court. He argued that bail is a right and that a person is presumed innocent until

proven otherwise and that his client is a nationalized Belizean with financial ties to the country.

Before ruling on bail, Justice Moore asked Bradley how many businesses he owns in Belize and what kind of investment he has in each of them. She also asked about other financial ties, his marital status and previous run ins with the law. Bradley told the court that he owns two businesses in Belize, Dark Night Cave

Tubing and a resort in Hopkins, representing an eight million dollars investment and he has been in a relationship with a Belizean woman for three years.

After considering submissions made by both sides, Justice Moore granted bail in the sum of \$50,000 plus one surety of the same amount. Bradley had to first surrender his travel documents before posting bail. Justice Moore ordered that the court notify the US Embassy that his passport has been confiscated. She also ordered that he attends all his court dates in the Belmopan Magistrate's Court and report to the Belmopan Police Station every Wednesday and Friday between the hours of 6 a.m. and 6 p.m. until the case is over. Bradley must not interfere with any of the prosecution's witnesses in any way.



# Cayo Declared Second Best Place In The World To Live

The murder of American news producer Anne Elizabeth McComb Swaney, a recent string of violent crimes and the threat of Guatemalan criminal elements in the area has placed an international blackeye on Belize, especially the Cayo District. Though the major markets have not issued a warning to nationals on travel to Belize, cautions are popping up. Despite this recent phenomenon, another major international media outlet has recognized Belize as one of the top destinations in the world to live or retire. Ironically, the part of Belize recognized as the second best place to live or retire in the world is the Cayo District. In an article written on January 14 and published on January 18, 2016 entitled "The World's 12 Best Places to Live or Retire in 2016", the Cayo District sits at number 2.

The article written by Kathleen Peddicord reads:

"Belize is one of the quirkiest countries in the world. Geographically, Belize is in Central America, yet its strongest ties are to the English-speaking Caribbean. Belize is Caribbean, Central American... and, thanks



## **Progress At New Santa Elena Sports Complex**

SANTA ELENA, Cayo, Thursday, January 21, 2016:

The Area Representative of Cayo Central, Hon. Rene Montero, recently went to inspect the construction site of the new Santa Elena Sports Complex and found that work is well under way and residents of the developing town will soon have their first class sporting facility that was promised by the United Democratic Party in 2013. The project is being overseen by the Belize Infrastructure Limited (BIL), a public sector agency of the Government of Belize (GOB). BIL oversees every stage of Government's sporting and multipurpose facilities projects; including the assignment of design, construction and management contracts.

The Investment project was initiated on January 21, 2014 with contract signature for consulting services and architectural designs for infrastructure at the Santa Elena Football Complex and Facilities. BIL, along with technical support from the Ministry of Works has worked closely with the town council on the development of the project. The project first required a feasibility study, inclusive of public and one-onone consultations with the community and relevant stakeholders. It also included socio/environmental studies as related to any environmental management, approved design plans, bidding documents inclusive of all cost estimates, and operational recommendations for the facilities. The first contract was awarded to a San Ignacio based firm, *DIEMA* Consulting Architects & Engineers headed by lead architect Mr. Juan **Polanco**. This was for consulting and design. Construction started a few months later.

for recreational and organized competition. According to Montero, the Santa Elena Football Complex and Facilities will include a basketball court, training football field, a *FIFA* standard playing field and a mile long running track. It has an estimated cost of \$2.25 million. It will be the home of Cayo Central's very own Premiere League team which Hon. Montero says will be launched this year.

The Victor August Football Field is one of many facilities that have been upgraded by the Belize Infrastructure Limited since 2013. The project for Falcon Field in San Ignacio Town includes a roofed, outdoor court facility with restrooms and a refurbished stage. The facility also features a playground, sidewalks and a bus stop at an estimated cost of \$850,000. Also in San Ignacio, the Victor Galvez Recreation Field is being upgraded to international standards at a cost of more than \$1.3 million.

# Belmopan Murder Suspect Implicated in Armenia Carjack

BELMOPAN, Cayo, Thursday, January 21, 2016:

Twenty-five-year-old **Lincoln Bejerano**, the man believed to be involved in the murder of two Belmopan taxi drivers have been charged for another serious crime in the Cayo Area.

Manager of Puma Energy Limited, Melonie Popper Coc, 38, of Ladyville Village reported to police that the company's grey 2007 Isuzu D-Max four door pickup truck was taken away from her on Saturday, January 2, in the Village of Armenia. At about 7:15 p.m. on Saturday, January 2, Coc was travelling along with her mother and four children on the Hummingbird Highway from Belmopan to Pomona Village and upon reaching the second bump in Armenia Village she pulled over to the side of the highway to make a phone call. She exited the truck and while on her cellphone she was approached by a slim built Hispanic male. The man had a low haircut and moustache; he was wearing a camouflage jacket over a plain white T- shirt and a dark three-quarters cargo pants. After approaching Coc, he ordered her to hand over the cellphone. At that time he opened his camouflage jacket and pulled out a pistol. Fearing for her life, Coc handed over the phone. He then grabbed her by the arm and walked her to the vehicle where he placed her in the back seat. He then took the children and her mother out of the vehicle. A second man got into the driver's seat of the vehicle and they then ordered Coc to get out of the car. The men drove off in the direction of Belmopan.

The car jackers left the entire family on the highway. Coc's purse containing \$1,400 cash, a white Blackberry cellphone registered to Puma Energy valued at \$1,200, two Samsung Galaxy Tab 4 valued at \$525 each, a Blu cellphone valued at \$700, clothing, shoes and other personal belongs valued at \$500 and

an assortment of identification cards were also taken. The truck has a value of \$12,000.

Bejerano was positively identified as one of the robbers that hijacked Coc's vehicle. On Monday, January 18, he was taken to the Belmopan Magistrates Court where he was charged for robbery and sent back to prison. Police believe Bejerano is the main suspect in the murders of Belmopan taximen **Isidro Suar,** 28, and Yoni Maas, 24. Shortly after Suar was killed on Friday, January 8, police coordinated vehicular checkpoints throughout the length of the George Price Highway and caught Bejerano and two others in his vehicle. One man managed to escape but Bejerano and a 17-year-old female minor were caught with a .22 pistol and arrested by police.

Lincoln Bejerano is known to many of the taxi men from the bus terminal. Suar's wife said she is not surprised that the name came up because her husband used to always mention threats coming from that name. She says Lincoln wanted him to do jobs for him like take him on robberies and other criminal activities.
